## Week-long Nazrul exhibition begins

A week-long Nazrul exhibition began in the city yesterday with the display of various articles bearing the memories of the National Poet, reports BSS. Photographs of different sizes, hand-writing, periodicals and dress of the rebel poet, paintings, gramophone records and audio cassettes are on display. The exhibition is being held at the Bangladesh Shilpakala Academy gallery.

State Minister for Youth, Sports and Cultural Affairs Obaidul Quader inaugurated the exhibition in the morning as part of the birth centenary celebration of Kazi Nazrul Islam.

The exhibition will remain open from 11 am to 7 pm everyday. But on Friday it will be open from 3 pm to 7 pm.

Earlier, Prof Anisuzzaman at a discussion on the poet stressed the need for collecting the memorable songs of Nazrul which are now lying with different gramophone companies in India.

"Our reserve of Nazrul songs will be further enriched with the original notations of those songs if we are able to retrieve them from the Indian record companies where the poet used to work," he said.

Prof Anisuzzaman said a museum has already been established at Churulia, the birth place of the Rebel Poet, with many articles and literary works including songs of Nazrul. "We are yet to claim that we have enough collections of Nazrul's works," he said.

Presided over by Director General of Shilpakala Academy Azad Rahman, the function was also addressed, among others, by Executive Director of Nazrul Institute Poet Nurul Huda and Subir Choudhury of the academy.

According to a message received yesterday, Ogata made the praise when the Bangladesh Ambassador in Geneva Dr Iftekhar Chowdhury called on her on Friday to personally hand over a letter from the Prime Minister.

"This was in response to the felicitations Ogata had earlier sent on the Prime Minister's receipt of the Houphert-Boigny Peace award. Ogata herself a recipient of the award, also congratulated the Prime Minister on the resolution of the situation in Chittagong Hill Tracts.
