Addressing a discussion at its central office to mark the 15th death anniversary of a BCU Chittagong unit leader, Chhatra Union leaders reiterated their demand for imposing a ban on communal politics in the country.

Earlier, they placed wreaths at the Central Shaheed Minar to pay tribute to the slain leader.

The BCU Chittagong unit leader Shahadat was killed by the activists of Islami Chhatra Shibir on May 28 in 1984.
