after a partial completion of the construction work. According to local people, the work of installation of machinery and a tower is yet to start. But work of main building, police camp, power sub-station and boundary walls has

already been completed at a cost

of Tk 1.33 crore. Under the revised scheme it was renamed as 'TV Relay and Regional TV Station-Rajshahi' and will be completed in two

started in 1994-95 fiscal at an

estimated cost of Tk 4.21 crore under the supervision of the Public Works Department. Local Authority of the pro-

ject in a letter in September 1998 requested the project di-rector of the National Broadcasting Authority-Dhaka to takeover the Relay Station but nothing has yet been done

in this respect, said the source. After deploying Ansar for security reasons the cost of the project is increasing day by day as more than Tk 10,000 is being spent against the wages of the security personnel, the sources added.

But the local authority could not give any idea when the relay station would start functioning although they said that the ma-chinery would be installed with the technical assistance of French Government.


