Memorandum

Subject: Charge framing against Mr Md Sayeed-ul-Latif, Scientific Officer for unauthorised absence from the place of work.

As Mr Md Sayeed-ul-Latif, a Scientific Officer of Electronics Institute at Savar was granted 2 years study leave outside Bangladesh without pay to study in the United States through the even number of memorandum dated 25-7-96 and the duration of which was effective from 31-8-96 to 31-7-98.

He was directed through a memorandum dated 29-10-97 to join has place of work on return as he did not join place of work in due time. Through an even number of memorandum dated 3-1-99 he was asked to explain why punitive action will not be taken against him for the said activity as per BAEC Regulations as he did not join the place of work and registered letters were sent to him in his local/foreign addresses.

As he has not yet joined the place of work till today, it is proved that he is hindering the research and development work of the commission by remaining absent willingly which is contrary to the disciplined conduct of government servant.

So accordingly, he has been charged by the clause 3 (B) of Government Servant (Special Provision) Ordinance 1979. The clause is as follows:

"Without leave of absence or any reasonable excuse, absents himself or otherwise abstains from, or fails to perform, his duties, whether or not in concert with others"

So he has been directed to submit his reply in writing in the following address within 5 (five) days of publication of the memorandum in the newspaper why one or more punishments will not be awarded to him as mentioned in clause 4 of the said ordinance. Otherwise action will be taken as per rule. He will have to inform in writing that also if he is interested to give hearing personally.
