## Request for Expressions of Interest

Credit No. BD-PE-57833

- This request for expressions of interest follows the general procurement notice for this project that appeared in Development Business, issue No. 508 of 16 April 1999.
- The Government of the People's Republic of Bangladesh intends to apply for a Credit from the International Development Association (IDA), and intends to apply part of the proceeds of this Credit to payments under separate contracts under "Air Quality Management Project" for (i) Overall Technical Assistance, (ii) Emissions Inventory and Source Apportionment, (iii) Three Wheeler Vehicle Emission Reduction.
- The services include:

#### (i) Overall Project Technical Assistance

The overall Technical Assistance (TA) consultant will assist DOE to achieve by the end of the three-year project period: a) collection of rigorous data on major air pollutants; b) timely provision to the public of data on air quality and vehicular emissions; c) formulation of an air quality management plan; d) testing of several emissions control options and analysis of their cost-effectiveness as well as social acceptability; e) establishment of more comprehensive or stringent air quality, vehicular emission and fuel standards, and lubricant regulations; f) improved enforcement of vehicular emission and fuel standards, and regulations governing the quantity and quality of lubricants; g) increased public awareness and involvement in air quality management; and, h) greater institutional capacity to implement the air quality management plan in Dhaka and other urban centers. Success will be defined in terms of the extent to which knowledge has been gained and various components of the air quality management system have been put in place.

The overall project TA is expected to be provided by (but not limited to) four types of experts. Expertise is required in the following areas: air quality monitoring and data analysis; automotive emissions control (three wheeler, two stroke and diesel engines) and in-use vehicle inspection; refining, lubricant and petroleum product distribution; and, air quality policy and standards. The selected company is expected to work with the Department of Environment (DoE), in close coordination with other consultants and equipment suppliers contracted under this project, for the duration of the three-year implementation period.

#### (ii) Emissions Inventory and Source Apportionment Analysis

Technical Assistance is required in the creation of an emissions inventory, to be completed by June 2000. The sources of emissions to be considered include mobile, fixed, and area sources such as vehicular traffic, industry, open burning, roadway dust and brick-making. The inventory will form the basis for ongoing analysis, including tracking the impact of the emissions control programmes, supporting dispersion modeling, developing control strategies and source attribution analysis. The activities to be supported will include: (a) creation of a detailed computerised emissions inventory; (b) particulate matter source assessment to provide a basis for effective control actions; (c) modeling to link the emissions inventory with ambient air quality; and, (d) additional analysis (such as health impact assessment) as deemed appropriate to assist DoE with their policy decisions regarding air quality management in Dhaka.

#### (iii) Three Wheeler Vehicle Emission Reduction Pilots

A series of pilot technology trials will be supported to test the cost-effectiveness and social acceptance of cleaner technology options for two-stroke, three-wheeler, and heavy diesel vehicles. Air pollution in Dhaka is dominated by two-stroke gasoline and heavy-duty diesel vehicular emissions. This project will support pilot activities for these vehicle types as a first step in promoting the most promising approaches. Some of the technical options being proposed are still at the laboratory stage and need to be tested in pilots to determine suitability for conditions in Dhaka and other cities in Bangladesh. For each pilot programme, DoE will determine: the number and type of vehicles to be included; participating groups or associations; financial flows; measurements to be taken during vehicle evaluations; and baseline data for assessing costs and exhaust emissions reductions. Investments in each pilot technology will be limited to a scale needed to test its feasibility. Based on the results of the pilots, policy recommendations (including regulatory and enforcement) will be made and implemented. A list of examples of some of the pilot programmes being considered is given below but other ideas will be actively solicited and evaluated for three-wheeler and diesel emission reductions during project implementation: (a) Quality Lubricant Dispensing Mechanisms and Independent Lubrication; (b) Regular Maintenance; (c) Engine Replacement; (d) Alternative Fuels; (e) Anti-smoke Belching Campaign; and, (f) Phase-out of Older Vehicles.

- The Department of Environment now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information separately for each of the above contracts indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.

- A consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers (January 1997, revised September 1997 and January 1999).

## Over Tk 18cr Narayanganj Poura budget proposed

From Our Correspondent

NARAYANGANJ, July 2: Narayanganj Pourashava authorities have proposed a budget of Taka 18.94.05.701 for the fiscal 1999-2000.

The proposed budget is Taka 45,85,447 less than that of the last fiscal.

Of the total revenue income, the maximum of Taka 8,90,58,547 is expected to be fetched from pourashava's own sources.

In the last fiscal Tk 10,29,22,561 was estimated earnings while Tk. 1,31,66,784 was collected from its own sources.

Besides, Taka 7,47,73,944 will come from the grant of government in development projects. Taka 6,39,000 from the grant of government in revenue sector and Taka 2,49,34,210 will be generated from the opening balance.

A total of 24 development projects will be executed in the current fiscal year (1999-2000). The highest expenditure of Taka 11,51,23,944 or 60.79 per cent of the total budget allocation has been proposed for the implementation of government

approved development projects which included Taka 3,98,73,944 for the construction of modern kacha bazar and purchase of hydraulic ladder. Taka 1,98,00,000 for the construction of bus/truck terminals and maintenance while Taka 1,50,00,000 for the construction of community centre cum super market. Taka 1,00,00,000 for the development of city roads and Taka 1,00,00,000 for the housing project.

The revenue expenditure of Taka 2,27,78,469 will be spent for salary, honorarium and allowance of the pourashava's staff. Of the total expenditure Taka 75,20,000 has been proposed for health sector and cleanliness programme, Taka 47,45,000 for education and tree plantation. Taka 1,25,000 for tax collection and establishment and Taka 42,20,000 for other purposes.

The main allocation for 1998-99 fiscal was Taka 19,39,91,148 but in the revised budget it became Taka 19,30,43,370.

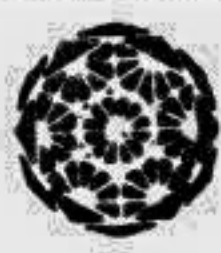
## \$ 27 m WFP aid for Bangladesh

UNITED NATIONS, July 2: The United Nations World Food Programme (WFP) announced on Thursday it is conducting a 27 million US dollar operation for emergency relief and rehabilitation in Bangladesh following heavy floods there, reports Xinhua.

The year-long operation, ending in May 2000, will focus on rebuilding activities in addition to food relief for the poorest and most vulnerable people of those affected.

Some 2.9 million Bangladeshis will benefit from the aid in a "food for work" scheme under which the rations will be given to those participating in reclaiming rural roads, community fish ponds, plantations and flood protection.

The South Asian country saw unprecedented floods in 1998 which directly affected more than 30 million people. Two thirds of them have been aided by WFP, the world's largest food aid agency based in Rome.

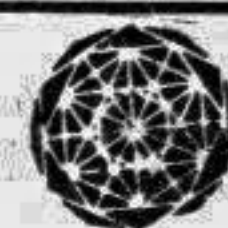
