3 murdered in city

Four persons were killed in separate incidents in the city in the 24 hours till last night.

The death figure, however, excludes the killing of a rickshawpuller early yesterday morning after he was shot by a police sergeant at Agargaon Monday night.

An owner of a motor garage was shot dead by unidentified gunmen near Sayedabad bridge in the city late last night.

The dead was identified as Saifuddin Ahmed, 45, son of Saibuddin Ahmed, hospital sources said.

The assailants shot Saifuddin in the throat in Nampara area at about 10:30 pm.

In a fatally injured condition, the victim was rushed to Dhaka Medical College Hospital where the on-duty doctors declared him dead, the sources added.

A garment worker was killed after allegedly being raped at

Clinton to visit Bangladesh, says Samad Azad

US president Bill Clinton is willing to visit Bangladesh, foreign minister Abdus Samad Azad said in the capital yesterday, reports UNB.

"I'm going to Bangladesh," Clinton told Azad at the Royal Palace of Morocco Sunday when the world leaders assembled in Rabat to join the funeral service of King Hassan II.

Talking to reporters at the Foreign Office in the afternoon, he said the US president told him that he would have undertaken his trip to South Asia much earlier had there not been elections in India.

Police sergeant guns down one amid large crowd

A city police sergeant shot and killed a young rickshawpuller Monday night in presence of a large crowd in Agargaon, prompting violent protests from local residents.

The sergeant, Saroj Kumar Roy, was arrested yesterday on charges of killing Masud, 24, with his service revolver.

The victim, who was rushed to Pangu Hospital, then shifted to DMCH and finally admitted to Chest Diseases Hospital, died early morning (4.30am) yesterday. He was shot at 10.30 Monday night.

Angry people in the locality where the rickshawpuller lived gathered at the place of occurrence in their hundreds yesterday afternoon and allegedly hurled crackers on on-duty po-

volver hit her.

Masud protested, and the angry sergeant shot him in the throat point blank at around 10:30 pm, according to local people and relatives of the dead. They said the whole episode took place before a huge crowd.

But Saroj was quoted to have told his superiors that he did not shoot Masud deliberately.

Saroj went to Mohammadpur thana and filed a case saying Masud was shot accidentally during the scuffle. We kept Saroj at the thana and he was officially arrested after the mother of the victim filed a murder case accusing the sergeant, said Ibrahim Fatemi, additional deputy commissioner for DMP's western zone.

Sergeant Saroj was produced
