

Opposition trying to create anarchy

Bangladesh Chhatra League (BCL), the student wing of ruling Awami League yesterday accused the opposition of hatching a "conspiracy" to create anarchy throughout the country in the name of calling hartal.

"The opposition is now engaged in a "deep rooted" conspiracy to deestablish democracy and destroy the economy of the country," alleged BCL president Bahadur Bepari while addressing an anti-hartal rally on the Dhaka University cam-

BCL brought out a procession on the campus and held a rally at Aparajeya Bangla in protest of yesterday's 30-hour long countrywide shutdown. The four party opposition allianceled by BNP called the hartal to protest the government's decision allowing transshipment facilities to India.

Bahadur Bepari also alleged that the oppositions is calling hartals frequently in a bid to save the killers of Bangabandhu Sheikh Mujibur Rahman. "Any conspiracy to save these selfconfessed killers will be foiled at any cost," he said.

Addressing the rally, the BCL leaders warned that they would not allow any more conspiracy against the country and the government of Sheikh Hasina. They also demanded immediate execution of the verdict of Bangabandhu Sheikh Mujibur Rahman murder case.

Hailing the government's decision to allow Indian goods throughth ecountry, the BCL leaders observed that it would further bolster the country's economy.

Among others, Anisur Rahman and leaders Shahjahan Alam Shaju, Sujit Roy Nondi, Liakat Sikder, Ashraful Ruban, Khalid Mahmud Chowdhury. Proshanta Vhusan Barua, Sajjad Hossain and AKM Ajim ad-dressed the rally.

Meanwhile, opposition BN-P's student front Jatiyatabadi Chhatra Dal (JCD) brought out processions and held rallies on the campus in support of the

hartal. They criticised the AL gov-ernment for allowing trans-shipment facility to India and alleged that the government has

started 'selling out the country to India' since it came to power. Terming the proposed transshipment facilities to India "a treaty of slavery", they said that they would rather lay down their lives than give corridor to

They urged the countrymen. particularly the student community to stand against the government's "subjugation" transshipment agreement.

Among others, Monzsur Elahi, Monwar Hossain Rana, Rafiq Sikder, AMB Mosharraf Hossain, Manir Hossain and Mostafizul Islam Mamun addressed the rally.

The paper said "after many years of conflict with the traditional rulers in the villages, the landowners, BRAC has become so widely accepted that the gov-ernment has asked it to take over some schools to improve teaching. BRAC has a large lending

programme for the poor in addition to a huge training effort in literacy, medicare, farming, animal husbandry, handicrafts and other money-making projects, the paper said.
When the Times reporter and

a renowned US journalist Ben Barrer turned to Bangladesh Ambassador to the USA KM Shehabuddin for his comment on BRAC the ambassador said "BRAC supplements the priori-ties of the government efforts in poverty reduction and informal education of adults and primary health care for women and children.




