Flowers give Panisara people a living

The day dawns with birds chirping and tuberoses blooming at Panisara, a serene countryside some 25 km west of Jessore town.

Tuberoses and gladiolus grow in plenty at Panisara. Besides, people of the area also grow various types of rose as well as marigold and hedge-plant.

The lucrative flower production on a commercial basis is now spreading also to some other areas in Jhikargachha, Sharsha and Monirampur thanas of Jessore and part of Chuadanga.

But what makes Panisara an exception is that it is increasingly being known as a flower garden of the country, a local public leader said. Of some

5000 acres of land under flower cultivation in the area, around 4000 acres are at Panisara, according to official statistics.

During a visit to the area, a number of local people told this correspondent that all of them were directly or indirectly involved in flower cultivation and trade. The entire area from Gotkhali bazaar on Jessore-Benapole highway to Panisara has virtually become flower lovers' paradise.

During the peak season, Panisara flower growers sell about 250 bundles of tuberoses per day at Gotkhali bazaar. Each bundle contains up to 3,000 sticks of tuberoses. The flowers find their way into flower markets in the capital

and from there these are supplied to markets in Chittagong, Sylhet, Rajshahi, Bogra, Khulna and some other districts.

Sirajul Islam Dhali, a tuberoses cultivator, recalled that the process was initiated by one Sher Ali almost two decades back. Ali also established a marketing channel.

"Today, Panisara people can sell flowers worth about Tk four lakh a day. But we had bad times in the past. Traders in Dhaka used to cheat us, make payments late and in small instalments. Now we sell flower on cash payment", said Mujibur Rahman, a young flower trader from the area.

Kamal snubs Khaleda's CHT formula

Eminent jurist and leader of Gano Forum Dr Kamal Hossain yesterday opposed the demand of Opposition leader and BNP Chairperson Begum Khaleda Zia to rehabilitate the slum dwellers in Chittagong Hill Tracts.

"This demand in no way can be supported," Dr Kamal said in an interview with Bangladesh Sangbad Sangstha (BSS).

Stressing the need for reconstruction of planned housing for the slum dwellers under a city plan, the Gano Forum leader said that the attitude of utilising the poorer people as tools of politics and power must be avoided.

It will not be proper to do or say something that might disrupt peace process in Chittagong Hill Tracts, Dr Kamal said, adding that the people of the

country expect tolerance from all quarters for establishing peaceful atmosphere in the hill areas.

He said the 'settlement issue' as initiated by late President Ziaur Rahman was a major cause for creation of unrest in the Chittagong Hill Tracts in post-1975 period.

Dr Kamal suggested discussion on the existing political differences on this issue for resolving the problems. But to aggravate the problem instead of resolving it cannot be expected, he added.

Refuting the allegations that he was exploiting the slum dweller issue for political purposes by taking stand against the eviction of slum dwellers, he said his politics was not aimed at capitalising the helplessness of the poorer section of

people.

Terming slum as a problem of the city, Dr Kamal underscored the need for forging national consensus to find out proper ways to solve the problem.

He advocated the idea of creating 'satellite town' in the suburbs of Dhaka city under a master plan to build the capital for all.

Referring to the verdict of the High Court on the eviction of slum dwellers, Dr Kamal said all concerned should abide by the verdict of the court.

On another question whether a section of NGOs trade on slums, he said the NGOs carry out their activities with the approval of the government. So, it is the responsibilities of the government to look into the irregularities of the NGOs, if any.

Certain US-bound garment shipment may get stuck

The US government may impose a temporary embargo on export of garments under categories 347/348, 352/652 and 647/648 when their quotas for the current year will be fulfilled, possibly by next month.

The restriction will be in force till the next quota year begins in January 2000, sources in the Export Promotion Bureau (EPB) and the Garments Manufacturers and Exporters Association (BGMEA) said.

Trousers and shorts are exported under category 347/348, underwear under category 352/652 and trousers under category 647/648.

Quota fulfillment rates for these categories were very good this year because of good demand in the US market. Till August 18, the fulfillment rate was 76 per cent for category 347/348, 69 per cent for 352/652 and 70 per cent for category 647/648.

Because of high demand, the quota under category 347/348 was raised in the middle of this year by re-adjusting it with other categories having lower demand.

"Exporters will suffer if a temporary embargo is imposed by the US government on these categories," BGMEA Vice-president Nurul Huque Sikdar said.

The apparels which have already been shipped will not be allowed to enter the US market till the next quota year begins, he said. "This will cause great loss to the exporters because they will have to wait for several months to sell those," he added.

of garments under one category only. The US government has already imposed embargo on export of three categories of garments from India and one category from Sri Lanka, he added.

Bangladesh faced a temporary embargo on export under categories 634 and 340 in October last year as their quotas were fulfilled. Coats were exported under category 634 and shirts under category 340.

80 feared killed in Indian road accident

NEW DELHI, Aug 26: At least 80 people were feared killed Thursday when a bus plunged into an irrigation reservoir in the southern state of Karnataka, domestic news agencies said, reports AFP.

The accident occurred about 30 kilometers (18 miles) off Devanagere town, the United News of India (UNI) and Press Trust of India (PTI) said.

UNI said six bodies had been recovered so far from the tank. The victims were Hindu pilgrims who were returning to Devanagere after offering prayers at a local temple.

Ninety-four people were killed at the same region of Karnataka on June 7 when a bus packed with 150 people veered off a bridge and rolled into a reservoir after one of its tyres burst.

The sources however said they suspect that huge quantities of garments were exported to the US this year under category 347/348 by forging EPB export visas. Apparels might have been exported also from other countries using Bangladeshi name tags, they claimed.

When contacted, Abdur Razzaq, Director General of EPB's Textile Cell, said some unscrupulous traders may have exported garments forging visa documents. Investigation is going on to detect the garments companies involved in the forgery, he said. No EPB official was found involved in the forgery, he said.

When asked, a BGMEA official said there is no possibility of a US embargo on garments export from Bangladesh because of visa forgery.

Bangladesh is going to participate in introduction of an Electronic Visa Information Delivery System (LEVIS) in the US customs very soon to detect forgery and stop it, he said.

Earlier, EPB suspended activities of 21 garments factories after those were found involved in forging 106 export visas in the last two years. About 12 lakh pieces of apparels were exported by using the forged visas.

Khaleda continues anti-transit campaign

BNP Chairperson Khaleda Zia led some 500 vehicles carrying her party's leaders, MPs, and activists on a one day "mini-road march" from Dhaka to Bhairab yesterday to protest the government's decision to give transit to India.

Vowing to resist the move, she called upon the people to join the August 30 mass procession in Dhaka and sit-in demonstration in front of the Secretariat on September 12.

Khaleda, also the leader of the opposition in parliament, began the march from Shaheed

Faruque Road at Jatrabari at 11 am after addressing a huge gathering.

She then proceeded to address meetings in Nawapara Jamdani Palli at Tarabo, Rupganj thana and Bagbari, Arahaz thana in Narayanganj district, Madhabdi, Panchdona, Palash thana, Itakhola Bazar, Shibpur thana, Barichabazar, Belabo thana and Nilkhuti, Rajpara thana in Narsingdi district and ended the march with a public meeting at Bhairab stadium in Kishoreganj district.

From Jatrabari to Bhairab, tens of thousands of people from far flung areas spontaneously assembled in the meeting spots and road sides to cheer the former prime minister with the sheaf of paddy -- the election symbol of BNP -- in hand. She replied by waving back to them.

A large number of gates were erected from Kanchpur bridge to Bhairab. The gates were inscribed with slogans greeting the marchers and protesting the transit move. Supporters everywhere

chanted slogans against the government and its move to give transit facility to India.

The opposition leader alleged that the government in its last three years' rule did not keep a single pre-election commitment to the people. But it is implementing one after another all the pledges it gave to India.

The BNP chief said the AL will ultimately give corridor to its masters on the pretext of transit or transshipment. She

expressed the determination to resist the government move even at the cost of life.

Three people have already laid down their lives to resist the move to give corridor to India. We have taken oath on the blood of the three martyrs to resist the government's evil design. If necessary, we will give more lives, but we will never allow the government to give transit facility to India.

"We can't allow India to transship its troops and

Kader Siddiqui vows to fight AL 'cancer'

'I don't take initiative without being sure of success'

Rebel Awami League leader Kader Siddiqui, MP has vowed to "free his party from cancer, make it pro-people and truly democratic".

He says the current AL led by Prime Minister Sheikh Hasina is "no longer acceptable to the people, which has deviated from its ideals and is in the grip of anti-liberation forces and the killers of Bangabandhu".

Talking to The Daily Star yesterday, the valiant freedom fighter described his move to reorganise the AL as a step to stop the rise of anti-liberation forces in the country. "Neither Sheikh Hasina, nor Khaleda Zia or H M Ershad, who now lead the nation, had any con-

tribution to the liberation of the country," said Siddiqui, who was among the few civilians to be awarded the second highest military award -- Bir Uttam -- for his valiant role in the War of Liberation.

"I don't take any initiative without being sure of its success. Maybe, I'll not be able to see the success in my lifetime but others will definitely do," a confident Siddiqui said.

Disclosing his plan to this paper, he said he would first resign from the Jatiya Sangsad from where he was elected on a ticket from the "illegal" leadership of AL.

Two killed, 200 hurt in B'baria clash

BRAHMANBARIA, Aug 26: Two persons were killed and at least 200 people including 31 policemen were injured during a gunfight between two rival groups of villagers in the sadar thana last night.

The dead were identified as Farid Mia, a school student of village Shuhagpur and Sabur Mia, a rickshawpuller of village Charchartala.

Farid succumbed to bullet injuries on way to the sadar hospital while Sabur was chopped to death during the clash.

According to police and witnesses, the clash was sequel to an altercation between the villagers over a football match that was held five days ago.

About one thousand people of two villages -- Charchartala and Shuhagpur -- were locked in clashes that began yesterday evening.

They used firearms and exploded crackers during the

clash that continued for about seven hours.

On receipt of information, the OC of Ashuganj thana along with a police team rushed to the spot. Failing to bring the situation under control, he sought reinforcement from district headquarters.

The Additional District Magistrate and Additional Police Super reached the spot with a huge contingent of police.

At one stage, the clashing groups attacked the policemen, injuring 31 including an ASP (Circle).

Police fired blank shots and tear gas shells to disperse the clashing groups.

The injured were admitted to Brahmanbaria, Ashuganj and Bhairab hospitals.

The bodies were sent to Brahmanbaria Sadar Hospital for autopsy.

No case was filed till filing of this report at 9 pm today.

Rupganj refineries return to normal

The vegetable oil refineries in Rupganj which came under attack from local hoodlums Wednesday resumed production yesterday afternoon after a team of policemen took charge of security of the premises.

However, in the morning yesterday, the alleged vandals who had led Wednesday's attack returned to terrorise the officers and employees once again until the 10-strong police team arrived at 1 pm.

The vandals damaged equipment, disconnected phone lines, took away some valuables and beat up the officers and employees of City Vegetable Oil Mills and three other adjacent factories at Uttar Rupashi, Rupganj, some 20 kilometres off Narayanganj town.

Fazlur Rahman, the owner of the factories, has alleged that Wednesday's vandalism was led by Altaf Hossain and Habibur Rahman, both local Awami League leaders.

The Tk 150 crore City Vegetable Oil Mills and other factories owned by Rahman refine more than a third of Bangladesh's edible oil requirement and produce flour and other such items. The products are marketed under the popular brand name Teer (arrow).

"The administration responded positively after the reports in the media," said Fazlur Rahman, one of biggest corporate taxpayers in the country.

Rahman alleged that his refusal to pay toll to the political activists drew their violent response.

HC restores retiring IFIC directors

The High Court has declared "null and void" the election of a director of IFIC Bank at its annual general meeting (AGM) presided over by a chairman it had appointed.

The court order followed objection by a former director who alleged that election of four IFIC directors at its 20th AGM was illegal.

Earlier, the HC had appointed Barrister Ishtiaq Ahmed to chair the AGM and submit a report within a month.

The AGM held on July 5 elected ASF Rahman, Salman F Rahman, Shahul Islam and A Matin Khan. The report was submitted on August 4.

Later, former director AM Aga Yusuf filed a written objection against the report saying the chairman of the AGM acted illegally in allowing A Matin Khan to seek election as a director "as there was neither nomination nor recommendation" by the directors for his election.

He also said that election of Matin Khan was in violation Articles of Association since all the four retiring directors expressed their willingness to be re-elected and there was no scope for Khan to be allowed to seek election in the absence of any nominations or recommendations.

Presidential appeal to the Bench and the Bar

Quick disposal of justice can restore confidence in judiciary

President Shahabuddin Ahmed has called for quick dispensation of justice so that people do not get frustrated and lose confidence in the judiciary, reports UNB.

"People come to court seeking redress of their grievances. Undue delays in getting justice due to backlog of cases or avoidable adjournments must be stopped," he said inaugurating Bar Vocational Course at Osmani Auditorium in the city yesterday.

The President reminded that the sole duty of the lawyers lies with the courts which are entrusted with the responsibility of enforcing the law. Lawyers are called the officers of the court. It is their solemn duty to assist the court in disposing of various cases between the parties.

"Both judges and lawyers are equally responsible for dispensation of justice. Punctual attendance and full utilisation of court hours are indispensable."

Underlining the importance of training of lawyers, he said there is no alternative to training and motivation in developing awareness about and commitment towards the legal community with a view to establishing a society based on the rule of law.

Sayedee wins at Supreme Court

The Appellate Division of the Supreme Court yesterday allowed the appeal of Jamaat-e-Islami leader Moulana Delwar Hossain Sayedee, setting aside the judgements of the High Court Division and the Election Tribunal, passed in an election case filed by Awami League leader Sudhangshu Shekhar Halder.

By the judgement, the election case was dismissed and the election of Sayedee became valid.

The Election Tribunal, Pirojpur, in a verdict delivered on May 19, 1997 gave directive for re-election in Gharghata Polling Centre and cancelled the election in Pirojpur-2 constituency of the Jatiya Sangsad held in 1996.

Sayedee appealed before the HC against the Tribunal judgement. Sudhangshu Shekhar also filed a cross-appeal.

The HC in its judgement delivered on December 7, 1998 not only upheld the Tribunal judgement but also gave directive for re-election in Barol-bunia polling centre.

Advocate Khandker Mahbubuddin Ahmed assisted by Barrister Moudud Ahmed and Abdur Razzak moved for Sayedee. Barrister Rafiqul Hoque with advocate Probr Halder and Shashanka Shekhar Sarker represented Sudhangshu Shekhar Halder.

fallen alarmingly.

"The reason, I suppose, is that the senior lawyers on account of heavy pressures of work and other preoccupations could not devote much time to the training of their pupils as much as was done in the old days."

Besides, he said, there is a large number of lawyers seeking admission into bar now. The senior-junior ratio has changed unfavourably against such opportunities, which were available in times when the profession was not so crowded.

a future generation of lawyers committed to code of conduct and ethics.

It aims at giving efficient legal service to litigant public and maintaining standard and dignity.

Shahabuddin said the training institute also set up monitoring cells in all District Bars with the help of trained human rights lawyers.
