UNESCO to release CD-ROM on Literacy Day

The UNESCO will release "Asia-Pacific Literacy Data Base" in CD-ROM version on the occasion of the International Literacy Day tomorrow, a UNESCO press release said yesterday, reports BSS.

The CD-ROM includes nine sites: literacy facts and figures, literacy glossary, literacy web, literacy resource centre network, donors and partners, national literacy policies, NFE curriculum, who's who in literacy and ACCU regional literacy programmes.

The press release said UNESCO estimates as many as 876 million adults in the world will enter the 21st century — to be known as information century — without reading and writing skills.

The Data Base is being developed in close cooperation with literacy, non-formal education experts and statisticians from international organisations, government sectors and NGOs and it will be the first comprehensive data base covering literacy situations and activities of 20 countries in Asia-Pacific region.

WHO DG meets FM

The visiting Director General of the World Health Organisation (WHO), Dr Gro Harlem Brundtland, yesterday laid stress on reducing consumption of tobacco in Bangladesh, reports BSS.

Dr Brundtland requested Foreign Minister Abdul Samad Azad to take necessary initiative to reduce the use of tobacco in the country in phases, an official handout said.

The request was made when the WHO chief called on Azad at the latter's office yesterday afternoon.

Holzman meets Khasru

Ambassador of the United States to Bangladesh John C Holzman called on Law, Justice and Parliamentary Affairs Minister Abdul Matin Khasru at his Secretariat office yesterday, reports BSS.

They discussed progress of the proposed National Human Rights Commission in the country. They also discussed bilateral issues and matters concerning mutual interests during the meeting.

Alleged terrorist succumbs to his injuries

An alleged terrorist, who was injured during a gunfight with police at city's Jatra Bari area on August 24, died at the Orthopaedic Hospital yesterday.

Ibrahim, 20 was the son of Abul Kalam, a resident of Dhanbaria under city's Demra Thana area, police and hospital sources said.

Ibrahim sustained critical injuries on his right leg when police and a gang of three terrorists, including Ibrahim, locked in a gun fight at Jatra Bari area in the early hours of August 24.

Sumon, 24, an informer of police was shot dead during the gunfight.

Ibrahim was undergoing treatment under police custody at the Orthopaedic Hospital when he died.

'Edn fundamental right of all citizens'

President Shahabuddin Ahmed yesterday said education is a constitutional right of all citizens, reports BSS.

In a message on the eve of the International Literacy Day, he said the government, side by side with formal education, has introduced non-formal education to educate the underprivileged people of the country.

"It (government) has fixed the target to raise the country's education rate to 62 per cent by the year 2000 and to free the nation from the curse of illiteracy by 2006," he said.

PM calls for unity to eradicate illiteracy

Prime Minister Sheikh Hasina in a message called upon all irrespective of party affiliation and opinion to be united to eradicate illiteracy from the country to face the challenges of the coming 21st century.

"The challenges of the 21st century is to eradicate illiteracy. I called upon all to be united to achieve this objective," she said in the message on the eve of observance of the International Literacy Day and the National Adult Education Week.

Russian envoy calls on Hanif

Russian Ambassador to Bangladesh EP Ivanov called on Mayor of Dhaka Mohammad Hanif at his office yesterday, reports BSS.

During the meeting, they discussed bilateral issues in cordial atmosphere and exchanged views over different development activities of the Dhaka City.
