SNS slams govt decision

Responding to a press report on this issue yesterday, the SNS noted that for the last several years women's organisations have been demanding for increase in number of reserved seats for women in the Jatiya Sangsad and holding of direct elections.

SNS also reminded the government that it was clearly envisaged in National Women Development Policy that number of women's seats would be raised and direct elections would be held in 2001.
