Addressing the rally, they alleged that Shantu Larma and his associates have betrayed with the Jammu people through signing a 'compromise' agreement with the government.

Leaders further alleged that government planned to destroy the Jammu people by promoting inner conflict among the Jammu people and Shantu Larma clique is cooperating with the government to implement that dangerous blueprint.
