#### SEAAT.Flame arrives Feb 1

The South East Asian Flame (SEAAT Flame) for Freedom from Tobacco, launched by World Health Organisation Director General Dr Harlem Brundtland last week in New Delhi as a campaign to reduce tobacco use, arrives Bangladesh on February 1, reports BSS.

The prime objective of the Flame, said a WHO official here, is to strengthen the effort towards a sustained tobacco control campaign in each country of the region by mobilising youth and women's groups and civil society.

The WHO official said the Flame is expected to arrive in Dhaka on February 1 and leave on March 31, 2000 boosting the joint elfort of the WHO and different social forces in fighting the menace of tobacco in the

The WHO Dhaka office has already chalked out a detailed month-long programme of the Flame campaign and w uld provide more information on SEAAT Flame campaign on January 30.

#### CU VC asks employees to resume · duties

From CU Correspondent CHITTAGONG, Jan 29: The Chittagong University (CU) Vice-Chancellor sat in a meeting with Chittagong University Employees' Association (CUEA) and Chittagong University Afficers' Association (CUOA) in his office today to discuss immedi-

ate reopening of the university. VC Professor Abdul Mannan urged the employees to join their respective duties regularly ignoring all kinds of obstruction. He said that to resume the normal activities of the university, the cooperation of all employees is essential. He also assured that security measures

will be taken for them. Meanwhile, today was the fifteenth day of Shibir enforced indefinite siege progamme on the CU campus. Academic activities are disrupted because of the siege but administrative activities are being held partially. More than 60 per cent teachers and employees attended today but no shuttle train or bus plied

between campus and the city. Islami Chhatra Shibir is enforcing a siege on the campus, to protest the killing of two of its activists in a clash with Bangladesh Chhatra League (BCL) on the campus on December 19 last year.

The 14th National Poetry Festival, the greatest festival of the poets and the connoisseurs of literature begins in the city on February 1, reports BSS.

### JU '98-99 1st yr Hons classes may begin in April

First year Honours classes of 1998-99 academic year of Jahangirnagar University (JU) are likely to begin by the first week of April, sources said.

The central admission committee of the university will hold a meeting on February 5 to finalise the date for start of classes.

Students of the session have to lose 20 months of their academic life before their classes begin due to unexpected delays to complete the admission procedure and session jams at the university. They were supposed to begin their classes in August

Since the university is a fullfledged residential one, classes of any new batch cannot be started until the students of the Master Degree final semester batch leave their seats in halls. "As the final exams of outgoing master degree students are yet to begin, we cannot start the classes of the new batch," an official said.

Earlier, the university authorities, at a meeting of the Syndicate, had decided to begin their classes in the second week of February. "But it is now not possible since the master degree examinations will take more time to be complete", a senior teacher said.

The fresh students have not only fallen victim to the delayed and lengthy admission procedure of JU, but also to the admission fee hike resistance movement in September last year which further delayed the admission process by 3 months.


