COMILLA, Mar 5: Comilla Palli Bidyut Samity (PBS)-2 on Wednesday filed a case against the Power Development Board (PDB) seeking injunction to its entry into EPZ area and stop all its activities, reports UNB.

Prime Minister Sheikh Hasina is scheduled to lay the foundation stone of the Export Processing Zone formally on March 12.

Following the case of PBS. the court has issued notice to PDB to show cause by seven days.

PSB-2 implemented the power supply work to the EPZ following the decision of a meeting held in presence of EPZ authority, PDB, Petrobangla and Bakhrabad Gas representatives.

Violating the decision. Executive Engineer of PDB (Sales & Distribution) in a letter on February 7 asked PBS-2 not to set up power lines in Airport. EPZ and adjoining areas.

But PBS ignored it and set up the power line and started power supply to the EPZ on February 29

GOPALGANJ, Mar 5: Unabated sales of non-iodised salt in different bazaars in the district have created health hazards of the people particularly the poorer section, reports UNB.

A large number of people in the district are suffering from different iodine deficiency related diseases like goiter, deaf, dumb, squint, and mental retardation.

Unscrupulous traders, defying government ban, are selling non-iodised salt in the market. Low price of such salt attracted the poorer section of the people who are ignorant as well about the problem.

Non-iodised salt in goodlooking packets with the label of iodised salt is also sold in the market cheating the consumers on the very nose of law enforcers.

A recent survey revealed that about 85 per cent of rural people in the district are using noniodised salt creating serious health hazards for themselves and for the posterity.

Besides low quality Indian salt is also sold in the market without the knowledge of the

were the causes of Kalaroa tragedy? Who are responsible for the incident occurred at Kalaroa SSC sub-centre on Thursday?

spot, this correspondent and other reporters from Satkhira collected different information.

Mentionable that six persons including one school mistress, and two examinees were killed in the stampede incident at Kalaroa Government College sub-centre under Kalaroa High School main centre during SSC examinations on the first day on March 2. The district administration, however, confirmed the death of four persons, including one examinee, one mistress and two guardians.

Regarding causes behind the tragedy, this correspondent was informed that during examination at this sub-centre, Section 144 was not imposed properly. No publicity in this regard was made earlier. Red flags were not hoisted within 200 yards from the sub-centre. This was violation of the government's instruction

The collapsible gate was opened at proper time, but the At the time of enquiry on the other doors at the first and second floors, where the examinations were scheduled to be held. were closed. Besides, the seat plan sheet for the examinees were written in indistinct letters. For this reason it was too illegible.

Every year a group of musclemen belonging to student organisation of ruling party, take control of the entrance and exit passage. For creating opportunity for adopting unfair means inside the examination hall. They also create chaos and takes chances to tease young girls and other ladies during gatherings. In 1999 in this subcentre these musclemen created such a situation and snatched away the girls' gold necklace and wrist watches. The musclemen enjoyed a picnic last year selling the articles. This year also they took control of the passage of first and second floors. When there was a gathering these musclemen teased girl students, mistresses and tore down their clothes.

Evewitnesses told The Daily Star that while such activities were going on, police personnel, however, managed to go upstairs and resorted to lathicharge. At this moment somebody closed the collapsible gate of the ground floor, which caused the tragedy. Different persons said the collapsible gate was closed by order of the Thana Nirbahi Officer (TNO) of Kalaroa. When contacted the TNO of Kalaroa Md Raisuddin and Officer-in-Charge (OC) Md Fazlul Haque said that the TNO was distributing question papers staying at the main centre at Kalaroa High School, while the incident was being occurred at college sub-centre. The TNO said he reached at the sub-centre at about 9.35 am and found the injured persons. He also added that the magistrate also reached the centre at about the same time. The TNO and OC said the Deputy Secretary, Md Abdul Wahab and the assistant hall super for the sub-centre can, in no way, avoid their responsibility

People, however, alleged that the local administration find the student organisation backed by the ruling party are responsible for the tragedy.

Centres in the rural areas are traditionally known as safe haven for lawbreakers in examination halls. Every year hun-


