Bureaucracy trying to torpedo move for effective HR body

A government initiative to set up an independent national human rights commission has drawn stiff resistance from the bureaucracy, active to make it a "toothless institution" The resistance came recently

from the secretariat of the home ministry even after Sheikh Hasina's Cabinet approved a draft Bill seeking constitution of the commission, sources said.

The ministry objected to those provisions of the draft law which, if remain unchanged, would substantially contribute to prevention of human rights violation by government officials in general and law enforcing agencies in retariat said that it "would enparticular.

In the first place, the ministry raised objection to the definition of 'human rights'. The draft Bill said that the phrase 'human rights' would mean "the right to personal life, freedom, equality and status guaranteed by the state's constitution, the rights enshrined in international human rights instruments ratified by Bangladesh and those enforceable through

any court of the country." The home ministry found the definition "broad-based" and was "unhappy" as the Bill envisaged violation of the rights as punishable offence. Arguing for trimming the definition, the home ministry secable any person to sue the

Prime Minister, Ministers and government officials on charge of human rights violation' while "law enforcing agency people have to face cases very

The ministry suggested dropping of another provision that would give the proposed commission the authority to conduct investigation - suo moto or on application of victim/s - into allegation of human rights violation, or failure by any person, group, organisation or public servant in preventing violation of human rights. Draft amendments to **PSA** finalised

The cabinet yesterday finalised the draft amendments to the Public Safety Act, according to official sources.

"The amendments proposed omission of the provision relating to criminal action against police officials for concealing facts or negligence to duty in investigating a case under the PSA", said one source.

But the provision regarding departmental action under Section 18(6) of the PSA has been retained.

The cabinet also approved amendments to Section 16 (3). empowering the appeal court to grant bail if there is reasonable doubt that the accused has not committed the offence. The amendments also provided that -councils through election. the accused should be released on bail till the disposal of the ernment Primary School

In Section 13 (4), a provision has been included so that an accused could be treated also as an

witness. Besides, in Section 14 (3), a provision has be inserted that a tribunal shall not punish any one only on the basis of witness given by a person who died or is not traceable, the sources added.

In another development, the law ministry has notified empowering the District and Sessions Judge of Chittagong to take into cognizance and hold trial of cases from the three hill districts filed under the PSA.

The cabinet also approved the draft Zila Parishad Act 2000 for forming the district It also endorsed the Gov-



12 OTs at DMCH unutilised for lack of equipment

Twelve operation theatres built about two years ago at the Dhaka Medical College Hospital still remain unutilised due to lack of required equipment and instruments.

Doctors say many operations cannot be performed in time because of the shortage of operation theatres. "In many cases, we are forced to reschedule operations and even cancel scheduled operations," said one

Around 20,000 surgeries are performed a year at the DMCH, OTs. Of the total operations, about 13,500 are done under anaesthesia and the rest under local anaesthesia, an official estimate said.

The 12 operation theatres are in a separate OT complex beside the hospital building, built with ADB assistance.

The equipment and instruments need for those are OT light, table, surgery instruments, diathermy machine, post operative monitor/bed, autoclave and instruments for intensive care unit -- ventilator, See Page 12 Col 1
