Int'l confce on arsenic tomorrow

A two-day international conference on groundwater arsenic contamination begins here tomorrow (Saturday) under the auspices of the NGOs, the UNICEF and the Government of Bangladesh.

The conference, third of its kind in last three years, is aimed at sharing experiences and finding future directions for addressing the emergency declared in 1996.

The two-day conference, to be held at the Dhaka Community Hospital, will bring to light various water contamination issues.

Welcoming a large number of journalists, Dr Quazi Quamruzzaman, Chairman of Dhaka Community Hospital Trustee board said, "Based on random surveys across the country, we estimate that about 8.5 crore people are now drinking arsenic contaminated water. We can solve our problem ourselves with the existing technology."

He also added, "In this regard we need a long term policy on watershed management and so we hope to achieve a national consensus during the conference."

It may be mentioned here that Arsenic continues to pose a serious threat to millions throughout the country, as most of the tube wells in 54 out of 64 districts have already been identified as 'contaminated'.

UNICEF Country Representative Shahida Azfar who led a five-member delegation in the

AJM workers block traffic on Dhaka-Ctg Rd

NARAYANGANJ, May 11: Several thousands workers of Adamjee Jute Mills today put up a barricade on Dhaka-Chittagong highway demanding payment of their salaries and allowances.

The workers of the Unit-4 came out of the factory under the leadership of former secretary of CBA Ismail Hossain at 7 am and put up a barricade at Simar Crossing, disrupting traffic for an hour.

Police rushed to the spot and requested the agitating workers to remove the barricade.

As the workers refused to do so, police resorted to lathi-charge.

Amid chase and counter-chase, the workers went back to the mills.

They resumed their duties at 11-30 am following an assurance given by the CBA leaders Atik Sardar and Abdur Rob of disbursing their salaries.

Rajuk in a quandary

Plans for more than 100 buildings approved without records in the archive

As Rajuk tries to tighten its grip over approval of new building plans, its officials have found out that plans for more than 100 buildings were approved without any record in its archive, sources concerned said.

Top Rajuk officials warned that these plans were initially classified as 2C, meaning these do not merit approval. But with the help of an organised gang within Rajuk, these plans were given "3C" category number and approved.

It was found that 'fake' Land Use Clearance 'certificates' were produced for approval of plans for multi-storied commercial buildings at busy road intersections and other places.

In several cases, Rajuk challenged the offenders but it was unable to fight the cases as no record could be traced in its office. Hundreds of files kept under the responsibility of clerks at the Authorised Section 'simply vanished', the sources said.

Recently, when Rajuk's Au-

thorised officer took steps to cancel the plan for a 20-storied building at a busy intersection, he was sued by the developer. The case is now pending and speculations are there that Rajuk might lose the case due to lack of back up files.

There were also instances where the Building Construction Committee approved plans at its meetings held without quorum, in violation of law. At least six top Rajuk officials and a number of employees are now under investigation for alleged involvement in such approval of plans. In one instance of illegal approval of plan for a structure in Gulshan lake area, when the 'approved plan' was obtained, Rajuk's town planner denied that it carried his signature, sources mentioned.

"Some of these offenders are walking away from courts showing documents which do not have any back up copy in Rajuk's Authorised section but bore signatures of approving officials," said a Rajuk source. The irregularities started to

come to light as Rajuk applied stringent measures to ensure proper approval of building plans over the last few months. The measures include submission of plans through architects registered with Rajuk. The plans must include environmental clearance and should also cover risks of earthquake. Rajuk has also stopped approving plans for more than six-storied buildings.

One source said that till recently, more than 70 per cent of Rajuk officials and employees including peons, guards and clerks were involved in "deals related to building plan approval". After imposition of strict measures, a section of employees even brought out procession inside Rajuk office, demanding "relaxation of the plan approval procedures and withdrawal of departmental allegations."

Rajuk Chairman M Azizul Haque, when contacted, told The Daily Star that the entire filing system has been comput-

PM to act as per Constitution

Fresh communications between the govt and the opposition on appointment of CEC

Prime Minister Sheikh Hasina last night said she would now proceed constitutionally to nominate a new Chief Election Commissioner in view of absence of positive response from the Leader of the Opposition Khaleda Zia to her

proposal for a discussion to reach an understanding for the appointment of new CEC following resignation of Mohammad Abu Hena, reports BSS.

In her reply to Khaleda Zia's letter declining to attend the meeting proposed by her earlier, the Prime Minister said although it was not constitutionally obligatory on her part to discuss the appointment of CEC with Leader of the Opposition, she took the initiative to uphold the spirit of democracy and set a rare example in the political history of the country.

The letter was handed over to the office of the Leader of the Opposition at Minto Road last night.

The Prime Minister in her letter to Khaleda Zia said she made the proposal for reaching an understanding on the issue of appointing a new CEC in the greater interest of democracy and to make nation's journey to democracy smooth.

The Prime Minister said that for upholding the norms and spirit of democracy (she took the initiative on the issue of appointing a new CEC although it is her own prerogative under Articles 48(3) and 118(1))

Three transport owners' assoc's oppose strike from May 16

Leaders of three transport owners' associations opposed yesterday the transport strike for indefinite period from May 16 and urged the owners and workers to ply their vehicles during the strike.

The press conference was jointly organised by Bangladesh Truck Owners' Association (BTOA), Bangladesh Covered Van Association (BCVA) and Transport Agency Owners' Association (TAOA) at the National Press Club.

They also urged the leaders of the transport organisations, who have called the strike, to withdraw the strike and to solve the problems through discussion.

They demanded of the government to stop police harassment, build new truck terminals and ease renewal process of route permit and fitness certificate. The leaders expressed their gratitude to the Home Minister for taking effective measures to stop extortion.

Fair and systematic trade union is not a threat to the transport owners, the leaders said adding treacherous leadership based on toll collection

Advani's remark on Kargil war induces Congress walk-out

NEW DELHI, May 11: Indian Home Minister L K Advani's perceived comparison between Indian army's victories in the 1971 war against Pakistan that led to the emergence of Bangladesh and in Kargil conflict last year triggered a heated debate followed by a walkout by the main opposition Congress and Left parties in the Rajya Sabha, upper house of Parliament, yesterday.

Advani, in reply to a call attention motion on internal security problem with reference to Jammu and Kashmir state, said the Indian army's victory in Kargil against Pakistani forces and intruders was different from all other victories in the past.

He said Kargil was a victory for India both on the battlefield as well as on the diplomatic front where India succeeded in winning the opinion of the entire international community in its favour.

Veteran Congress member Karan Singh sharply reacted to Advani's remarks and said it was not correct to 'berate' India's victory in 1971 as it was not only a military triumph but also led to the birth of a new nation.

Advani said there was no question of comparing between

Former civil servant or a judge?

The prime minister has decided to unilaterally nominate the new chief election commissioner.

However, whether a former bureaucrat or a judge should be given the job is still an open question, ruling party sources said.

The prime minister has already communicated to Khaleda Zia last night that following the opposition leader's refusal to the offer to sit for a dialogue, she will now "proceed constitutionally." The constitution allows the PM to unilaterally nominate the person for CEC and advise the president to give the appointment.

A central working committee meeting of the ruling Awami League is expected to discuss the appointment this afternoon, including whether the person should be a judge or a retired civil servant.

"Since the opposition has rejected prime minister's offer for a discussion on the issue, we are now free to go ahead with proposing a name to the president," said an Awami League presidium member.

"In so doing, the party leaders are examining three options: to continue with acting chief election commissioner Moshtaque Ahmed Chowdhury for some time; to give the job to

a retired bureaucrat; or to appoint a Supreme Court judge."

Some ruling party leaders believe there is no legal bar for Moshtaque Ahmed Chowdhury to continue as the acting CEC for some time.

"When (Mohammad) Abu Hena went on leave, he gave Chowdhury the charge of chief election commissioner until he joined the office. Now that Abu Hena has resigned, Chowdhury can continue until a new CEC is appointed," said another presidium member, on condition of anonymity.

ADB links loans with reforms, governance

US\$ 1.5 billion to be disbursed over the next three years

The Asian Development Bank (ADB) has outlined a US\$ 1.5 billion lending scheme for Bangladesh over the next three years (2001-2003), but linked actual disbursement with reforms, good governance and implementation capacity.

At a press briefing yesterday, an ADB mission, on a 15-day visit since April 26 in connection with the preparation of the new Country Assistance Plan (CAP) for Bangladesh, disclosed this.

The visiting ADB mission also expressed its concern over Bangladesh's foreign exchange reserve position and slow pace of reforms and asked the government to maintain a sound macroeconomic policy.

"The actual disbursement will depend on the progress of reforms in different sectors and the efficiency of project implementation by the government," said Rajat M Nag, Deputy Director of ADB's Programmes Department (West) and a member of the visiting ADB Country Programming Mission.

ADB Resident Representative Suphit Suphiphat, Principal Country Officer and Mission Chief Sudipto Mundle, Programmes Manager Kazu Sakai also spoke on the occa-

sion. The visiting officials said that accomplishment of the targeted CAP goals would require significant improvement in governance. The ADB has alerted the government about the large and growing fiscal deficit and in particular, low foreign exchange reserve position, they added.

The ADB mission has just concluded discussion with the government, major stakeholders of the civil society and development partners for formulating the CAP.

According to the new plan, Bangladesh will receive US\$ 500 million annual assistance from ADB, US\$ 200 million up from the earlier amount, of which US\$ 350 million will come from ADB's soft loan window -- Asian Development Fund (ADF) -- with 1.5 per cent interest rate. The remaining US\$ 150 million will be from Ordinary Capital Resources (OCR) with an annual interest of 6.5 per cent.

This is the first CAP that has been prepared after the government and ADB signed a Poverty Reduction Agreement on April 3 during ADB President Tadako Chino's visit to
