NU Honours part III exams

Candidates' mass protest rally tomorrow

Honours part III students forced suspension of classes at Eden College and staged a sit-in demonstration in front of Dhaka College yesterday as part of their continuing movement demanding rescheduling of their part III final exams under National University (NU).

The students of different colleges under National University have also decided to hold a grand rally on June 8 at the Central Shaheed Minar to voice their demand.

According to sources, students brought out processions at different colleges including Dhaka College, Eden College, Jagannath College, Titumir College and Gazipur Bhawal Badre Alam College yesterday to press for their demand.

Students of Eden College forced the authorities to close the college. Similar situation prevails at Jagannath College and Titumir College, sources said.

At Dhaka College, agitating students demonstrated on the campus in favour of their demand and laid siege to the room of the college principal. The principal later held a meeting with the students to bring the situation under control.

According to students, the principal admitted that there is not a single department in the college which has completed more than 30 per cent of the courses as per the NU syllabus.

Dhaka College principal also informed the students that the National University (NU) authorities will shortly have a meeting with all of college principals to discuss the issue.

She assured them that she would recommend in favour of their demand at the proposed

meeting.

Meanwhile, the agitating students sent letters to the students of different colleges across the country asking them to join the grand rally at the Shaheed Minar.

One of the student leaders told The Daily Star that they are making preparations to make the rally an all-out success.

Scouts workshop from tomorrow
