



SKOP calls 24-hour strike today

Sramik Karmachari Oikya Parishad (SKOP) has called a 24-hour countrywide strike beginning at 6 am today to press home its demands.

"We have decided to go ahead with the strike programme as a dialogue with the Minister for Labour and Manpower yesterday failed to yield positive results, one SKOP leader told The Daily Star yesterday.

Earlier, SKOP leaders at a press conference yesterday called upon all concerned not to open educational institutions, industries, offices and business establishments. Rail-road and river transports will also come under the purview of the strike, SKOP leaders said.

Sramik Dal president Abdullah Al Noman, Dr Wajedul Islam Khan, Shah Mohammad Abu Zafar and Abdullah Safar addressed the press conference at SKOP's temporary office.

NCB cheques to have water marks

Bodies of 58 Asian migrants found in container truck at UK port

DOVER, England, June 19: The bodies of 58 people, believed to be asylum-seekers from Asia, were found early today inside the refrigerated container of a truck in this busy southern English port, police said, report agencies.

Two other men were found alive inside the air-tight compartment of the Dutch-registered vehicle and were recovering from their ordeal in hospital, a police spokesman said.

The gruesome discovery was made shortly after midnight after the truck arrived in Dover on a ferry from the Belgian port of Zeebrugge. Unconfirmed reports said the dead comprised 54 men and four women, but no children.

Customs officers were "absolutely horrified" when their routine inspection revealed the grisly pile of bodies, but police could not confirm whether the unfortunate stowaways had died of suffocation or cold.

"They all seem to be Oriental (East Asian) and if you were to look through the numbers of people claiming asylum in this country, the most common Oriental group are Chinese. But this has to be confirmed," a Home Office spokesman said.

Police arrested the Dutch driver of the 15-meter long truck. The vehicle aroused suspicion because it was registered to a company, Van Der Spek, which had not used the route before, ferry operators P and O Stena Line said.

Food gap reduced to zero, first time in the country

The country's food-gap came down to zero in 1999-2000 for the first time, according to official sources.

The latest production has been projected at 243 lakh metric tons (MT) against a net annual requirement of 213.58 lakh MT of foodgrain. Deducting the 10-12 per cent usual crop loss, the net food production settles exactly around the requirements level.

As per the estimations, Bangladesh grew 7 lakh MT more rice than the requirement in 1999-2000 and again, it produced 7 lakh MT less wheat than it needed.

Never before in the 30-year history of Bangladesh had the domestic production been at par with the domestic requirements. Ten to 20 lakh MT of food gap has been an annual phenomenon for Bangladesh.

Each year Bangladesh used to cover up its food deficit by accepting an average volume of 5 to 10 lakh MT food from donors and by importing.

This time though the government heaved a sigh of relief as it avoided pressure on the scarce foreign exchange reserves by abandoning the fiscal plan of food import (four lakh

MT) in 1999-2000.

Experts told the Daily Star that such surge in production could not have happened in a better time since food aid commitments from abroad were already on the slide.

Thanks to the subsequent bumper in wheat and paddy productions, the projection of 224 lakh MT at the beginning of the year was revised upward at 243 lakh MT at the end of the fiscal.

According to officials, *aus* production stood at 1.73 lakh MT, *aman* 10.3 lakh MT, *boro* 10.6 lakh MT (projected) and

Procession was brought out during the hartal hours while a rally was held at the Court Point in the afternoon with the district JCD president Mizanur Rahman Chowdhury in the chair.

40 bighas of govt land in Mirpur illegally occupied

DUIIP plan to allot 1100 plots to low income group uncertain

Over 40 bighas of government land at Mirpur Section -12, earmarked for allotment of plots to low income people, could not be recovered from illegal occupants in several years.

The Department of Housing and Settlement can not remove the illegal slums there because of a court injunction, sources in the Department said.

The land was demarcated into about 1100 plots, each measuring three-fourths of a *katha*, for allotment under the Dhaka Urban Infrastructure Improvement Project (DUIIP).

The Department also failed to allot plots to the allottees in its Mohammadpur "F" Block as the land is illegally occupied by some people, the sources said.

Slums have sprang up and

some shops have been built on the land along the Shyamoli Ring Road. During a visit to the area, some shop owners said they built shops with permission from the local member of parliament.

A total of 23,063 applicants applied for the 470 plots in "F" Block, categorised as A, B and C. They paid Tk 30,000 for A, Tk 25,000 for B and Tk 15,000 for C category plots, some of the applicants said.

Applications were invited from middle and low-income groups of people in January 1998 for the plots in "F" Block.

The Housing Department, failing to recover the land at Mohammadpur, later proposed to the Ministry of Planning for construction of 720 flats instead of allotting plots.

"The proposal was made to accommodate more people on the land," a high official of the Department told The Daily Star seeking anonymity.

"The land can not be recovered as there is a High Court injunction on eviction of the slum," the official said.

About one thousand applicants have already withdrawn their applications due to uncertainty in getting plots, some of them told this correspondent.

"If the government can not recover the land or wants to build apartment buildings, it should inform the applicants through a public notice," said an applicant, Masud Kabir.

Housing Department officials said any applicant can withdraw his application and get back his money.

Opposition likely to enter parliament today

The opposition parties, boycotting parliament proceedings since July 8, 1999, are expected to return to the House this morning.

The adjournment of the House immediately after the passage of the supplementary budget at 10:40 a.m. held back the opposition's much-awaited return yesterday. Khaleda Zia, the Leader of the Opposition in parliament, arrived at the parliament building at 11 a.m.

Deputy Leader of the Opposi-

tion in parliament Prof. Badruddoza Chowdhury told reporters yesterday, "We've asked our party MPs to be present at the parliament lobby at nine in the morning tomorrow (Tuesday)."

"We will go back to the House to protect the Constitution, not to protect what the ruling party says, the seats and salaries," he said, explaining reason behind the return.

Prof. Chowdhury, briefing waiting journalists after the ad-

joined meeting of the BNP parliamentary party that ended at 11:30 a.m., claimed that the opposition had definite information about the ruling party blueprint to scrap constitutional provision for national elections under non-party caretaker government.

"Now we know it for sure that the government wants us to stay outside the House. If the opposition seats are vacated, the government would fill up

Negotiations on blocks 19 & 20 resume with Maersk Olie

Petrobranga resumed negotiations on Sunday with Euro-pean oil company Maersk Olie for oil and gas exploration in deep sea blocks 19 and 20.

The company is now taking up various issues including taxation and duration of the initial operation period (IOP). Sources concerned said Maersk Olie seeks a five-year IOP instead of the three-year time frame outlined in the Model PSC. Negotiations with it resumed after two months.

Maersk is seeking a PSC for mainly conducting seismic survey in deep sea blocks 19 and 20 instead of focusing on drilling exploratory gas or oil well.

It argues that deep sea blocks require heavy investment for developing a gas or oil field (in

case of discovery) and ensured supply of the gas or oil to consumers. Therefore, it wants the government to ensure purchase of its gas. Since the government is not willing to sign any Gas Purchase and Sales Agreement now, Maersk seeks a seismic survey oriented PSC.

Petrobranga is also likely to hold negotiations on block 11 with Malaysian national oil company Petronas later this month. Some sources however said Petronas has informed Petrobranga that it is interested in both blocks 9 and 11 and not block 11 alone.

Meanwhile, Petrobranga is waiting for a joint response from Irish oil company Tullow and American oil company Chevron regarding the govern-

ment's recent proposal regarding block 9 that Bangladesh exploration company BAPEX should be the operator. BAPEX has a 10 per cent carried over interest in this block while Chevron, Texaco and Tullow has 30 per cent interest each.

The government proposed this to end disagreement between Tullow-Chevron and Texaco about which company would be the operator in the block.

While Chevron-Texaco agreed to the proposal, Tullow did not. The government then suggested that the three companies discuss the proposal among themselves and give the feedback soon.

Sources said Tullow has un-
