PM at Nat'l Trained Imam confce  
**AL devoted to uphold  
cause of Islam**

Prime Minister Sheikh Hasina yesterday said Awami League is always devoted to uphold the cause of Islam but never believes in making 'trade' in and 'politics' with religion, reports BSS.

"Our government is dedicated to serve the cause of Islam and will continue this role also in future," she said while speaking as chief guest at the "National Trained Imam Conference and Prize-giving Ceremony."

Held at the Osman Memorial Auditorium under the auspices of Imam Training Academy and Islamic Foundation, Bangladesh, the function was also addressed by State Minister for Religious Affairs Maulana Nurul Islam, MP Secretary of the Ministry of Religious Affairs Mohammad Mahfuz Sobhan and Islamic Foundation Director General Maulana Abdul Awal.

"We believe in work — our *Taman* and *Akida* are truly reflected through our deeds," she said. In this connection, she recalled that the Father of the

Nation Bangabandhu Sheikh Mujibur Rahman silently worked for expansion and welfare of Islam. He never utilised religion for political interest, the prime minister added.

The prime minister said that since assumption of power by her party a number of ambitious projects have been taken for welfare and development of Islamic activities in the country. Among others, she listed construction of Hajj camp at a cost of Taka 40 crore, Islamic Foundation Bhaban at Taka 10 crore and allocation of Taka 21.80 crore for establishment of Imam Training Academy and for taking various socio-economic development projects by the trained Imam.

Besides, she pointed out that Taka 1.25 crore has been sanctioned for expansion of Jamaat-ul-Falah cum Islamic Centre in Chittagong, allocation of Taka 15 crore for construction and beautification of the Minar of Baitul Mukarram

Mosque and inclusion of the manpower of 43 district Islamic Foundation centres under revenue heads.

The prime minister declared that under Islamic Foundation the government will soon launch poverty alleviation programmes under which poor people — particularly women — would be provided credit and other facilities for creation of self-employment opportunities.

The prime minister declared that considering the plights of the Imam, particularly their family members in their absence, her government is considering floating of a "Welfare Fund" for the Imam of the country's mosques.

Stressing the need for training of the Imams to face the impending challenges of the time, the prime minister said that the ongoing training of the academy would be further expanded. She pointed out that so far 43 thousand Imams were trained under the programme.

While handing over the cheque, the Prime Minister inquired about the arrangement made for the treatment of the baby and assured further help, if needed.

Hasina highly appreciated the move taken by friends and admirers of the artist couple for raising fund for the treatment and expressed the desire to buy their art works for making further contribution.

Artist Hashem Khan was present on the occasion.
