

# 10 killed as bomb goes off in crowded Pak train

KARACHI, July 16: A bomb ripped through a crowded passenger train bound for the city of Karachi in Southern Pakistan today, killing 10 people and injuring 30 others, railway officials and doctors said, re-

The train was pulling out of the station in Hyderabad, 160 kilometers north of Karachi, when the bomb went off in a rear railway car, officials said.

Troops promptly cordoned off the area. Railway officials said residents reacted quickly. rushing victims to a nearby

hospital No one claimed responsibility for the explosion, and police said they had no suspects.

"It was an act of terrorism, but it is premature to say who was involved," said Hyderabad police superintendent Moazim Jah Anzari. "We are investigat-

Four passengers died in the emergency ward of the hospital, railway workers said. Hospital officials said another four people died within an hour. Another two passengers died later

of their injuries. Doctors said the number of injured also increased as passengers arrived at the hospital with minor injuries, many of them with cuts and bruises. There were still several passengers considered to be in serious condition, they said.

The authorities were still trying to identify four of the dead, said the state-run news agency Associated Press of Pak-

The hospital also declared an emergency, putting out an appeal for blood donors and calling in additional staff to

help treat the victims. "The train was just leaving when there was a huge bang.

smoke everywhere and people screaming," said a passenger, who identified himself only as Azim. He was traveling with his sister and her two children in the passenger car carrying the

explosive device. But the man only suffered cuts and bruises. The rear of the railway car was a tangled mess of twisted steel.

In recent months, there have been several bombings in Pakistan. Most of the explosions have occurred in the eastern province of Punjab, the country's largest and most populous region.

However, Karachi, Pakistan's largest city of 14 million people, also has been a target.

Pakistani authorities have blamed many of the explosions on neighboring India, but the accusations have not been publicly backed by evidence.

## Col Malek dead

Col (retd) M A Malek, a veteran-freedom fighter and Awami League leader, died of heart attack in the city's Suhrawardy Hospital early yesterday morning. He was 68, reports UNB.

Family sources said Col Malek was admitted to the hospital on Friday night as he fell sick during a public meeting in Manikganj

He was buried at his family graveyard in Manikganj. Late Malek was Mayor of

Dhaka City Corporation and Textile Minister of Ershad government. He joined Awami League and contested the parliamentary by-election from Manikganj last year. He left behind his wife, a son

and a daughter.

Prime Minister Sheikh Hasina yesterday visited the Baridhara residence of late Malek and expressed her deep shock at the sudden demise of the AL leader. She also consoled the bereaved members of his family.

#### Two fishermen drown in Bay

They were identified as Abul Fazal, 55, and Mofizur Rahman, 22.

#### Bangabandhu Murder trial

## HC hears confessional statements of Faruq, Shahriar

The High Court yesterday heard confessional statements of Faruq and Shahriar, condemned in the Bangabandhu Murder Case, reports UNB.

The court will hold hearing today and is expected to give ruling on a petition for outsidethe-prison treatment of another condemned accused, Bazlur Huda, providing him with daily necessaries like nail cutter and allowing him to meet his counsel.

Proceedings in the court of Justice Mohammad Ruhul Amin and Justice A B M Khairul Haque, hearing the death reference and convicts' appeals in the historic case, remained adjourned for threeand-half hours yesterday from

11.30 am. As the hearing began after weekend in the morning, defence counsel Afzal Hossain read out remaining part of cross-examinations of investigation officer ASP Abdul Kahar Akand from page 638-650 of the 1099-page paper book.

When he sought permission to start reading from examination of the accused by the trial court under Section 342 of the CrPC, the HC division bench asked him to read out from confessional statements of the accused terming those "more im-

from confessional statements of Lt Col (dismissed) Syed Faruq Rahman and Lt Col (retd) Sultan Shahriar Rashid Khan from page 740-752. They, however, have petitions to retract the confessions, incorporated in a supplementary paper book for

In his confessional statement Faruq said as per plan Col Abdur Rashid had political con-tact with Khandakar Mushtaque. "Rashid, Dalim and Mushtaque decided to topple the BAKSAL government and I supported for logical reasons," he had stated before a magistrate court after police remand.

Faruq in his statement. made under Section 164 of the CrPC, quoted Abdur Rashid as saying that the then deputy chief of army staff, Major General Ziaur Rahman, would sup-port the bid if they could kill President Sheikh Mujibur

Rahman. Elaborating on their final operation preparations in the name of night parade in the small hours on August 15, Faruq said as one officer had wanted to know about the bid, he replied that there was no other option but to change the government.

"Bangladesh will be subservient to India. The key is one person - Sheikh Mujib - ... Then the lawyer read out There is only one way ... The

change is possible through proclamation by him (Mujib). I he doesn't agree, if there is any resistance, none of us will survive," Faruq had said before the putsch.

... So he (Mujib) will have to be executed. Political change will be dealt by Rashid," the principal accused in the murder case confessed in the magistrate court to have said to the officers during the night parade.

About Faruq's role in the most gruesome killings in the country, Col Shahriar in his confessional statement said he (Faruq) by moving in a tank had inactivated the Rakkhi Bahini and gone to Bangabandhu's residence on August 15 morning.

Shahriar said he, Rashid Chowdhury and another officer had gone to Serniabat's home and then radio station already captured by Major Dalim while Major Mohiuddin, Major Noor Major Bazlul Huda and Major Aziz Pasha conducted operation at 32 Dhanmondi street.

According to his statement, Risaldar Moslemuddin had made the foray into Sheikh Moni's residence. Major Mohiuddin along with 2 Field Artillery men fired from cannon on the residence of President Sheikh Mujib from other side of Dhanmondi Lake.

#### Body to resolve power problem in garment factories soon

By Staff Correspondent The Bangladesh Garment Manufacturers and Exporters Association has urged the gov-ernment to act to resolve power and gas problems in the garment factories.

A BGMEA delegation led by its president made the appeal yesterday while it called on State Minister for Energy and Mineral Resources Prof. Rafiqui Islam, said a BGMEA press release.

BGMEA President Anisur Rahman Sinha told the state minister that power crisis has been seriously hampering production in export-oriented readymade garments.

The minister said the government is very sincere about the development of the garment industry and that a joint committee comprising representatives from the ministry, BG-MEA, Dhaka Electric Supply Authority (DESA), Power Development Board (PDB) and Rural Electrification Board (REB) shall be formed to resolve power problem, the press release said.

The joint committee will submit recommendations before the prime minister on how to deal with the power crisis in garment factories, the state minister said.

The DESA chairman and other senior officials of DESA and PDB were present during the meeting, the press release added.

flee with minor injuries. Earlier, the attackers fired 20 bullets and exploded bombs

to terrorise people. Later, local people put up barricades at C&D-Crossing blocking traffic on the Bagerhat-Khulna highway for an hour from 5 pm protesting the killing.

Police rushed to the spot and brought the situation under control

# Rejoinder

This rejoinder is issued to contradict misleading imputations carried in a news item published in a Bengali Daily Newspaper on July 10th against ARKAY TEXTILES MFG. CO. LTD.

To put the record straight the following facts are placed for general information:

- 1. ARKAY TEXTILES MFG. CO. LTD. is an Export oriented Textile Industry. It was allowed by the Custom, Excise & Vat authorities to pay Excise Duty on its local production under the provisions of Rule 96KK of the Excise and Salt Act, 1944 vide their License No. 4/R/License/Tex/2/93 dated 4.8.93. The authorities issued the License after examining the relevant legal provisions as existed at the time.
- 2. Since then ARKAY TEXTILES MFG. CO. LTD. has been regularly paying Excise Duty on the basis of the above Rules and has never defaulted in its payment. Copies of receipted challans through which Excise Duty has been paid every month have also been regularly submitted to the authorities. The facilities granted under Rule 96KK is still available as the same has not been cancelled or withdrawn.
- 3. For sometimes past there has been a change of interpretation of relevant legal provisions by Custom, Excise and Vat authorities as to relevant legal provisions relating to the applicability of the Excise and Salt Act. 1944 vis-a-vis- VAT Act relating to towel. While ARKAY TEXTILES MFG. CO. LTD. has been maintaining that 'Towel' produced by it is an excisable item under the Excise and Salt Act, 1944 and hence not liable to payment of VAT, it has been the stand of the authorities that Towel is an item that should come under the VAT Act and liable to Vat and not Excise Duty. Strangely enough, the authorities never cancelled or withdrew the facilities they provided to ARKAY TEXTILES MFG. CO. LTD. under the license granted by them under Rule 96KK of the Excise and Salt Act, 1944. Surely for the same item there can not be payment twice once under Excise Act and another under Vat Act. ARKAY TEXTILES MFG. CO. LTD. strongly maintain that towel was covered by Excise & not Vat.

has been vindicated by the passage of Finance Bill 2000 during last session of the parliament where in due amendments have been brought in the First Schedule of Excise and Salt Act 1944. Thus, before this amendment was brought, Towel continued to be covered by Excise Act and not Vat Act.
