## 75th birth anniversary of Tajuddin Ahmed today

The 75th birth anniversary of late Tajuddin Ahmed, Bangladesh's first Prime Minister and one of the leading architects of the War of Liberation, will be observed today, reports BSS.

To mark the day, Tajuddin Smriti Sangad will launch two books — Second part of the Tajuddin's Diary (1949 to 1950) and Tajuddin Ahmed: Hithar Pata Thekey' containing his speeches, statements and interviews from 1969 to 1974. The ceremony will be held at the Institution of Engineers.

Muktijuddha Jadughar has arranged a week-long photography exhibition beginning today. Rare photographs of late Tajuddin Ahmed will be put on display.

Tajuddin Ahmed was born in 1925 at village Dardaria under Kapasia thana of Gazipur district. He dedicated his whole life to the service of the teeming millions in this part of the world. He was a very good student as well as an orator, organizer and politician.

## Goods worth Tk 5 lakh looted

Robbers looted cash, gold ornaments and other valuables worth about Tk 5 lakh from a house in the city's Mirpur area early yesterday.

Police said a gang of six robbers entered the residence of Alhaj Aminul Huq, located on the first floor of the building at 15/A/B first colony Mirpur, after cutting open the grills of the kitchen window, at about 3 am in the morning.

"The robbers confined us in a room and took away the key of the wardrobes at gun point", police quoted a victim as saying. The gang beat up the inmates of the house when they tried to call for help.

The robbers took away Tk 23,000 in cash and 11,000 Saudi Riyals, 40 tolas of gold ornaments and a licensed gun.

Aminul Huq, owner of the residence, filed a case with Mirpur police station in this regard. None was arrested till last night.
