larviciding was conducted to

Hanif yesterday monitored

Khilgaon Samajik Sangstha.
He inaugurated a community
awareness rally. The mayor
himself took part in larvicide
operation in the area.Mohammad Hanif in a brief
address to the local people urged
to cooperate with the ongoing
DCC programmes aimed at
eradicating mosquitoes and
other wastes. DCC commis-
sioner Mohammad Monsur Ali,
former commissioner, Polish
Anwar accompanied the city
mayor.Meanwhile, the DCC authori-
ties have reiterated their ap-
peal to the city dwellers to clean
flower pots, broken bottle, poly-
thene bags and adjoining areas
of their houses to contain pro-

The Bangladesh Medical As-
sociation (BMA) de-
manded withdrawal of the
transfer order of four cardiolo-
gist and cardiac surgeons and
the suspension order of three
other doctors of the National
Institute of Cardiovascular Dis-
eases (NICVD), said a press re-
lease.
Following a fruitful meeting
of BMA with the ministry con-
cerned, the work abstention
programme was postponed for
three weeks at the NICVD.
BMA hoped that the gov-
ernment would take satisfac-
tory steps regarding punitive
actions against the three doc-
tors, it said. But the Health
Ministry has suddenly trans-
ferred the four doctors, it
added.
