

Parties urged not to nominate fundamentalists, bank defaulters

Speakers at an anti-terrorism meeting in the city on Monday urged the political parties not to nominate fundamentalists, terrorists and bank defaulters in the next general elections, reports BSS.

They also blamed government for not taking effective actions against the fundamentalists who, they alleged, have built huge armory of latest arms across the country aiming to grab the state power by the "Taliban" style of Afghanistan.

"Santrash Birodhi Shanti Andolon", a bar council's social movement against growing terrorism, held the meeting with its convenor Barrister M. Amirul Islam in the chair at the Institution of Engineers.

The meeting was attended by Pro-Vice Chancellor of Dhaka

University Prof. Shahadat Ali, eminent cultural personality Syed Hasan Imam, former diplomat Wallur Rahman, Acting Editor of the Daily Ittefaq Riazat Khan, Advocate S. S. Halder, Syed Ahmed, Prof. Abdul Mannan Chowdhury and Prof. Aminul Huq, among others.

Initiating the discussion Barrister Amirul Islam observed that an identified group of fundamentalists had been trying to create a reign of terror across the country. "This fanatics have dared to kill eight people including six student leaders in Chittagong, journalist Shamsur Rahman and planted bombs in a bid to kill the prime minister at her own constituency Kotlaipara," he said.

"Even the fundamentalists

are threatening to kill Hasan Imam and ADAB chairperson Dr. Kazi Faruk Ahmed," he added.

Barrister Islam said terrorism has become the number one barrier for democracy, development and progress of the national economy. Terrorists, he said, should be dealt with an iron hand. They (terrorists) should also be boycotted socially by all.

He urged political parties to avoid fundamentalists, corrupts and terrorists in nominating as their party candidates.

Hasan Imam urged all irrespective of party affiliation to come forward in resisting the fundamentalists and anti-liberation forces in the country. He said the defeated forces of 1971 have been conspiring to jeopardise the ongoing democratic atmosphere in the country.

Advocate S.S. Halder said the fundamentalists have been hatching an evil design to divide the nation by fueling on communalism. He said the fundamentalists do not believe in religion as they used religion for their political purposes.

Hartal disrupts academic activities at DU

The academic activities at the Dhaka University were disrupted but administrative activities were conducted partially during the hartal yesterday.

A DU press release said that administrative activities at the Registrar Building and hall offices were done normally and all scheduled programmes were held as usual.

Central Library, Science Library and all the banks on the university campus were open but the attendance were very

thin during the hartal hours.

Classes could not be held but the scheduled examinations at the Arts Building and Karzon Hall examination centres were held as per schedule. "None was absent at the examination centre," Deputy Examination Controller Md Abdul Latif said.

However, no untoward incident was reported on the campus during the hartal hours.

Meanwhile, ruling party's student wing Bangladesh Chhatra League (BCL) brought out a procession and held a rally on the campus protesting the hartal.

Addressing the rally at Aparajeyo Bangla, BCL leaders said that BNP-led opposition is conspiring to destroy democratic institutions and to save the killers of Bangabandhu Sheikh Mujibur Rahman as well.

They also urged the students' community to take preparations for a "second Liberation War" to eliminate the "evil forces".

Presided over by Bahadur Bepari, the rally was addressed, among others, by Ajay Kar Khokon, Anisur Rahman, Ashraf Azim Rubon and Prashanta Bhushan Barua.

Bangabandhu murder Silent procession in city demanding execution of verdict

Bangladesh Mohila Awami League women's front of the ruling party brought out a silent procession in the city yesterday demanding immediate execution of the killers of Bangabandhu Sheikh Mujibur Rahman.

Starting from the Suhrawardy Uddyan the procession led by Mohila Awami League President Begum Ky Rahman was concluded at the Bangabandhu Bhaban in the city's Dhanmondi area.

Later a rally was held at the Bangabandhu Bhaban which was addressed by AL General Secretary and Local Government Minister Zillur Rahman. State Minister for Shipping Mofazzal Hossain Chowdhury Maya, Language Movement hero Adv Gazul Haq, Adv Shaha Khatun, Khaleda Khanom and Mokbul Hossain, MP.

Zillur Rahman alleged that BNP-led four party alliance was conspiring to foil the verdict of Bangabandhu Murder Case and save the self-confessed killers. He demanded of the government to execute the killers of Bangabandhu immediately.
