## Taka dips to its lowest since 1975

The Bangladesh Bank yesterday devalued taka by about six per cent, the highest since 1975, making the dollar costlier by Tk three.

With the new rate effective from Sunday, the official buying rate of dollar has been fixed at Tk 53.85 from the previous Tk 50.85 and selling rate at Tk 54.15 from Tk 51.15. The middle rate will be Tk 54.

The last devaluation was made on November 30, 1999 when taka was made costlier by three per cent.

According to foreign exchange dealers, the market was anticipating a devaluation for the last few weeks, especially when Pakistan and India also devalued their currencies late last year.

Every Thursday, there was panic in the market and traders would take forward cover to hedge their currencies, said dealer of a foreign bank. "Incidentally, we had fewer requests for forward coverage this

### PM's remarks

Contempt petition likely to be filed with HC on Sunday

A group of pro-opposition lawyers has collected nearly 300 signatures of lawyers on a Vokalatnama for filing a contempt petition against Prime Minister Sheikh Hasina for her recent remarks on the judiciary.

On behalf of the group, BNP leader Barrister Maudud Ahmed is preparing the draft of the petition which is likely to be filed with the High Court on Sunday, sources close to the group said.

But it was yet to be decided who would file the petition. The group is pressing the President of Supreme Court Bar Association, Barrister Mahmud Hossain, to be the petitioner.

He has maintained so far that he would move the petition if it is backed by all irrespective of party affiliation.

SC Bar sources said the Executive Committee of the Association has already authorised its President and Secretary to file the contempt petition.

## Govt seeks to address weaknesses within

Special body to recommend measures to improve public prosecution, police probe

The government has initiated a move to address weaknesses within itself in the wake of raging controversy over granting of bail to accused in sensational criminal cases.

But, its tension with the judiciary is yet to subside, with Prime Minister Sheikh Hasina continuing criticising the court for indiscriminate granting of bail to the criminals under trial.

Defending her position during a meeting with a delegation of Dhaka Reporters' Unity at her office, the prime minister said she is ready to appear before court to tell the hard reality.

On several occasions, the prime minister criticised courts,

the higher courts in particular, for granting bails to notorious criminals and said the practice is a major obstacle in the way of curbing crimes. The PM's remarks drew widespread reproach from different quarters, including the lawyers.

In search of an effective mechanism to check the trend of setting notorious criminals at large on bail indiscriminately, the government has recently formed a three-member committee, a Law Ministry official told The Daily Star yesterday.

Headed by Additional Attorney General Mehbub Alam, the committee will look into the lapses on the part of the government, and suggest ways to

improve the performance of the public prosecutors and police officers in the process of opposing moves for such bails, added the official, preferring anonymity.

A high level meeting at the Law Ministry on Tuesday also decided for action against the public prosecutors and the investigating police officials for their failure to perform properly in opposing bails for the criminals, according to meeting sources.

The meeting, chaired by Law Minister Abdul Matin Khasru, also decided that the police and the public prosecutors would be provided with necessary logistics

## PM stands firm on her views on judiciary

Remarks reflect people's sentiment, says Hasina

Denying the allegation of contempt of court, Prime Minister Sheikh Hasina yesterday said that what she told about the judiciary was for the interest of the people only, reports UNB.

"What I've said reflects the sentiment of the people. I've not said anything to undermine the court or the judiciary," she told a delegation of the Dhaka Reporters' Unity at her office.

The Prime Minister said: "I don't know where and how I've violated the Constitution or undermined the court. I am working for the people and despite all criticism I'll say whatever is necessary for protecting the interest of the people, for the welfare of the people."

Hasina said she is ready to face anything for safeguarding the interest of the people. "I will not hesitate, even if I have to face cases or criticism."

Pointing out the positive impact of her repeated comments on the process of grant-

ing bails of the criminals, she said a result is being shown. Police, administration and other related people are getting the chance to be corrected, flaws are being rectified.

"If the people can get some benefits from my efforts, I am happy," she said, vowing to continue her crusade for the welfare of the people. "I'll face all odds and obstacles for the interest of the people."

The 19-member delegation of the DRU, led by its president Anwarul Huq and general secretary Monwarul Islam, asked questions about the political and economic condition of the country, as well as the law and order and other current issues.

The Prime Minister said her government was trying heart and soul to solve the existing problems of the country and for restoring discipline in all sectors.

She said that for curbing terrorism, her government has taken stringent action against

the terrorists. Even a ruling party man is not spared if found involved in any criminal activity.

"We don't give indulgence to terrorism or corruption, unlike what had happened in the past. We've not tolerated any kind of terrorist act," Hasina said. "Can you cite an example I've not taken action against the member of my party if he is involved in crime?"

Rather, she said, actions against the terrorists were hampered by the obstacles caused by the opposition parties, which allege that opposition members are being suppressed if any of the terrorists belonging to opposition parties are arrested.

The opposition parties are giving protection to the terrorists through political cover, she alleged. "If the opposition party activists are arrested even with illegal arms then those parties issue statement and launch

## Report on voters at Khaleda's residence misleading: BNP

BNP has protested and condemned the misleading information about the number of voters registered at the candidate's residence of Leader of the Opposition in Parliament Khaleda Zia, reports UNB.

Clarifying the actual situation, BNP Secretary General Abdul Mannan Bhuiyan in a statement yesterday said Khaleda Zia, her two sons with their wives live there. Private staffs, drivers, peons, gardeners, sweepers, cooks, maids and government and non-government security staffs also live at her No 6 Sahheed Moinul Road residence.

Besides, the main house at 6 Shaheed Moinul Road compound, there are staff quarters, barrack for security forces and separate houses.

All those staying in the compound during registration of voter have enlisted their names on their own.

Khaleda had no personal desire or direction to enroll them as voters with her residential address.

None of them are fake or false voter, asserted Bhuiyan. The number of voters enrolled in the previous list was higher than the present, one, he added.

## Two killed in city

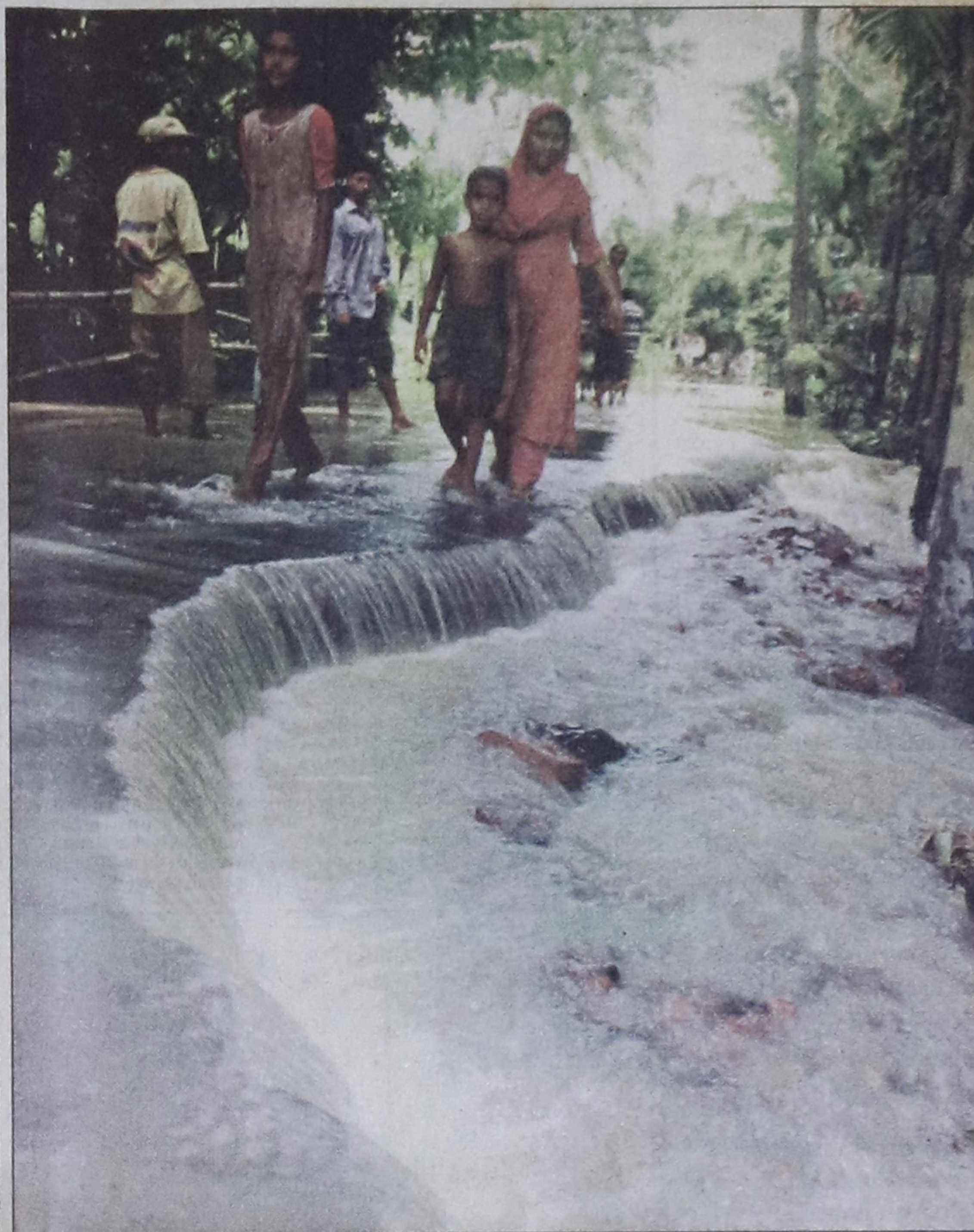

## Flood situation worsens: 2 drown

Flood situation in the country deteriorated yesterday with further swelling of some rivers, reports UNB.

Two boys drowned in Manikganj while several lakh people remained marooned in different districts.

The died were identified as Robin, 4, son of Abbas Ali of Uttar Seora in Manikganj town and five-year-old grandson of Chandu Miah of Dighulia village in the district.

The Padma and the Jamuna receded by 3 cm at Aricha and Goalundo points but the flood-hit areas in Singair and Satturia upazilas were submerged further.
