Bumper sugarcane yield expected

RAJSHAHI, Sept 2: Bumper sugarcane production is expected in Rajshahi Sugar Mills (RSM) zone in the current season, sugar mills officials said.

Officials have attributed the high hope of bumper yield to favourable weather and availability of seeds, fertilisers and pesticides during farming.

According to the officials, the crop has been cultivated on 15,374 acres of land under the zone. Out of the total, 1,800 acres of land in 40 blocks under 10 sub-zones have been brought under high yielding varieties (HYV) of sugarcane.

About three lakh metric tons of sugarcane are likely to be produced this season, RSM officials said.

During the last season, 2.5 lakh metric tons of the crop were produced by cultivating 23,000 acres of land.

Average production rate was 12.44 metric tons per acre last year, while the rate will be 20 metric tons per acre this year, RSM officials hope.

When contacted, RSM General Manager Suraj Rahman Shaikh total this correspondent that the production could surpass the target as sugarcane plants had grown very well, thanks to mainly favourable weather condition.

However, he cautioned illegal operation of power crushers in

the mills zone must be stopped to achieve sugar production in the mills.

At least 40 power crushers are in operation in the mills zone, RSM General manager (Agriculture) Emdadul Haque said. Each machine crushes three tons of sugarcane every day, he added. "Two power crushers were seized this week".

Haque said owners of power crusher are active now, but sugarcane plants will still grow by two feet. Crushing of immature sugarcane causes a great loss as percentage of sugar in sugarcane is much below now, he added.

According to the officials, newly developed HYV Ishwardi-20, 24, 25, 28 and 29 have been cultivated on about 35 per cent of the total land. These varieties will give a production rate of about 30 metric tons per acre, officials said.

Meanwhile, Rajshahi Sugar Mills fixed a target to produce 10,270 metric tons of sugar by crushing 1,30,000 metric tons of sugarcane during the current season.

In the last season, RSM produced only 6,540 metric tons of sugar by crushing 90,000 metric tons of sugarcane. RSM were to stop crushing only after 58 days of production for lack of supply of sugarcane, incurring a loss of

about Taka 14 crore.

BSS from Thakurgaon says: Sugarcane plantation in Thakurgaon Sugar Mills Zone this season started recently at village Khanbari under Sadar upazila.

The programme was jointly inaugurated by Ramesh Chandra Sen, MP and M Emdadul Hoque, MP.

On the occasion, M Baharul Islam, MD, M Nurul Islam, GM, M Abdul Wahab, DGM, M Abdul Qudus Hawladar, GM (Finance), other officials and field workers of the Mills and some farmers were present.

The target of sugarcane cultivation on 13,000 acres was fixed for 2000-2001 sugarcane growing season. For the purpose the mill has taken up a programme to disburse loans of Taka 6.52 crore among the sugarcane growers of the mill zone.

Meanwhile, training programme for the sugarcane growers has started. Under the programme, 300 sugarcane growers will be imparted training in 9 batches.

Last season, sugarcane was cultivated on 9,582 acres in the mill zone. It is expected that one lakh metric tons of sugarcane will be available for crushing in the mills in the next sugarcane crushing season.

National PM likely to open work on Ruppur plant in Nov

PABNA, Sept 2: The unusual delay in implementing the 'Ruppur Nuclear Power Plant' once had raised doubt about its future. Now construction work on the project appears to begin soon, returning smile on the faces of local people, reports UNB.

Work on the project undertaken 38 years ago and then got entangled in red tape, is expected to be opened by Prime Minister Sheikh Hasina in November next.

The then government had taken up the ambitious project at Ruppur in Iswardi upazila with a view to bringing the vast population of the northern region under power supply network.

To implement the project, the government had acquired 259.90 acres of land and purchased some 22 lakh of bricks.

Later, 72 houses and guest houses were constructed on 88 acres of land at Shahpur village for its officials and employees. But all the houses have gradually been abandoned, making those unsuitable for habitation.

Official sources said the project authorities on various occasions had discussed with different donor countries for funds to implement the country's lone nuclear power plant project. But all their efforts went in vain.

Apart from Sweden and Norway, the government had talks with Canada in 1964 to set up a nuclear reactor capable to generate 70mw power. But later the decision was reversed and the government proposed to set up a 140 mw power plant.

However, in 1966, the donor countries Sweden,

Canada and Norway had refused to provide financial assistance for the project.

In 1973, a fresh decision was taken to set up a 200-mw nuclear reactor. And this decision too saw a revision as Bangladesh Atomic Energy Commission came up with a proposal to set up a 300-mw plant.

During 1980-88 period, France, Britain and Germany had showed interest to establish a nuclear power plant here. But there was also lack of initiatives in this regard from our side, the officials said.

When the present government came to power, it decided to revive the project in order to resolve the country's persisting power crisis attributed to short supply.

At last the Cabinet at a meeting on July 23 gave a nod of approval to the proposal for implementing the 'Ruppur Nuclear Power Plant'. It also endorsed in principle another proposal to constitute a Nuclear Power Committee, headed by the Prime Minister.

Meanwhile, a foreign expert team has conducted a feasibility study and agreed to extend their assistance to implement the project.

The Council of Ministers also approved an action plan to raise the capacity of the proposed project to 600mw. Thus a 10-week pre-implementation training programme was held in Dhaka in 1998.

Official sources said works to recover the acquired lands, which have been leased out to farmers, are going on.

Experts hope that industrialisation in the northern region will be accelerated if the project could be implemented as per the plan.

Smugglers active along borders in northern dists

SIRAJGANJ, Sept 2: Many Indian goods like sugar, salt, cosmetics goods, saree, steel pots, phensidyl, heroin are being smuggled into Bangladesh illegally through the border along the northern districts every day.

All the goods come from border areas by the smugglers by trucks, buses, trains and minibuses and stocked at Ullapara bazaar. Ullapara Bazar is now a safe area for the smugglers. A section of unscrupulous traders purchase and carry these goods to the other parts of the country. Many goods enter through the northern and southern parts of the country from the border of Hilli, Mogholhat, and Burimari every day by roads. These are stocked at Ullapara through riverway via Sirajganj-Bhuapur and Bangabandhu Jamuna Bridge. A good number of smuggled goods are sent to Dhaka through Ullapara.

It is learnt that paying bribes 'selami' to the members of the law enforcing agencies the smugglers pass the goods everyday through Ullapara via Bangabandhu Jamuna Bridge. Besides, a large number of Indian goods rush Bangladesh through Hilli of Dinajpur, Mogholhat and Burimari of Lalmonirhat, Bhurungamari, Sonarhat, Roumari,

Chilmari of Kurigram, Sona Masjid of Chapainawabganj and the border areas of Thakerganj. Money collected as bribe is distributed among police, BDR personnel and other members of law enforcing agencies. The government is losing a huge amount of money as revenue and many industries of the country may shut down as these smuggled goods are coming through illegal way. On the other hand one section of influential persons and unscrupulous people are becoming rich by doing such mal-practices.

When contacted officer-in-Charge of Ullapara Police Station Abdus Sukur told this correspondent, everyday the ruling party leaders and workers enter the police station and they take breakfast everyday and take money from them and every month he has to send handsome money as 'selami' to the higher authority and has to donate to the higher authority's wives costly sarees, to please the authorities. He said it is an open secret that, he had to be engaged through dishonest ways to make up those expenditure spent for them. Asked about the youths of the society who are going astray by taking phensidyl, heroin and doing unsocial work, the Officer-in-Charge replied that it was not his headache.

Erosion intensifies

KUSHTIA, Sept 2: Flood situation here has improved with the fall of water level in the rivers Padma and Goral, reports UNB.

With the recession of water level erosion of the rivers intensified and devoured about 1,000 dwelling houses rendering about 8,000 people homeless during a span of 15 days in Daulatpur upazila.

Meanwhile, a vast tract arable land, many dwelling houses,

offices, educational institutions, business establishment, roads, bridges and culverts went into river in many other parts of the district.

Continuous erosion has created panic among the people living near the banks of the rivers. Fresh areas are being engulfed every day rendering a large number of people homeless.

The affected people have been suffering for want of pure water,

sufficient food, fodder for their cattle, adequate medicine for combating water borne diseases and scarcity of house building materials for reconstruction of their houses which was damaged by the flood.

Flood-hit people have been passing their days in distress in absence of relief operations by the government or any non-government organisations. Most of the people have become jobless and they are now dependent on relief materials.

Hundreds of cattle have died due to serious fodder crisis in the affected areas. Cholera, diarrhoea and dysentery have broken out in many flood-hit areas.

Meanwhile, prices of rice and other essentials have gone high beyond the purchasing capacity of the common people. If adequate measures are not taken by the government immediately the situation may go beyond control, local leaders feared.

The badly affected villages under Chilmari union are: Chakrapur, Purbazumara, Pashchim Udaynagar, Uttar Udaynagar, Charvabandari, Sarkapura, Pashchim Amdani Ghat, Purbazumara Ghat, Purbazumara Ramkrishnapur, Pashchim Char Ramkrishnapur, Dakkhin Kharizathal, Uttar Kharizathal, Dakkhin Sarkapura, Uttar Sarkapura and Temadia.

The affected villages under Ramkrishnapur Union are Sonatala, Sarkapura, Charbhadrar, Charukuri, Bagmari, Madhuguri, Islampur, Kharibona, Dhakipara, Bhaglo, Kharizathal, Loknathpur and Charpura.

Under Philipnagar Union, villages of Jotashi, Natunchar, Alinagar and Abedergat and under Maricha Union Laxminagar, Purardiar, Chilmari Bhurkapara, Hatholpara, Koldiar and Machdair were also affected.

The local leaders urged the government and other voluntary agencies to come to the assistance of the flood and erosion affected people for the sake of humanity.

News snaps

Electioneering starts

GAZIPUR, Sept 2: Some 80,000 new voters seem to be deprived of exercising their franchise in the coming Tongi Municipality election, as the new voter list is unlikely to be finalised before the election, reports UNB.

Official sources said the election would be held on the basis of the 1995 voter list. Meanwhile, some opposition leaders, who are interested to contest for the posts of ward commissioner in the election, have started electioneering. However, there is no probable candidate for municipality chairman from opposition parties as they are boycotting the election.

Diarrhoea claims 5 lives

JESSORE, Sept 2: An outbreak of diarrhoea claimed five lives and affected some 8,000 people here in last eight months, reports UNB.

According to hospital records, some 1,690 people were affected by the waterborne disease in Abhoynagar, 1,282 in Keshabpur, 1,137 in Monirampur, 982 in Chowgacha, 361 in Sarsha, 711 in Bagharpara, 263 in Jhikargacha and 212 in Sadar upazilas during the period. Most of the patients were treated in thana health complexes. Five people admitted to General Hospital died of the disease. However, unofficial sources put the number of affected people at 10,000.

Four youths arrested

KISHOREGANJ, Sept 2: Police in their separate drives in the town arrested four youths along with 252 bottles of liquor and Indian phensidyl, reports UNB.

Police said they raided a house at Baobor Dakkhin Para on Wednesday and arrested Towkir Mondal, 25, and Kamal, 24, along with 212 bottles of beer and whisky. In another drive in Amlapara area on Aug 24, they recovered 40 bottles of phensidyl and arrested Shahjahan, 25, of village Magura in Muradnagar upazila and Rubel, 16, of Amlapara in this connection. They arrested were sent to jail after being produced before the court.

Headmaster suspended

JAMALPUR, Sept 2: Headmaster of Nandina Model Academy in Sadar upazila has been suspended for his alleged involvement in misappropriating Tk 1.29 lakh of the school, reports UNB.

The school managing committee took action against its headmaster Mohammad Abdul Kader following an audit report.

Surveillance team formed

BENAPOLE, Sept 2: The trend of illegal power use is rising here depriving the government of huge revenue, reports UNB.

Officials said the system loss in Navaran Palli Biddyt Samity (NPBS) has multiplied in recent months due to illegal power connections and meter tampering. To check its system loss, NPBS has constituted a surveillance team. The team, meanwhile, has detected illegal power connections in 19 households in Benapole and Baghabra areas. The Samity has filed cases against four people with Sharsha police and collected fines from 15 illegal power users.

Three unnatural deaths

COMILLA, Sept 2: Three unnatural deaths were reported in Comilla and Cox's Bazar districts in one week till Tuesday, reports UNB.

The victims were identified as housewives Nilufer Begum, 35, and Pervene Akhter, 22, of Daudkandi upazila in Comilla and housemaid Shahela Akhter of Moheshkhali in Cox's Bazar. Police said Nilufer Begum, wife of Abul Kashem of Korikandi and Pervene Akhter, wife of Mizanur Rahman Molla of village Ozarkhola, allegedly committed suicide by taking poison on Aug 29. The body of housemaid Shahela Akhter was recovered from the bay in Moheshkhali upazila on Monday.
