

Woman killed in road accident

A woman was killed in a road accident at Savar on Dhaka-Aracha highway on Friday afternoon.

The victim was identified as Amina Begum, 50, an employee of the dining room of Al Biruni Hall of Jahangirnagar University. Witnesses said she was run over by a taxi cab near Pranti gate of JU while crossing the highway at about 6pm. She was first rushed to the JU medical centre where she had been given first aid. Later, she was referred to the DMCH as her condition deteriorated and she died on way to the hospital.

DU VC panel election: Hectic campaign underway

Hectic campaign is underway among the politically affiliated teachers of the Dhaka University for election to the Vice Chancellor's Panel of the university, scheduled for September 21.

The tenure of the incumbent VC Prof AK Azad Chowdhury expires on September 29.

Campus sources said that the senior teachers, particularly those belonging to the ruling party-backed "Blue Panel", are all vying for nomination for the VC panel election.

The Opposition BNP and Jamaat-backed "White Panel" is yet to decide whether they will contest the election or not.

Sources said they are not interested in the polls since their position in the 84-member Senate body is not so strong.

Sources said the prospective candidates are maintaining regular communication with Senate members who will elect the VC panel. They are also maintaining close contact with the ruling party's policy-makers who play a vital role in various important issues including the VC panel polls.

Meanwhile, discontent is growing among teachers belonging to the Blue panel. On Tuesday, the pro-government teachers held a meeting to

nominate three teachers for the VC panel, but they failed to reach a consensus as a good number of senior teachers desired their inclusion in the panel. Names of 24 teachers were proposed.

Members of the Senate, the highest policy making body of the university, will elect a three-member VC panel from which university Chancellor and President Justice Shahabuddin Ahmed will nominate one as new VC.

Those who are expecting to get nomination from the Blue panel include incumbent VC Prof Azad Chowdhury. Pro-VC

Prof Shahadat Ali, Prof Sultana Shaif, Treasurer Prof Abul Hashem, Prof Aminur Rashid, Prof Gias Uddin Ahmed, Dean of the Arts Faculty Prof Kazi Shahidullah and Prof Nowsheer Ali Khan.

Prospective candidates of the White panel are Prof Momin Chowdhury, former pro-VC Dr Wakil Ahmed, Prof MA Favez, Prof AFM Yusuf Haider and Prof Mahmud-ul Amin.

Sources said that the prospects of the incumbent VC Azad Chowdhury is bright as he is popular among his colleagues for the various development activities he carried out during his tenure.

Dhaka City Mayor Mohammad Hanif has said that illegal rickshaws plying on roads will be removed in phases to free the city of traffic congestion.

He said that it would be an inhuman step if all illegal rickshaws are removed at a time because 24 to 30 lakh people are directly or indirectly dependent on rickshaw plying for their livelihood.

Hanif said this while addressing the biannual conference of Dhaka City Rickshaw Samikha League at WAPDA auditorium in the city yesterday. State Minister for Shipping Mofazzal Hossain Chowdhury Maya, Abdul Haque Sabui, Habibur Rahman Akland and Yusuf Ali also

spoke on the occasion, says a press release by the DCC. The mayor alleged that although the Dhaka City Corporation is the sole authority for issuance of licence for rickshaws, there are many rickshaws in the city plying with so-called licences from other organisations. He sought cooperation from Rickshaw Samikha leaders to stop plying of illegal rickshaws on the roads.

When asked if she suspected any particular person or group behind the attacks she said, "It is the Taliban and the religious extremists". She also threatened them in 1975, she said.
