

# Ivy has been rescued, but what about others?

BNWLA saves one woman from an Indian brothel, but many others remain untraced

One dark night two years ago, four girls with two children accompanied by two men crossed the border into India with high hopes for prosperous jobs. Little did they know that the night would never end for them.

The girls and the children were sold to brothels in India by the men who had promised them jobs. They never thought that they would be able to escape from the nightmare that became life for them. Only one among them was luckier than the rest.

Ivy (not her real name), only eighteen years old now, was repatriated from a Delhi brothel where her husband sold her, and returned home on September 28 with the help of Bangladesh Women Lawyers Association (BNWLA).

"I was married to Khokan about five years ago. I had two children by him, a daughter and a son. One day, Khokan

proposed that we both go to India for better jobs. He said that I could also work there and be paid," Ivy said.

I happily agreed, hoping of a better life and also that I would be able to send money to my poor parents," Ivy, from Bilpara village in bordering Goga union in Jessore, said.

She was smuggled along with the others through the Sarsha thana in Jessore border. They bribed the border guards from both sides to pass through. The journey on foot was difficult. After a while Ivy wanted to return with the children but the men threatened to hand them over to police.

The group travelled through Calcutta headed for New Delhi on train. Here Khokan and the unidentified man who travelled with them, abandoned Ivy with her children at a slum in Gandhi Nagar next to Jamuna.

After being kept under lock and key for two months Ivy was

separated from her children and taken sold for 40,000 rupees to a woman called Madhu, also known as Rani, at a brothel at Azimri Gate in Old Delhi. She never saw her children again.

"I was raped and beaten up on the first night by a number of men and threatened with torture and told to cooperate or face grave consequences.

It was after 2 years of this heinous life as a sex worker that she was forced to become, that a Bengali speaking client took pity on her and informed the police.

She was taken to jail from where she was transferred to Nari Nirjatan Home in Delhi where she received treatment for trauma and psychiatric therapy.

Bangladesh BNWLA came to know about Ivy through a network known as 'STOP' which has watchdog in jails and courts. After the usual formalities between two countries was brought back home on September 28, Mominul Islam Shuroj, investigation officer of the organisation said.

"The biggest problem is helping these type of victims is that there is no bilateral agreement between the two countries. The process for their repatriation, as a result, become difficult," Advocate Salma Ali, Executive Director BNWLA said.

Ivy will be reunited with her parents as soon as the flood waters in Jessore, where her parents live, recede. In the meantime, she is being given vocational training to be able to earn a livelihood.

The whereabouts of the other women who were with Ivy is not yet known. The late of her children is also not clear yet.

Khokan and the man who was the mastermind behind Ivy's fate continue their trade of women across the border. Khokan is believed to be living in Malapota in Khulna City. A case will soon be filed against him.

Ivy was very lucky, but many more women from our country are perishing in brothels in the neighbouring countries. Can they all be rescued and brought back?

The handy medical book emphasizes general observational skills which help a person suspect a deviation from normal health conditions, describes nearly a hundred health problems or illnesses and provides information on some health-related topics.

## Threat to newsmen

### DRU demands immediate action against Abu Taher

The Dhaka Reporters' Unity has strongly condemned and protested the remarks made by Laxmipur Municipality chairman and district Awami League general secretary Abu Taher against the journalists.

In a statement, DRU president M Anwarul Haq and general secretary Monowarul Islam said the Laxmipur district AL leader has publicly threatened to kill and amputate hands and legs of journalists and subsequently set on fire copies of the Daily Jangar, Manabzamin and Prothom Alo.

Abu Taher's public utterance in presence of a government minister has made the journalists scared and panicked, they added.

## BDRCS takes up Tk 12 cr flood relief programme

Armed forces working in flood-hit areas

Bangladesh Red Crescent Society has been working to help about a million flood affected people with general and medical relief, a meeting of the organisation was told yesterday, reports BSS.

BDRCS secretary general Ali Hassan Quorshi informed the meeting that it has plans to assist 775,000 people with general relief and about 100,000 people with medical relief for a period varying from one week to three months.

The Taka 12 crore programme includes distribution of 3,360 metric tons of foodstuff, medical operations through 16 medical teams, distribution of two million water purifying tablets, 100,000 doses of oral rehydration salts and 18,200 sarees. The plan also includes providing plastic roofing materials for 18,200 families and 33,600 CI sheets, the secretary general said.

He was speaking at a meeting of senior officials of the BDRCS about the current flood situation and ongoing Red Crescent relief operation, a press release said. Chairman of BDRCS Sheikh Kabir Hossain earlier spoke of the overall response of the organisation in addressing the sudden calamity which has hit the South-Western Bangladesh.

### Bangladesh Armed Forces

Nearly one lakh and fifty thousand flood affected people have been evacuated and treated by members of Bangladesh Armed Forces. It was officially stated yesterday.

The Armed Forces personnel have so far evacuated 1,15,000 marooned people and 20,404 affected people, ISPR release said.

Meanwhile they (Armed Forces) continued their flood relief activities in greater

Rajshahi, Kushtia, Jessore and Khulna districts in close coordination with the local administration and other agencies. Their relief teams continued activities in 92 unions 19 in Meherpur, 20 in Chuadanga, 12 in Jhenidah, 29 in Jessore and 12 in Satkhira districts.

The Army personnel so far distributed 20 thousand 700 packets of dry food and 53 dakhits of cooked food, 14 thousand 576 kg of flattened rice, 25 thousand 700 gallons of pure drinking water, seven thousand 928 packet of oral saline, nine thousand kg of rice, one thousand 960 pieces of clothes and 64 thousand pieces of bread from their own resources.

Army speedboats are being used for distribution of relief materials from government sources, while the members of the Army engineering corps are using pumps for draining out floodwaters at Chuadanga and Jhenidah districts.

BAF helicopters are carrying out five to six sorties a day from Jessore base to Karpashdanga, Jibon Nagar and Moheshpur, Benapole, Kalaroa and Satkhira. Besides carrying out relief materials, the choppers are also being used for air dropping and evacuating marooned people to safe places, the press release added.

### More allocation

Meanwhile, the Relief and Disaster Management Ministry sanctioned another 325 metric tons of rice yesterday for the flood-affected people in different districts of the country.

Of the total, 100 tons have been given to each of Jessore and Satkhira districts, 50 tons to each of Jhenidah and Chuadanga and 25 tons to Meherpur district, an official press release said.
