98 pc of CHT peace accord implemented: Report

BANDARBAN, Nov 4: Ninety-eight per cent clauses of the CHT peace accord between the government and PCJSS have been implemented, a report of the CHT affairs ministry said, reports BSS.

According to the report, a separate ministry for overseeing CHT affairs was created and a tribal MP (from Khagrachari) was appointed the CHT affairs minister in compliance with CHT peace accord.

It said that a committee led by Chief Whip of Jatiya Sangsad Abul Hasnat Abdullah was formed to monitor the implementation process. Other members of the committee are Chairman of the Regional Council Joytirindra Bodhipriya Chakma alias Shantu Larina and Chairman of the task force on internal migration Dipankar Talukder. The committee has convened four meetings so far.

The report also said a 22-member regional council led by Shantu Larina was formed with the approval of Parbatiya Zila Parishad Act that was amended on November 22, 1999. Bir Bahadur MP was appointed chairman of CHT Development Board (CHTDB).

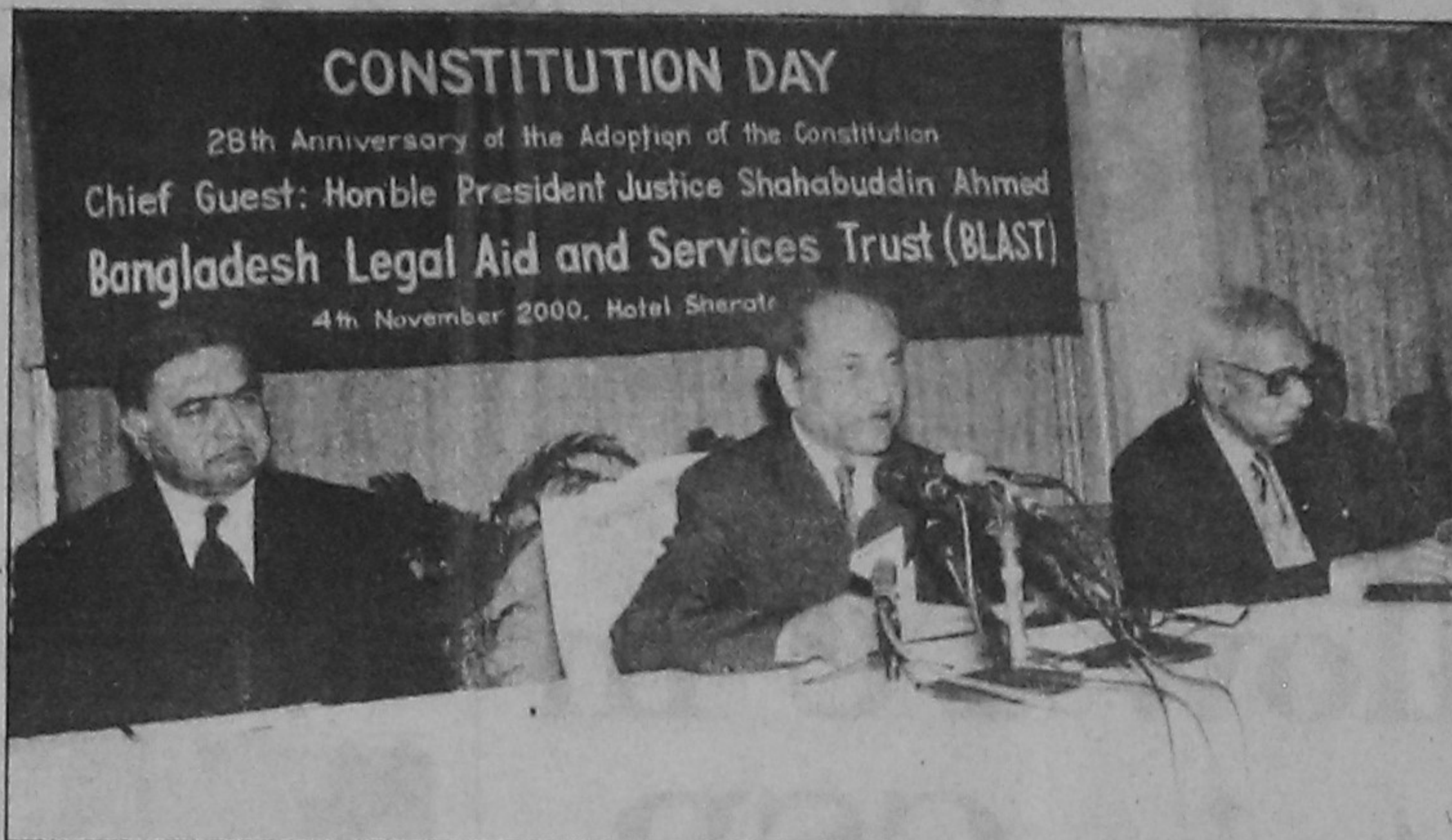
It said that 56,256 tribal people belonged to 10,427 families between March 28, 1997 and February 27, 1998 were provided with different benefits in 20 installments under official package programme. The report said lawmakers from Rangamati Dipankar Talukder was assigned to oversee the matters relating to the internal migrants as chairman of the taskforce.

The ministry said land commission has started working to settle disputes relating to land. A retired judge is supervising activities of the commission, it said.

The report said that Tk 240.40.00.000 was allocated in the last three years for development work in the CHT region. All government offices also maintain tribal quota in jobs, it added.

So far 19 PCJSS activists have been released from jail while 66 cases have been withdrawn and accused in 20 cases were exempted punishment. More than 38 cases are in the process of being withdrawn while name of one person was dropped from a case entirely at Bandarban, it said.

The ministry report said that the 19 PCJSS members, who decided to start a new life were assured that they would get Taka 50,000 as a grant for rehabilitation.
