Eight hundred forty eight renowned lawyers of the country in a joint statement yesterday demanded legal action against Inquilab for publishing a parody of National Anthem on October 20, reports BSS.

In the statement the lawyers said they were surprised to see that the paper did not apologise although different quarters raised protest against it.

The lawyers said "We have achieved our independence through supreme sacrifice of many martyrs.

They said, "We have observed that those who wanted to destroy the continuity of constitution and independence the same group with the help of their foreign masters, was trying to destroy the stability of pro-liberation and democratic government.

The lawyers said that the act of Inquilab was a threat to independence and sovereignty.

# Justice Ruhul Islam dead

Justice Ruhul Islam, a retired judge of the Appellate Division of the Supreme Court and a former Chairman of Bangladesh Press Council died of cardiac arrest on Saturday night at Bangladesh Medical College Hospital, family sources said yesterday. He was 80. reports BSS.

Justice Islam who joined High Court Division of Bangladesh Supreme Court in 1972 and retired from Appellate Division in 1983 was buried yesterday afternoon at the Azimpur Gravevard.

A native of Kushtia, Justice Islam had his Master's and LLB from Aligarh University. He served as Advocate General of erstwhile East Pakistan in 1970. He joined legal profession in 1951. He served as Chairman of Press Council for six vears (1986-92).

He left behind his wife, four sons a large number of admirers to mourn his death.

The qulkhwani of the deceased will be held in the city on Tuesday after Asr prayers at his 9/19 Iqbal Road residence in the city.






