### British ship that sank 57yrs ago being salvaged

BARISAL, Dec 2: The British passenger ship 'Rudra' which sank about 57 years ago, is being salvaged from the river Kancha near Bhandaria upazila under Pirojpur district by a private team led by one Abdul Hye Talukder, reports BSS.

According to an official source, the Bagerhat-bound passenger ship 'Rudra' from Pirojpur sank at Jholagathi in the river Kancha about three kilometres off Bhandaria Steamerghat with over 200 passengers on board on Bangla month Magh 13, 1350 (1947) due to severe cyclone.

The rescue operation of the ship has been done many times at the government and non-government levels earlier, but with no success. All the passengers including children and women died as the ship capsized.

## Crisis deepens in BNP

Crisis in BNP has further deepened as the party leaders and activists at all levels are divided into two camps over policy decision on vital issues.

The decade old conflict between the hardliners and moderates intensified in recent days as the hardliners comprising 'anti-liberation and undemocratic' elements are desperately trying to establish their supremacy in the party by influencing the party chief.

Party sources said the hardliners have long been misguiding BNP Chairperson Khaleda Zia and trying to align the party with rightwing fundamentalist parties.

They said a dozen BNP leaders, who made huge assets through corruption when the party was in power, are trying to place their chosen hardliners in key positions in the party and its front organisations.

They said these leaders hold secret meetings at the business offices of two leaders at Sharif Mansion at Motijheel in the city. One of the leaders is from Chittagong and another from Bhola.

The hardliners are backed by some rich but non-political elements who promised huge subscriptions to the party if their men are placed in key positions.

Their main target now is to make Standing Com-

mittee member Dr Khandaker Mosharraf Hossain secretary general of the party and Nasiruddin Ahmed Pintu president of Jatiyatabadi Chhatra Dal (JCD), BNP's student front.

But the move to remove Abdul Mannan Bhuiyan from the post of secretary general was strongly opposed by the moderates who enjoy support of the rank and file in BNP and JCD.

A joint move by the hardliners and two aides of the BNP Chairperson to make Pintu president of JCD was opposed by majority of the leaders and activists of BNP, JCD and other front organisations.

Pintu, a non-student, was made general secretary of JCD in December 1998 at the influence of Khaleda Zia's aide Mosaddek Ali Falu amid strong resentment in the rank and file of BNP and JCD, the sources said.

With a very poor academic background, Pintu was never a student leader in any educational institution, they claimed.

Pintu, who was known as the right hand of Falu, became very powerful in BNP when the party came to power in 1991. He then devoted himself to making his personal fortune.

Diouf also lauded the political will of Prime Minister Sheikh Hasina in undertaking a large number of programmes aimed at alleviating poverty.

### Indian garments worth Tk 6 lakh seized in Ctg: 5 arrested

CHITTAGONG, Dec 2: Smuggled Indian garments worth about Tk 6 lakh were recovered in the city yesterday.

Six people including an Indian citizen were arrested for their alleged involvement in the smuggling.

A police team led by the Officer-in-Charge (OC) of Potenga police station recovered the goods from a private car at Cement Crossing in Airport area at around 5.30 pm.

The arrested were identified as Kazi Nazmul Hasan of Howrah, West Bengal, Masud, 28, Shahed Ali, 30, Ashraf Ali, 26, Masud Tareq, 38, and Saiful Islam, 32.

### SKOP calls hartal in Narsingdi town Dec 11

NARSINGDI, Dec 2: Sramik Karmachari Oikya Parisad (SKOP) has called for a dawn-to-dusk hartal in the district town on December 11 to press home their demands, reports UNB.

The programme was announced today at a protest rally in the BSCIC industrial area following the tragic fire incident at Choudhury Knitwear factory that killed about 50 workers.

The demands of the workers include Tk two lakh compensation for each worker died and treatment and compensation for all injured in the fire incident on November 25.

### 2 Indians held with arms in Satkhira

SATKHIRA, Dec 2: Police arrested two Indian citizens along with a pistol and seven bullets from village Shearpara in Kaliganj upazila on Friday, reports UNB.

The arrested were identified as Ansar Gazi, 30, son of late Bachtulla of Barunhat village in Hasnabad thana and Abdus Salam, son of Nur Ali of village Katakhal in same thana of Uttar Chabbish Pargana.

Kaliganj thana OC Abdur Rashid said patrolling team of police challenged the two men while they were moving at village Shearpara in the evening.

Later, police recovered a German made pistol and bullets from them. A case was filed with Kaliganj thana.

### Rival faction rejects Razzak-Tayeb backed faction forms BNP Khulna dist unit

KHULNA, Dec 2: Activists of rival groups of both city and district BNP were seen flexing their muscles in front of two separate offices of the party today. The showdown is the result of the formation of 101-member new district committee on Friday evening with Gazi Abdul Parias president and Shaharuzzaman Mortuza as General Secretary. This committee is strongly being backed by former speaker Shaikh Razzak Ali MP and city Mayor Shaikh Tayeb Rahman.

The Joint Secretary General of BNP's central committee and former whip Ashraf Hossain termed the newly announced district committee as most unacceptable and ultra vires of the party constitution. I was not informed of the convening of the district council on Friday in the party's city office despite the fact of my being the convenor of the district committee earlier approved by the chairperson Begum Khaleda Zia last year, said the former whip.

Friday evening's meeting of the Razzak Tayeb group ran into trouble as activists of Ashraf-Manju group stormed into the city office of the party. The meeting ended in fiasco. But they again sat in the parlour of City Mayor's Private residence where 101-member district committee was announced.

Khulna City BNP president M Nurul Islam Dadu expressed his sharp rejection against formation of the new district committee and sought intervention of party chairperson Begum Zia to resolve the crisis immediately to avert a clear split. See page 11 col 1

### Police, Degree examinees clash in Sirajganj: 100 injured

SIRAJGANJ, Dec 2: At least 100 people were injured in a clash between Degree examinees and police and BDR personnel at Jamtali Haji Korop Ali Memorial College centre under Kamarkhanda Upazila of the district today.

Police and witnesses said the trouble began at noon following expulsion of 83 examinees for cheating in the examination.

The examinees started hurling stones at on-duty policemen, damaged a police pick up and ransacked the office and residence of college's principal.

Police and BDR personnel fired tear gas shells and 25 shots to disperse the agitating examinees.

When contacted, ADC, Revenue, admitted the incident. A case was lodged with Kamarkhanda thana. None was arrested in this connection till filing of this report at 6 pm today.

### Shrimps worth Tk 100cr lying at Mongla for want of vessels

KHULNA, Dec 2: Eighty containers of frozen shrimps worth over Taka 100 crore have been lying in the container yard at Mongla port since last fortnight due to crisis of sea-going vessels. As a result, exporters are being subjected to extra financial involvement for transporting the cargo from Khulna to Chittagong for shipment for maintaining time schedule. If ships are not paled at Mongla Port immediately, then LCs of frozen shrimps worth several crores of tk will stand cancelled for violating terms and conditions, said some exporters of Frozen Foods.

According to a reliable source of Khulna office of BFFEA, there is no possibility of placing the feeder vessels at Mongla Port before middle of the current month for loading the containers of frozen shrimps.

BSC ship 'Banglar Moni' scheduled to arrive at the port by December 12 is not capable to load more than 50 containers, said the source. Buyers will refuse to accept the frozen shrimps if they do not get it well ahead of the Christmas day, the source further said.

Our frequent reminders to authorities concerned for solving the crisis of feeder vessels have so far gone unheeded throwing shrimp export trade through Mongla Port into uncertainty, said Malek Sarker, Convenor of Khulna unit of Bangladesh Frozen Food Exporters' Association.

This indifferent attitude of authorities concerned is causing colossal loss in foreign exchange earning, he said.

### AL activist chopped to death in Khulna

KHULNA, Dec 3: Awami League activist Abdus Salam, 26, was murdered at Charehat under Khalishpur thana at noon yesterday.

Police said Salam was one of the prosecution witnesses in Jubo League activist Lenin murder case filed with Digholla thana on July 6 this year.

According to witnesses, a group of eight unidentified miscreants chopped him to death in front of Charehat mosque.

He was rushed to Khulna Medical College Hospital where the attending doctor declared him dead.

Salam was a casual worker of Platinum Jubilee Jute Mills.

A case was recorded with Khalishpur thana this evening.

## Court hears arguments in Gore's election challenge

TALLAHASSEE, Florida, Dec 2: A landmark trial that could determine the US presidency was underway today with a judge hearing Al Gore's contest of George W Bush's victory in Florida, reports AFP.

The hearing focused on Gore's request for the manual recount of thousands of disputed Florida ballots, which Bush opposes.

The proceedings at the Leon County Circuit Court, in the Florida capital Tallahassee, started at 9.20 am (1420 GMT) with Gore's top lawyer David Boies outlining his arguments.

"We have alleged that the certified results reject a number of legal votes and include a number of illegal vote," he said.

But Bush's lawyer Barry Richard claimed a recount would be "unreasonable and contrary to Florida law."

Judge Sanders Sauls said he expected the session to last about 12 hours, but it was not immediately clear when he would rule on the recount request.

Bush holds a razor-thin 537-vote lead in the Florida results certified by state officials, but Gore contends that if the contested ballots are manually recounted, the final tally will show him the winner. Over a million ballots from Palm Beach and Miami-Dade counties, including 13,300 disputed by the Gore camp, were earlier delivered to the Tallahassee court on orders from Sauls.

The vice president suffered a setback on Friday when Florida's Supreme Court rejected his appeal to have the disputed ballots recounted immediately.

Also on Friday, Sauls told Gore lawyers for the

third time that he would not order a recount until he hears the arguments on both sides.

The Bush camp vehemently opposes any recount, maintaining that the ballots have already been tallied and rejected twice as non-votes by machines.

But, at the same time, they have asked for and received from the judge an order that some 1.2 million ballots from three other counties be kept locked up and prepared for delivery to Tallahassee.

The Democrats accuse the Bush camp of using delaying tactics that could prevent a possible recount from being completed before a December 12 deadline for Florida's Electoral College slate to be named.

This could play into the hands of the Bush campaign, as Republican legislators have said they could take the unprecedented step of naming the electors if the deadline is not met.

But the Gore camp is quietly pinning its hopes on another two lawsuits in which Democratic activists have asked that 25,000 ballots be thrown out because Republicans allegedly tampered with absentee ballot applications in Seminole and Martin counties.

In both cases, the plaintiffs want all the absentee votes cast out, as it is impossible to link the contested forms with specific ballots.

Both trials, which do not involve Gore lawyers, are to be held in the Florida capital on Wednesday, almost a month after the November 7 presidential election. See page 11 col 8

## 200 buried alive as shopping centre collapses in China

BEIJING, Dec 2: Some 200 people were buried alive when a shopping centre in southern China's Guangdong province collapsed, officials from Dongguan city said today, reports AFP.

"Some 40 people have been pulled out of the building" an official at the Houjie township government in Dongguan told the agency by phone.

"We don't know how many are dead, but we estimate that about 200 people were buried when the building collapsed," he said.

Hong Kong press reports however said at least 10 people were killed and 40 injured in the tragedy.

An official at the Houjie Township fire station said the building collapsed in the afternoon, with rescue operations beginning immediately and going into the night.

Firemen and police descended on the scene from neighboring Dongguan, sending injured victims to four nearby hospitals, he said.

The popular one-storey shopping centre was undergoing renovation, with two upper floors nearing completion, he said.

Hong Kong press reports said the building collapse shook the entire commercial area of Houjie.

Reuters quoting Hong Kong media said, about 100 people were buried when a two-storey shopping mall collapsed in China's southern Guangdong province.

Television footage shown in Hong Kong today showed rescuers removing bodies from the disaster site as other workers clambered over mounds of fallen wooden scaffolding and debris to search for signs of life underneath.

There were no indications, nor confirmation, of the death toll.

### Two groups of terrorists clash at N'ganj: 20 hurt

NARAYANGANJ, Dec 2: At least 20 people were injured, eight of them by bullets in a gunfight between two groups of terrorists in Fatullah rail station area in early hours today.

Police and local people said two groups of terrorists clashed over control of a fisheries farm at 2 am.

Both the groups exchanged several rounds of shots during the clash that continued for an hour.

## Order to seize property of Asadul's son

KHULNA, Dec 2: Court has ordered attachment of all moveable property of the eldest son of Kulia UP Chairman Asadul Huq and one of his armed cadres Sajjad Munshi to the state.

Accordingly, police attached all moveable property of Sajjad Munshi at 4 pm on Thursday from his house at Elarcher village under Satkhira sadar thana.

Munshi is one of the accused in a case recorded under Articles 4, 7 and 10 of the PSA for launching an armed attack on the office of Dainik Satkhira Chitra last month.

Asadul and his eldest son known as Babu are also accused in the case.

OC of Satkhira sadar thana said that property of Babu would be attached today. But it did not take place till filing of this report this afternoon.

Police quoting previous records said Asadul Huq was arrested first in 1983 in Abdul murder case and also in Taskin murder case in 1998. He was acquitted in Abdul murder case, but chargesheeted in Taskin murder case.

Police further said Asadul masterminded an armed attack on The Daily Star's Satkhira correspondent Prof Abu Ahmed early this year. See page 11 col 1
