More assistance from WB to fight polio, TB, leprosy

World Bank will provide all sorts of cooperation to Bangladesh in eradicating polio, tuberculosis and leprosy, combating arsenic problem and AIDS prevention, reports UNB.

The assurance came from World Bank South-Asia Regional Director Richard Skolnik while talking to Health and Family Welfare Minister Sheikh Fazlul Karim Selim at his office yesterday.

The Health Minister apprised that the National Health Policy, announced earlier, will help ensure the health services to the poor and improve the nutrition situation of the country.

He further apprised the WB official that the health policy will also help develop rural health infrastructure and modernise hospitals and ensure quality health services to the people.

The WB Regional Director emphasised the need for ensuring healthcare services for the mother and child, including removing their nutrition deficiency.

Sheikh Selim also apprised him that the health policy, which was announced recently, envisaged all these aspects.

Pakistani daily slams faux pas by Pak diplomat

A leading Pakistani daily 'The Frontier Post' has deplored 'the latest faux pas committed by a senior Pakistani diplomat in Dhaka' that created an 'unhappy situation' between Bangladesh and Pakistan, reports BSS.

The newspaper in an editorial on Saturday said that regardless of everything a diplomat is not supposed to make political statements, unless expressly authorised by the home government.

Referring to the widespread protests from all levels for the disgraceful remark of the Pakistani diplomat on the Liberation War and Awami League, the newspaper said, 'Bangladesh has been quite correct in its attitude towards Pakistan.'

'Our Deputy High Commissioner has committed what is inexcusable indiscretion,' the editorial said and criticised the Pakistani Foreign Office for delaying in taking action against the diplomat.

The newspaper underlined the need for maintaining best possible relations with all countries in the world especially Bangladesh. 'With Bangladesh our equation ought to be very, very special,' the Frontier Post added.

'The failures of our foreign policy management are now so egregious that it will not be an exaggerated demand to call for a major changes at the head of the Ministry of Foreign Affairs,' the newspaper said.

'IT can help generate job for youths'

Speakers at a seminar yesterday stressed on the development of country's telecommunication infrastructure immediately to give an impetus to the Information Technology (IT) in generating employment opportunities and called upon the government and non-government agencies to help spread the IT revolution in the country.

Addressing the seminar on 'Role of Information Technology in Self-employment', they also said that there is no alternative to equip our youths with the IT knowledge to meet the growing demand in IT sector throughout the world and thus help solve the unemployment problem of the country.

The seminar, held at the National Sports Council auditorium, was jointly organised by Department of Youth Development (DYD) and Ministry of Youth and Sports to mark the 'National Youth Festival-2000'.

State Minister for Information Prof Abu Sayeed inaugurated the programme in the morning while Deputy Minister for Local Government, Rural Development (LGRD) and Cooperatives Sabir Hossain Chowdhury addressed the concluding session of the seminar as chief guest.

Saber Hossain said that the essence of IT is inspiration and possibilities adding 'Our challenge should be to keep pace with the changing world of IT and the development of IT section in the country is the only means to face the challenges of globalisation.'

He also pointed out 'We have to adopt the technology in the new millennium for our development and government should take necessary steps in spreading the IT education throughout the country for generating more employment.'

Speakers and participants of the seminar made a set of recommendations which includes introduction of modern education system, more allocation for IT sector in the fiscal budget, infrastructure development, setting up of quality training institutions with modern curriculum, co-ordination among the different government agencies and ministries and more-over formulation of a national policy with foresightedness to exploit the immense opportunities of the sector.

Prof M Abdus Sobhan, Executive Director of Bangladesh Computer Council presented the keynote paper at the seminar.

Among others, Secretary of Youth and Sports Ministry Manik Lal Samadder, Director General of DYD A F M Motiur Rahman, Deputy Director (Planning) of DYD Habibullah Bahar Golondaz and Principal of RUISTEC Miktilul Islam addressed the programme.

Saber Hossain also distributed the awards among the winners of Essay Writing Competition, organised on the occasion of the National Youth Festival.
