## BNP slams EC for denying voting right to expatriates

BNP secretary general Abdul Mannan Bhuiyan has expressed dissatisfaction and anger at the Election Commission's denial to enrol the expatriate Bangladeshis as voter.

In a statement yesterday, he said some 30 lakh expatriate Bangladeshis have long been demanding to enrol themselves as voter and thus allow them to cast votes in elections.

But he said the EC had rejected the long cherished demand of expatriates to attain the right to franchise without explaining any reason. He said BNP had expressed solidarity with the demand of the Bangladeshis citizens staying abroad.

Bhuiyan said the expatriates have been contributing to our economy by sending their hard earned money from different countries. The 30 lakh Bangladeshis expatriates, who regularly send money to their homes, are the key source of our foreign exchange earning.

The BNP secretary general said the expatriates are not only staying abroad to meet their own needs, but also contributing to the development of the country. And thus depriving the

expatriates of their voting right is apparently denial to their contribution for the country, he added.

Besides, he said the Constitution of Bangladesh permits voting right to each and every eligible citizen of the country. "Denial of voting right to the expatriates is a violation of their Constitutional right," Bhuiyan observed.

In this context, Mannan Bhuiyan cited that the Bangladeshis citizens, who are serving government job abroad have been enrolled as voters and they are entitled to cast their votes by post. "If the government service-holders can be voters than the authority has no right to deprive the expatriates of their voting right," he added.

He said the government and the EC announced that it would not be possible to enrol the expatriates as voters, citing various lame excuses. But it is the responsibility of both the government and the EC to remove these obstacles and barriers for ensuring the right to expatriates.

Bhuiyan said a BNP delega-

tion recently met with the EC officials and reiterated the demand for enrolling the expatriates' name in the voters list, but neither the government nor the EC has taken any move to consider the demand.

He demanded of the EC to take steps to enrol the expatriates as voters by reviewing its earlier decision. He also asked all concerned to refrain from activities that are designed to curb the rights of expatriate Bangladeshis.

### Democracy Day tomorrow

Democracy Day will be observed across the country tomorrow marking the 10<sup>th</sup> anniversary of the fall of autocracy in the face of people's movement spearheaded by the then main opposition political parties, reports BSS.

Bangladesh Awami League and its front organisations will hold a discussion in Dhaka and other places of the country on the occasion.

Scores of other socio-political-cultural organisations have chalked out similar programmes to observe the day in a befitting manner.

### Tk 1.65cr Swedish aid for BNWLA project

Sweden will provide Tk 1.65 crore to Bangladesh National Women Lawyers' Association (BNWLA) to implement one of its projects, reports UNB.

The Swedish Embassy and BNWLA signed an agreement to this effect in the city on Monday.

Councillor of the Embassy Anders Granlund and BNWLA President Farzana Karim Firoz signed the deal on behalf of their respective sides.

The main objective of the three-year project is to ensure justice to distressed women, said a press release.
