# BMDA takes up mini-ditch digging programme

RAJSHAHI, Dec 13: Barendra Multipurpose Development Authority (BMDA) has undertaken a massive programme of digging mini-ditches in its area for irrigation in the dry season and pisciculture.

United Nations Development Programme (UNDP) is giving financial assistance for the programme.

BMDA sources said, the project began in 1999 and a total of 150 mini-ditches had already been dug under the first phase of the project. One hundred fifty more mini-ditches will be dug during the ongoing

Measurement of each mini-ditch is 16 feet by 16 feet in length and breadth and six feet in depth. Saplings of different varieties of fruit and wood trees are also being planted along the mini-ditches.

Farmers are also cultivating fish in the ditches. BMDA sources said, the mini-ditches are becoming popular among the farmers of the

Aman paddy is the main crop in the Barendra region which is transplanted and reared in the rainy season when normally irrigation is not required. But, most of the years, the sources said, amount of rainfall decreases in the month of September and October. This drought-like situation causes serious decrease in production of paddy. To face this emergency situation, farmers use to irrigate their paddy fields from the near by ditches and ponds.

But the ditches and ponds are neither sufficient in number nor distributed all over the area in a planned manner.

So, most farmers cannot use the traditional method.

BMDA sources said that a drought-affected paddy field of one to two bighas of land could be irrigated from a mini-ditch.

### 29th martyrdom anniversary of Serajuddin Hossain



### Subject: Notice for admission into MBBS course in government medical colleges during 2000-2001 academic session.

Applications are invited in prescribed form under following terms and conditions for admission into 1st year MBBS course in 13 government medical colleges of Bangladesh during 2000-2001 academic session.

Candidates willing to get themselves admitted must have the following eligibility: Should be a permanent citizen of Bangladesh.

Should pass the SSC/Dakhil or equivalent examination from any Secondary and Higher Secondary Board/Madrassah of Bangladesh or from any recognised board or university outside the country and HSC/Alim or equivalent examination without any third division with physics, chemistry and biology. Should obtain at least 1300 marks in both examinations and should have pass marks in biology (theoretical and practical separately) in HSC or its equivalent examination.

The candidates who passed the SSC examination before 1997 and HSC or equivalent examination before 1999, will not be eligible to apply.

1450 male/female students will be admitted into 13 government medical colleges on the basis of merit and district quota. 70% (i.e. 1015 seats) of the 1450 seats stated will be selected on the basis of national merit, rest of the 30% (i.e. 435 seats) on the basis of population of 64 districts on the basis of district merit will be selected.

40 (forty) additional seats will be reserved for the children of freedom fighters. These candidates

should have the same minimum eligibility. Should obtain at least 1300 marks in total in SSC and HSC examinations. They will have to submit certificate in support of participating in great War of Liberation of their father/mother signed by the chairman/convenor of Bangladesh Muktijoddha Central Command Council and countersigned by the Chief Advisor with the application. Chances will be given for admission into these reserved seated in different medical colleges purely on merit A total of 16 additional seats with 12 seats for the candidates of Rangamati, Khagrachhari and

Bandarbans hill districts (3 tribal and 1 non-tribal in each district), 2 for the tribal candidates from greater Sylhet district and 2 seats for tribal candidates for other districts will be reserved. They should have minimum educational qualifications like the other general students, but they can apply if they obtain at least 1200 marks in total in SSC and HSC examinations and will have to appear at the same admission test. They will have to submit applications regarding character, tribe and district from the deputy commissioner of their respective districts and tribe chief (in case of tribal candidates) and incase of non-tribal candidates they will have to give certificate from the deputy commissioner of their respective districts regarding district and character. Chances will be offered for admission into different government medical colleges in these reserved seats totally on the basis of merit.

The final selection for admission will be done on the basis of the results of the following examinations-

The written test on the current syllabus of HSC course will be held on (MCQ) system and physics, chemistry, biology, general knowledge and English will be included:

(Physics-30, Chemistry-30, Biology-30, English and = 100 marks General Knowledge-10)

40% of the total marks detain in SSC or its = equivalent examination

60% the marks obtained in HSC or its equivalent = 100 marks examination 200 marks

No viva-voce test will be taken and time fixed for written test: One hour.

Selection will be made on the basis of the marks obtained in physics, chemistry and biology in HSC examinations if the total marks obtained is equal. If that is also equal, the merit will be selected on the basis of marks obtained in biology.

In case of claiming the district quota, the district as mentioned in the application is the permanent district of the candidate will have to be certified by the mayor of local city corporation/pourasabha chairman or approved official/local thana nirbahi officer/chairman of union parishad/first class magistrate/official.

The decision in which medical college the candidate will get the chance for admission will be fixed on the basis of merit prepared for final result of the admission test and option of college as given by the candidate will be fixed. It will have to be mentioned on the specific column of the application as to in which college the candidate wants to get himself admitted on order option. If the candidate does not want to get himself admitted in any college then (x) will have to be given in the space or keep the

space blank. Processing of admission forms security and finalisation of results will be done by computer. Examining answer-scripts will be done by OMR machine marks tested in (OMR) machine can not be challenged in any court. But if there is any objection regarding the results of the test then application will have to be made within 15 (fifteen) days from the day publishing results to the Director, Medical Education and Health Manpower Development, Health Directorate, Mohakhali, Dhaka by depositing a Bank Draft for Taka = 500/- (five hundred) (non-refundable) in his favour for scrutiny of the respective result. The applicant will be informed about the result after scrutinising the answer script

Candidates passing HSC or its equivalent examination from different boards can deposit application form in the college by procuring the prescribed application from any medical college according to their choice, but in case of Dhaka Medical College, only the student who have passed the examinations from Dhaka Board can procure application form and deposit. Students passing from Dhaka Board may procure application form and deposit application form as per their option apart from Dhaka Medical College.

Application forms can be procured on payment of Taka 20 (twenty) (non-refundable) from the specific medical college. The application form will have to be deposited in the college after filling them up properly with Taka 260/- (two hundred sixty) (non-refundable) as centre fee in the college from which the application form has been procured.

The following documents will have to be enclose with the application form.

Attested photocopies of marksheets of SSC and HSC or equivalent examinations. Attested photocopy of the certificate from official as mentioned in 5(b) section regarding permanent

Three copies of attested recent passport size photograph.

Attested photocopy of the certificate as mentioned in section 2(c) for the seats on the basis of quota for tribal and non-tribal candidates.

Incomplete application and application with wrong information will be cancelled and in case of the candidates appearing at/passed in the admission test, any wrong information is detected later on, then his test/result will be regarded to be cancelled. No applications, under any circumstances will be acceptable after the expiry of the specific date.

Any application regarding the change of name of respective district in the specific column of the application and order of option of colleges for admission, under no circumstances will be acceptable.

The list of total 1490 with 1450 select on national merit and district quota and 40 seats as reserved for the children of freedom fighters will be informed at the time of publishing final result of the 1490 candidates getting the chance. 154 will be admitted on the basis of total merit and option of college in the Dhaka Medical College. 153 each in Sir Salimullah, Chittagong, Mymensingh, Rajshahi, Sylhet, Barisal and Rangpur Medical College and 53 each in Khulna, Faridpur, Bogra, Dinajpur, and Comilla Medical College will be distributed for admission. At the same time waiting list on merit basis will also be published. The seats which will remain vacant after the expiry of the last date of admission, will be filled in from the waiting list. Chances will be given to the candidates prior to filling up the seats from the waiting list for changing college on the basis of the merit of male/female students and order of options (automigration), but this chance will not be for more than twice.

Students finally selected in the seats reserved for tribal and non-tribal students will be nominated for admission into different colleges on basis of merit and option apart from Dhaka and Sir Solimullah Medical College.

Final admission of the selected candidates will be on the basis of the fitness of health by medical test by the medical board as fixed by the principal of medical college concerned. The following original copies of certificates and documents must be deposited at the time of admission. Otherwise, the selection of the candidate will be rejected outright.

Original certificate of passing SSC or its equivalent examination.

Migration of student from one college to another will totally be closed during the academic session for the admitted male/female students.

Application forms for admission can be procured from all the offices of the principals of government medical colleges from 17/12/2000. The last date for depositing application form in the medical colleges concerned is 10th January 2001. The written test for the admission will be held on Friday, the 26th January 2001 at 9:00 am at the venue as fixed by the principal of the colleges concerned. Black ball point pen will have to be brought at the time of admission test.

The application form will be rejected outright if there is no signature of the applicant on the application form. All information regarding admission can be known from the offices of the concerned medical
