The Election Commission will give its verdict today whether the parliamentary seat of expelled BNP leader Maj (Retd) Akhteruzzaman would be vacant or not.

The Commission had earlier fixed the date for its decision on the issue after a three-hour hearing on December 11 last year.

Akhteruzzaman, who was elected from Kishireganj-2 constituency on BNP ticket in the1996 general elections, had joined the 19th session of Jatiya Sangsad defying party decision of boycotting JS sessions. He was expelled from BNP in September last vear.

Soon after the expulsion, Opposition Chief Whip Khandaker Delwar Hossain in a letter to the Speaker asked for declaring Akhter's parliamentary seat vacant. Delwar showed a number of reasons for this including violation of Section 70 of the Constitution.

Prime Minister Sheikh Hasina has said her government wants to hold trial for all political killings to ensure justice, reports UNB.

"The path of establishing rule of law has been created through holding of trial and pronouncement of verdict in Bangabandhu murder case after repeal of the infamous Indemnity Ordinance," she said while inaugurating the annex building of the Supreme Court yesterday

The Prime Minister expressed the hope that the court's verdict sentencing the killers to death would be

Apart from the assassination of Bangabandhu, the country witnessed brutal killing of four national leaders in Dhaka Central Jail on November 3, 1975 and the killing of President Ziaur Rahman in Chittagong in

The Prime Minister also announced that the Ombudsman would be appointed before the next gen-

"We are working with a commitment to establish democratic values, human rights and justice by establishing an independent judicial system acceptable to the

Hasina said her government is working sincerely to ensure quick disposal of cases in the interest of the

About relations among the three organs of the State executive, legislative and judiciary she said the government and the people expected the three organs would be complementary to each other for people's welfare.

Describing the court as one's last resort for justice. the Prime Minister said it is the fundamental right of the people to seek justice and get it.

Ĉhief Justice Latifur Rahman and law and Parliamentary Affairs Minister Abdul Matin Khasru also addressed the function.

The annex building of the Supreme Court has been constructed at a cost of Tk 38.73 crore on 10.50 bighas of land. The four-storeved building, designed similar to the main building, will accommodate 34 courtrooms.

A total of 44 judges will be able to run court at the same time in the new building, which will help quick disposal of pending cases, Supreme Court sources said. See page 11 col 3

They rebel leaders reiterated that

they had full confidence in her leadership and would always abide by her directives

BNP Secretary-General Abdul Mannan Bhuiyan, Khondakar Mosharraf Hossain, BNP's Student Affairs Secretary Amanullah Aman and Nazimuddin Alam also attended the meeting.

Road digging back again

Road digging in a large area of the city by DCC and other agencies concerned is once again afflicting the city dwellers. The ordeal that started a few months ago doesn't show any sign of letting up.

Sources said lack of coordination between DCC and agencies like Dhaka WASA, DESA and BTTB that have been digging different city roads for 'different purposes' throughout the year, frequently delay project implementation.

The already poor condition of city roads worsened recently when WASA started installing new pipelines for Syedabad Water Treatment Plant under the Fourth Dhaka Water Supply Project from September last vear.

Since then, WASA has excavated portions of the roads from Nilkhet crossing to Bangla Motor link road, from Bangla Motor towards Moghbazar and from Shajahanpur towards Khilgaon rail crossing. The damaged portions of the roads that were filled up with earth after installation of the pipelines are yet

to be repaired. At present, WASA is digging up roads at Bashabo, Maniknagar, Jatrabari and Jurain areas for installing pipelines while DESA is digging up the Mirpur Road from Sobhanbagh area towards the Russell Square.

Residents of the Central Road area complained that a recently rehabilitated lane connecting Central Road and Bhuter Gali was dug up for installing cable only a few

Police raided all residential halls of Daulatpur govt BL College at midnight last night to nab the kill-

Police are also looking for a woman leader of BCU who allegedly was one of the masterminds of the

The young women has been absconding since the murder, said OC Zakir Hossain of Dumuria

Police are desperately looking for the hired killers of Biplobi Communist Party to find out the motive behind the killing, said OC who expressed his reluctance to comment on the involvement of some BNP and JP activists named in the

Dumuria thana BNP president Molla Abul Kashem, Secretary of thana unit of Jubo Dal Molla Sirajul Islam, president of thana and unit of Chhatra Dal Mofizul Islam, HMA Rouf of thana unit of Jatiya Party, former president of district unit of BCU Shamim Akhter, secretary of thana unit of BCU Moinul Islam,

secretary of thana unit of CPB Kazi Abdullah, JP activists Shahinur Sarder and Yahia Sardar are among the 20 persons named in the FIR.
