

## Six to die for dacoity, killing 4 in Bogra

BOGRA, Jan 12: Six people were sentenced to death by a court here on Wednesday for committing a dacoity in a night coach after killing four people, including a policeman, reports UNB.

The convicts are Mostafa Kamal alias Lovelu, 24, Habibur Rahman alias Hoby, 52, Shahidul Islam alias Shahid, 24, Nazrul Islam alias Nazu, 26, Bidu alias Bipul, 24, and Nazrul Islam alias Bulbul, 20. Bulbul was tried in absentia.

According to the prosecution, the accused swooped on the Dhaka-bound coach when it reached Kaliarpukur on Bogra-Naogaon highway on July 8, 1996. They looted valuables worth Tk 2 lakh after stabbing to death police constable Abul Kashem, 40, coach helper Abdul Mannan, 42, passengers Binoy Kumar Das, 26, and Saidul Islam, 18.

Police later arrested seven people in this connection. Of them, Bulbul went into hiding after he was released on bail.

Police submitted a chargesheet against them on Dec 31 the same year.

After examining the records and witnesses, the Additional District and Sessions Judge pronounced the verdict, acquitting one of the accused.

## Road accidents kill 5 in city

Five people were killed in separate road accidents in the city yesterday.

The first accident occurred when a passenger bus of the Motijheel-Banani route hit a rickshaw in front Nightingale Restaurant at Bijoy Nagar at around 10am, killing both the passenger and the rickshawpuller.

The passenger was identified as Ferdousi Jhumur, 30, a teacher of Agrani School and College and wife of Samit Ahmed, principal officer of Eastern Bank. The identity of the rickshawpuller could not be ascertained.

The rickshawpuller died on the spot while Jhumur was rushed to the Dhaka Medical College Hospital where doctors declared her dead.

The body of the rickshawpuller was kept at the DMCH morgue for autopsy.

A case was filed with Motijheel police in this regard.

In the second accident, a BDR sepoy was fatally injured after he was kicked out of a running minibus near the Firm Gate footbridge at around 12 noon, police said.

The deceased was identified as Nurul Afsar hailing from Bramanbaria.

Tejgaon police rushed Afsar to the DMCH where he died at about 12:30pm.

The body was sent to the DMCH morgue for autopsy. A

## Power crisis to persist in coming lean season

# 200mw loadshedding a day despite all possible steps

Although the Power Development Board (PDB) is taking all possible steps to face the inevitable power crisis in the coming lean season from March, there would be at least 200 mw of loadshedding daily across the country, official sources said.

However, as per directives from the Prime Minister's Office, PDB would take measures to keep loadshedding as low as possible in Dhaka.

Loadshedding in last year's lean season even shot up to as high as 500 mw. "This shows the situation is better this year," one source said.

At present nine power generating units out of the 63 in the country have remained closed

for a quite long time for maintenance work. They can generate 898 mw.

PDB officials said as most of these units are likely to resume power generation by April-May this year, they would be able to overcome the lean season crisis this time to a great extent.

On the other hand, experts say that power shortage in the lean season would not be less than 500 mw daily because of scheduled closure of some other units including a few major ones for maintenance work and temporary suspension of generation in various units.

The First Unit of Ghorashal power plant with a generation capacity of 55 mw, a 56 mw unit

and a 34 MW unit at Ashuganj would resume production this month, PDB sources said.

Overhauling of 210 mw Raujan-1 unit at a cost of Tk 30 crore is nearing completion and it would resume power generation by the middle of next month.

Rehabilitation work of Khulna 110 mw power unit will be completed by May 30 this year. Production in 30 mw Syedpur power unit has been temporarily suspended.

The first and second units of Fenchuganj power plant remained closed for two years and one of the units recently

## JRC meet begins

Bangladesh and India began talks in Dhaka yesterday for devising modalities of further cooperation in economic use of waters of the common rivers and fighting floods that hit both the countries last monsoon, reports UNB.

The talks are being held in a two-day meeting of the Joint River Commission (JRC). Bangladesh Minister for Water Resources Abdur Razzak and Indian Minister for Water Resources Arjun Charan Sethi are leading their respective sides in the meeting.

Last meeting of the JRC was held in New Delhi in 1999 where the two sides had agreed on sharing data on the common rivers flowing down the two countries. The two neighbours share some 54 rivers, including the mighty Ganges and the Brahmaputra.

Talking to newsmen during a recess, Indian Secretary for Water Resources Z Hasan said sharing of Teesta waters was also on the table. He, however, parried a question whether an agreement on the Teesta, like the Ganges Water Treaty, would be signed capping the talks.

## 44 Jamaat-Shibir activists held in Sirajganj

## Lawyers belonging to BNP, JP call on Khaleda

Ziaur Rahman Khan told newsmen after the meeting that they would continue boycotting the court until the problem is resolved.

## Israeli, Palestinian negotiators say

# Little hope for an accord during Clinton's tenure

JERUSALEM, Jan 12: Israel and the Palestinians held high-level peace talks into the early morning hours today but negotiators said they didn't think they would be able to reach an agreement before US President Bill Clinton leaves office, reports AP.

After three hours of talks at the Erez checkpoint between the Gaza Strip and Israel, an Palestinian negotiator said it would take a miracle to strike a deal in the eight remaining days of US President Bill Clinton's term.

The two sides are working toward a treaty outline leaving it for a proposed visit by US mediator Dennis Ross to narrow differences on key points.

The negotiations resumed unexpectedly after both sides agreed to try to reduce friction. On

Thursday, Israel began easing its closure of Palestinian areas.

Today, there were only scattered confrontations in contrast to previous weeks when Palestinians would often march toward Israeli positions after Friday noon prayers.

In the West Bank town of Hebron, a Palestinian man was shot and killed by Israeli troops during stone-throwing clashes. As they carried the dead man to a nearby Jewish settlers' compound, soldiers held up what they said was his gun. It was not immediately clear if he had tried to shoot at the soldiers.

# Dispute over appointment of two IT experts in EC drags on

The dispute over appointment of two IT experts in an Election Commission project that sparked a tussle between the Chief Election Commissioner (CEC) and his deputies has not yet been resolved.

The IT experts Lionel J Wollner and Mainul Haq appointed in August last year by the CEC in an EC project to "strengthen" it are working.

Their appointment created a tussle between CEC M A Syed and the three election commissioners Abidur Rahman, Moshtaq Ahmed Chowdhury and Shafiqur Rahman who opposed it

saying it was done "violating" rules.

The CEC earlier assured his three colleagues that the issue would be resolved through discussion. None of the commissioners however raised the issue at any meeting.

In late November, the tussle reached its peak when the CEC, on return from an official visit to USA, issued a letter expressing his disagreeing with the decisions taken by the Commission in his absence.

During the CEC's visit between October 16 and November 12 last year, the three commissioners

decided to cancel the appointment of Wollner, who allegedly interfered in the Commission's activities.

The CEC stood by Wollner and justified the appointments. The three commissioners termed his activities "whimsical".

When contacted by telephone, Election Commissioner Moshtaq Ahmed Chowdhury told The Daily Star yesterday that the issue was still undecided. "We gave decision for cancellation of the appointment, but the consultant is working."

# Khaleda's 'reconciliation' in JCD not working

Crisis in BNP's student wing Jatiyatabadi Chhatra Dal (JCD) persists as rebel JCD activists are preventing its leaders from entering the Dhaka University campus.

BNP chief Khaleda Zia announced JCD's new central committee with Nasiruddin Ahmed Pintu and Shahabuddin Laltu as President and General Secretary respectively on December 23 last, triggering violent protests from within the organisation.

The two rival sides then reached a 'reconciliation' at the initiative of Khaleda Zia on Monday but the rebels have not yet accepted the new leadership of

JCD and have asked their followers not to come to the campus.

A group of supporters of Pintu and Laltu came to the campus on Thursday for the first time since formation of the new committee. The rebels halted them in front of Madhu's canteen and asked them to leave the campus. They however did so.

JCD Sources said the rebel group agreed to accept the new leadership and withdraw their agitation against it under pressure from Khaleda Zia. But now they are feeling frustrated.

Earlier, they demonstrated against Pintu-Laltu committee with the hope that it would be cancelled and a new one would be formed.

Meanwhile, a small number of leaders and activists of the rebel group attended BNP's public meeting at Paltan Maidan in the city on Thursday. The others condemned them for this.

The rebel leaders were now being blamed by their supporters

for the reconciliation reached on Monday, agreeing to accept Pintu-Laltu committee.

Sources said some rebel leaders and activists are planning to join hands with Pintu and Laltu following assurance of accommodating them in the new committee. This has created misgivings and distrust among the rebels.

## Corruption case against 30 PWD men in Khulna

## BCL factions trade fire over control of bus stand at Bakerganj

BARISAL, Jan 12: Two factions of Chhatra League today exchanged gunshots at Bakerganj to take control of a local bus stand, reports UNB.

However, nobody was injured in the gunfight between BCL's Lokman Dakua group and Jalal-Khokon group.

Today's clash erupted when Lokman Dakua group tried to recapture the area. Witnesses said the warring BCL men traded 25-30 rounds of gunshots in the hour-long battle from 2 pm.

Traffic on Barisal-Kuakata road came to a halt for over two hours during the clash in which the feuding groups also exploded bombs and pelted brickbats at each other.

Local MP Syed Masud Reza and Awami League leaders rushed to the spot but failed pacify their student activists. Police was present there but they did not go into action, locals said.
