## SC stays ban on fatwa for six weeks

The Supreme Court yesterday stayed for six weeks the High Court judgement on January 1 declaring all Fatwas (edicts) illegal.

Chief Justice Latifur Rahman, however, kept the stay non-operational in the case of housewife Shahida Bibi of sadar Upazila of Naogaon. Shahida fell victim to a 'Fatwa' given by local Moulana Haji Azizul Islam, forcing her to go for a 'hilla' (interim marriage with another person after divorce to

remarry her husband). The stay came upon a petition against the High Court judgement given by Justice Golam Rabbani (since appointed a judge of the Appellate Division) and Justice Nazmun Ara Sultana. Justice Rabbani did not took part in the hearing yesterday as it was on his verdict.

The petition was filed by Mufti Mohammad Abu Taiyab of Lalbagh Jamiya Ashrafiya Madrassah and Maulana Abul Kalam Azad, Chairman of Bangladesh

Masjid Mission. The forced marriage had traumatised Shahida's life as her husband Saiful Islam declined to accept her after the 'hilla' marriage. The moulana claimed to have overheard Saiful verbally divorcing her three times over a family feud 18 months ago and

gave a Fatwa recently that they could not live as

husband and wife. For that she had to marry another man and obtain a divorce and remarry Saiful. When Shahida's plight was reported in newspaers, the Division Bench comprising Justice Golam Rabbani and Justice Nazmun Ara Sultana issued a suo moto rule on the Naogaon district administra-

tion and gave the judgement on January 1. But the district administration replied that Azizul Islam had already been arrested along with five others on charges under Nari-O-Shishu Nirjatan

# Tofail blasts India for not allowing duty-free access to LDC products

Industry Minister Tofail Ahmed yesterday strongly criticised South Asia for not allowing dutyfree access to goods from least developed countries in the region.

"Whereas EU is going to give duty-free access to our goods, and US and Canada are providing quota facilities, our big neighbours are doing nothing for us," the minister said while addressing a dialogue on Agenda for South Asian Co-operation at the BRAC centre in the city.

"We have withdrawn all kinds of barriers and reduced duty and tariff rapidly. Even that was not reciprocated by the bigger countries, particularly India

The South Asia Centre for Policy Studies (SACEPS), which was formally launched yesterday, organised the dialogue.



## PM asks armed forces to be ready for external attack

Prime Minister Sheikh Hasina has advised the armed forces to remain ever ready to resist any external attack to protect the country's independence and sovereignty, reports UNB.

"We should always remain ready to face any situation so that we can safeguard our sovereignty and independence," she said.

She did not indicate if there are any external threats. However, a neighbouring country has now massed troops on the frontier following a border

The Prime Minister, who also holds charge of the Defence Ministry was addressing the inaugural function of the Third National Defence Course and First Armed Forces War Course at the National Defence College at Mirpur in the city yesterday.

She said her government wants peace, not war. "We want local, regional and international peace and at the same time we will have to remain alert for neutralising any attack from external forces.

Only a stable democratic system in the country can

ensure protection of sovereignty. When democracy exists in a country, none can dare to attack it, she said, adding that socio-economic development is essential for combating external attacks.

Addressing the high civil and military officials, Sheikh Hasina said integration of the people with the armed forces is also important to win any war against the enemies

She suggested the trainees of National Defence College, which imparts training to high military officials and gives guidelines for adopting national strategy, to involve all forces while taking up any strategy to protect national interest.
