UN lauds Bangladesh's role in peacekeeping

A top military official of the United Nations (UN) has lauded Bangladesh armed forces for its immense contribution to bring peace in many trouble-torn areas in the globe especially between Iraq and Kuwait, reports BSS.

"Without the help of Bangladesh Army things were impossible to carry out peace mandate of the UN in Kuwait" the official said on Friday.

Major General John A Vize, Force Commander (chief) of the United Nations Iraq-Kuwait Observation Mission (UNIKOM) while talking to media team from Bangladesh said that UNIKOM has become the most successful peace mission of the UN and that most of the credit goes to Bangladesh and its Army.

"I'm totally satisfied. It's a pleasure for me to have an opportunity to do work again with the Bangladeshis who are totally dedicated and professionally confident," Vize said. "They (Bangladesh Army) made enormous contributions to restore peace and rebuild the war-ravaged Kuwait," he observed.

Vize, who also worked with Bangladeshis in peace keeping mission in Cambodia, admitted that considering his past experience and the present one "My admiration is immense."

He said 75 per cent of the total contribution to UNIKOM, an UN Observation Mission performing duties in the 14-km De-Militarised Zone (DMZ) in Iraq-Kuwait borders, were made by the Bangladesh Army.
