KARACHI, Jan 18: Pakistan said today it will miss its tax revenue target for the fiscal year to June because efforts to widen the tax net slowed and imports were lower than expected...

The tax target is a key condition of the International Monetary Fund loan programme. Sarfaraz Ahmed, chief of sales tax at the Central Board of Revenue, said the tax body has informed the military-led government...

We told the government that assumptions on which the revenue target was fixed proved wrong during the first six months and it is not possible to meet the target under present condition...
