to 'unmask' opposition

Deeply concerned over the "rise of fundamentalist forces" in the country, the Awami League leadership is now planning to "unmask ultrarightist face" of the BNP-led fourparty opposition alliance, some senior leaders of the party said

BNP can not evade responsibility of Saturday's violence unleashed by one of its alleys, they said.

Maulana Azizul Hag and Fazlul Hag Amini, two top leaders of Islamic Oikya Jote (IOJ), a component of the alliance, are directly involved in the violent movement in favour of fatwa (religious edict), an issue lying with the judiciary, they told The Daily

The IOJ leadership has launched the violent movement under the banner of 'Islamic Law Implementation Committee', the ruling party leaders said.

Opposition slates cop murder, demands judicial probe

Secretaries general of parties belonging to the four-party opposition alliance yesterday condemned the killing of a police constable and demanded judicial inquiry into the incident as well as exemplary punishment of the real culprits.

In a joint statement, BNP secretary general Abdul Mannan Bhuiyan, Jatiya Party secretary general Naziur Rahman Manjur, Jamaat-e-Islami secretary general Ali Ahsan Mujahid and Islami Oikya Jote joint secretary general ARM Abdul Matin said that the government has resorted to political repression to protect itself from people's growing anger.

They said the Awami League, which has completely failed to run the country and also stands isolated from the people, is now trying to create anarchy through inciting hostility among different classes of people to cover up its failures incompetence and misdeeds.

Bomb scare at CU



AL now plans Amini, his son & 12 others held for declaring judges murtad

The Detective Branch (DB) of police yesterday arrested Secretary General of Islami Oikya Jote (IOJ) Mufti Fazlul Haq Amini whò at Friday's rally declared the two High Court judges 'murtad' for giving verdict against fatwa.

The IOJ leader, his son and 12 of

his followers were arrested when they were coming from Lalbagh Madrassah to attend a protest rally at Paltan at about 3.30 pm.

Amini, also convenor of the Committee for Implementation of Islamic Law, was kept in Ramna thana custody till last night. Sources said the arrested would be produced before the CMM's court today.

When asked, a top DB official said they were arrested on charges of threatening High Court judges at a rally at Paltan Maidan on Friday

and instigating violence afterwards. The official, however, could not confirm whether charge of killing the police constable was brought against Amini and 13 others.

Meanwhile, police batoncharged a procession of Ulema-Mashaikh (Islamic Scholars) near Purana Paltan Crossing in the city yesterday afternoon, leaving at least 30 of their activists injured.

Police also kicked some of them and dragged them into a police van. creating panic in the area. Over 50 activists were picked up during the operation.

Police first baton-charged a procession of Ulema-Mashaikh on Bijoynagar Road at about 5 pm. The procession was brought out from Paltan Mosque after Asr Prayers. Later, the Islamic activists held a

rally in front of the mosque protesting what they said police atrocities' the Islamic activists at Mohammadur in the city during hartal hours on Saturday. After the rally, the activists

brought out another procession. When the procession reached Bijoynagar Road, hundreds of police men deployed at Paltan crossing surrounded it from both sides and started clubbing the activists. They ran into the nearby shops, restaurants and other establishments but SEE PAGE 11 COL 5

'Ustad' was inside the mosque when'students' killed the cop'

One of the alleged killers of police constable Badhsa Mia, Humayun Kabir sat on the floor of Mohammadpur police station yesterday, handcuffed to a wooden shelf. He looked poised and remorseless. Kabir talked to journalists with

confidence. "Our ustad (teacher) Shaikhul Hadis Allama Azizul Haque and his brother were inside the mosque when the policeman was killed by students," Kabir calmly told to The Daily Star Correspondent

"When we opened the main gate of the mosque, I found lots of policemen outside. I asked police to let our ustad go away. The police agreed." Kabir said he had been "studying"

Hakkani Hakikia Madrassha for over ten years. He said his father, a retired Roads and Highways employee, had sent all his brothers for madrassha education. He hails from Baufal, Patuakhali and is the youngest among six brothers and three sisters.

As Kabir talked, 58 other suspects, aged between 12 and 40 years, arrested on Saturday from the same area in Mohammadpur, pleaded not guilty to the police officials who stopped to have a look into the two large cells of the police

Outside, several hundred curious onlookers waited for hours to have a glimpse of the suspects.

At least two platoons of riot police cordoned off the police station when prison van, which took them to the Chief Metropolitan Magistrate's court in the old part of the city.

The CMM's court placed

Humayun Kabir, Hizbullah and Akram Hossain on three days' remand and sent the rest to Dhaka Central Jail. The entire area is known as Mohammadia Housing. There are

more than a dozen madrassahs in the area, accommodating several thousand students. These have been built in the last ten years. Local people said Chairman of

Case filed against IOJ chief, 36 others

Islami Oikkya Jote (IOJ) Chairman Maulana Azizul Haq, his son and 35 others have been accused in the case filed with Mohammadour thana in connection with the killing of police constable Badsha Mia

The constable was beaten to death by Islamic zealots inside Noor Masiid at Mohammadi Housing in Mohammadpur area of the city during the hartal on Saturday called by a section of Islamic scholars on Saturday.


Soon after the killing, police arrested 58 people for their alleged involvement in it. Of them, 32 have been accused in the murder case. Besides, the IOJ chief, his son Maulana Mahfuzul Haq and some others now absconding have been accused in the murder case.

Of those absconding, Imam of Noor Masjid Abu Bakar Siddique was arrested yesterday evening from his rented flat at Mohammadi Housing. In the FIR filed by SI Delwar Hossain Akhond, it was alleged that Badsha

Mia was killed on instruction from Maulana Azizul Haq and that he was present during the killing. Meanwhile, one Tamuzuddin of Mohammadpur Housing Society filed

another case under the Public Safety Act (PSA) accusing the 58 arrested and 250 others on charges of rampage, blocking roads and hurling brick-

Nigerian languishes in jail for years despite end of term

He was arrested in March 1992. After three years' trial, the court sentenced him to two months' imprisonment. On completion of the prison term, he thought he would be flying back home in Nigeria.

But he is still a virtual prisoner in Dhaka Central Jail. He is now a victim of legal complications and lack of attention by the authorities, sources concerned said.

Nineteen-year-old Nigerian citizen Goddyu Ochendo was arrested in connection with drug smuggling by teenaged American girl Elieda MacCord in 1992. In July 1993, Goddyu was acquitted in the drug smuggling case. But on July 13, 1993, he was charged with using

He then complained to the Chief Metropolitan Magistrates Court that he could not go home as his lawyer defrauded him of his money. He had 1421 US dollars with him, which he had deposited with his lawyer through the court during the trial. But his lawyer did not return the dollars,

Block 16: Shell Oil likely to seek extension of PSC

Shell Oil is likely to apply for extension of the Production Sharing Contract (PSC) for block 16 as the block is likely to be relinquished on May 5 next due to non-fulfilment of work commitment. Shell has been pursuing drilling

of a deep-sea well of a complex nature for the last two years, said sources. But thanks to high cost, Petrobangla turned down the proposal to drill the well at Magnama a spot situated 60 km off the Chittagong coast. Successful drilling of the block would have averted the situation, sources added.

Last December, Shell Oil relinquished the whole area of block 15 where it made no discovery in its five years of operation.

Block 16, however, has more prospects than block 15. Cairn, the original operator of these two

blocks, discovered the Sangu gas field in early 1996, two years after the signing of PSC. Sangu supplies over 120 million cubic feet of gas per day now.

Yesterday at a Joint Review

Committee meeting on block 16 at Petrobangla, both the government officials and the Shell Oil officials agreed that Magnama, though costly, had enough potential to justify its drilling.

But Shell Oil has expressed its

inability to mobilise rig, build drilling structures and complete the drilling at Magnama by May 5 the deadline by which the oil company must successfully complete the drilling of the well or give up all the areas of block 16 (excepting where it has production and operation). In such a critical situation.

Petrobangla suggested that Shell

Oil seek extension of the block to

undertake the Magnama operation Shell Oil said it would do so. Shell intends to drill over 3700

metres deep in Magnama. A source said, "Magnama is located in a high pressure and high temperature zone. Shell needs to use special rig and special tools in this operation. In the Bangladesh territory of the Bay of Bengal, none has ever drilled a well in high pres-

sure and high temperature zone

other than Shell and so, none has

adequate knowledge about the

geological peculiarities there." "Typically, in many land-based wells, the high pressure-high temperature zone might not be available up to a depth of 5000 metres. But in the Bay of Bengal, rig operators reach the high pressure zone at 3400 metres in depth," he added.
