Nepalese CJ escapes attempt on life: 5 killed

Nepal's Chief Justice Keshav Prasad Upadhyay escaped unharmed after an attack by suspected Maoist rebels in West Nepal but four security staff and a judicial official were killed, an official said.

Upadhyay was on a scheduled inspection tour of West Nepal on Saturday when his team was ambushed and attacked with bombs and gun fire at Painsathhi in Surkhet district.

"Upadhyay is safe after the incident," a home (interior) ministry spokesman said late on Saturday. He said Baldev Dhital, a senior official of the Surkhet appellate court, who was part of the chief justice's team, and four security quards were killed.

Another member of the team, a judge of the same court, Purushottam Parajulia and two security personnel were injured in the same incident and were undergoing treatment at a local hospital, one police official said.

Home ministry spokesman Gopendra Bahadur Pandey blamed Maoist rebels, who are fighting against the 10-yer-old constitutional monarchy, for the attack.

There was no immediate word from the Communist Party of Nepal (Maoist) about the attack, the first on a senior court official since the Maoist conflict began five years

The group, considered ideologically close to Peru's Shining Path guerrillas, has launched an armed campaign to try to install a one-party communist republic in the world's only Hindu kingdom that is among the poorest nations on earth.

Badsha Mia buried

Police constable Badsha Mia was buried at his family graveyard in Durgabuddi village under Rajair thana in Madaripur yesterday.

Badshah Mia, 50, a constable of Mohammadpur thana was beaten to death by Islamic zealots inside Noor Mosque at Mohammadpur Saturday afternoon.

The body of Badsha Mia was first taken to his Takerhat residence in the morning yesterday. Then it was taken to Durgabuddi where he was buried after a namaz-e-janaza. The local Superintendent of Police

attended the janaza. The autopsy report showed that Badsha Mia was killed following physical torture.
