Resolve conflicts to win polls, PM asks partymen at Natore

Cabinet meets at Uttara Ganobhaban today

Addressing AL leaders of northern districts including Natore at the Uttara Gonobhaban, she advised the local leaders not to waste time lobbying for party nomination but to work hard to win the people's support

Hasina also the AL chief, instructed the district leaders to form

teams at the village level and campaign for the AL government's achievements.

"You must work for the 'boat' (AL's election symbol) no matter who gets nomination," she said.

The AL chief also warned of

The PM flew in Natore at 4:20

pm to hold a meeting of her cabinet at the Uttara Ganobhaban today. She is also due to address a public meeting before the cabinet meeting.

Sheikh Hasina said, the opposition's oust-government movement

has failed. "We challenge the opposition's threat ... We'll return to power with the people's mandate," she said

Hearing on split verdict begins

Hearing on the split verdict on the six accused in the Bangabandhu murder case began in the High Court yesterday.

The split verdict was given by a Division Bench of the High Court on December 14 last year. One of the judges, Justice Ruhul Amin, in his verdict had upheld the death sentence of ten out of the 15 convicted by a trial court on November 8, 1998 for killing Bangabandhu Sheikh Mujibur Rahman on August 15, 1975. He acquitted the rest five. Justice Khairul Huq, another judge of the Bench, upheld the death sentence of all the 15.

Justice Fazlul Karim heard the verdict on the six accused.

One of the six, Capt (rtd) Majed, was given death sentence on murder SEE PAGE 11 COL 3

A Division Bench of the High Court yesterday issued a Rule Nisi upon the government to show cause within two weeks why Islami Oikkya Jote (IOJ) Chairman Shaikhul Hadith Maulana Azizul Huq and General Secretary Mufti Fazlul Huq Amini should not be brought before the court to satisfy it that they are not held in custody illegally and why their detention should not be declared illegal.

The Division Bench comprising Justice Abu Sayeed Ahammad and Justice Khademul Islam Choudhury gave the order following filing of two writ petitions on behalf of them.

The petitions were filed by advocate Mahbubur Rahman MP, according to a press release issued by him.

Azizul Huq is aged over 82 years. He and Amini were implicated in "false cases", the writs said.

Tk 15 cr IT project for five varsities hangs in balance

The fate of Tk 15-crore project for a one-year postgraduate diploma programme in information technology (IT), considered a thrust sector in the sountry's economy, bangs in the balance due to burequieratic bettlepack.

The government initiated the programme in 1998, aiming at developing human resources in the IT sector. The specially tailored course is supposed to teach the bright students of science and business disciplines the fast growing information technology, sources said.

Five universities Bangladesh University of Engineering and Technology (BUET), Shahjalal University of Science and Technology, Khulna University, Chittagong University and Rajshahi University were selected to introduce the course. The government-provided fund would be equally distributed among five universities.

The course curriculum was also finalised last year and several meetings

were convened to finalise the course. Main thrust of the initiative is to produce brilliant IT professionals, another source said.

The programme also looked forward to getting feedback from IT sector. The government has a plan to earn one billion US dollars from this sector in three years.
