9 new HC **Judges** appointed

STAR REPORT

President Shahabuddin Ahmad yesterday appointed nine judges to the High Court Division of the Supreme Court.

The fresh appointment is being regarded as a move to make the Supreme Court more functional to dispose of tens of thousands of pending cases.

Law, Justice and Parliamentary Affairs Minister Abdul Matin Khasru confirmed last night that the new iudges were appointed to the HC Division. The newly appointed judges are likely to take oath on Thursday

The judges are: Law Secretary Abdul Hai, Solicitor Abdur Razzak, Registrar of the Supreme Court Marziul Hag from the Judicial Cadre, Deputy Attorney General Altaf Hossain Khan Arun, and Iman Ali and Mahmud Hossain from the office of the Attorney General, and Shamsul Huda Manik, Hasan Faez Siddique and Faruk Ahmed from the Supreme Court Bar Association.

With the new appointments, the number of judges in the High Court Division stands at 49. But, people involved with the judiciary said more number of judges is required to dispose of thousands of cases pending with the SC.



Ekushey returns to inspire nation

The nation pays homage to the martyrs of the historic Language Movement on the Shaheed Day today, renewing its pledge to draw inspiration from the glorious memories of Amar Ekushey, and give democracy institutional shape and ensure economic emancipation for the teeming millions in the country.

On this day 49 years back, heroic sons of the soil Salam, Jabbar, Rafiq, Shafiq and Barkat embraced martyrdom to establish Bangla as the state language of the erstwhile East Pakistan.

They were killed when police had opened on unarmed students, demonstrating under the banner of

All-Party Students Action Committee against the conspiracies of Pakistani rulers to declare Urdu as the only state language. Fearless students in their thousands took to the streets to foil a heinous move to undermine Bangla, the language of the majority, five crore people who lived in the then East Pakistan

The day is also being observed as the International Mother Language Day in 188 countries across the globe. On November 17, 1999 UNESCO declared February 21 as International Mother Language Day.

The Language Movement was a giant step towards

Shafiullah should have been an accused, not witness

Judge blasts ex-army chief during hearing

Former army chief General Shafiullah and chiefs of other armed forces came under fire as the prosecution yesterday ended presentation on testimonies of witnesses in the Bangabandhu Murder Case.

"He (Shafiullah) should have been made an accused" instead of a witness in the case, Justice Muhammad Fazlul Karim commented as the prosecution quoted witnesses' testimonies in the hearing on the split judgment of a previous High Court bench.

Justice Karim added that Shafiullah's failure to respond to the President's urgent call was not "an inefficiency but a gross mistake" since he was in command of the entire army.

The judge also blasted the then army chief for succumbing to the pressure of Major Dalim, a fugitive

convict in the case, and for following him to the Radio station to express his allegiance to the administration installed by the August 15, 1975 plot

The judge's comment came on the fourth day of the hearing of the case in the second bench when the prosecution ended their submission on the witnesses' testimonies and cross-examinations involving the six accused, acquitted by one of the two judges of the previous bench.

Justice Karim also questioned the role of the then BDR chief Major General Khalilur Rahman and navv and air force chiefs, saying they all deserved to be accused in the case.

Justice Karim commented that General Shafiullah also accepted foreign postings after August 15, 1975 like most other plot leaders.

The prosecution, however, apparently tried to defend General

all witnesses of the case, calling their role as "inefficient."

During the past four days of hearing, the prosecution cited testimonies of witnesses to establish the charges against the six accused and to explain the background of the entire case.

The case came for hearing before a third judge in line with the legal provisions because of the split verdict on December 14 last year by Justice Mohammad Ruhul Amin and Justice ABM Khairul Hague.

The judges were unanimous on the death sentence of ten accused but were divided on the fate of the rest five. They also could not reach consensus on the charge against one of the ten accused, fugitive former Captain Majed, though they

There has so far been ten hartals n Dhaka and nine in Chittagong. At least 18 people have been killed and several hundred injured in hartalrelated violence over the first 20

The month has had nine days of

official holidays, including weekends and the Ekushey February. However, there have so far been seven countrywide hartals. Moreover. Chittagong and Brahmanbaria have had two more hartals each. The four-party opposition alliance has also designated February 25 and 26 for countrywide dawn-to-dusk hartals.

Frequent hartals have disrupted

socio-economic activities across the country. The eventful month began with a hartal, called by the leftist political parties. That day a procession led by State Minister Mofazzal Hossain Chowdhury Maya attacked a CPB rally.

1997 textbook scam

BAC sues ex-NCTB chief, 3 others

The Bureau of Anti-Corruption (BAC) has filed a case against former chairman of the National Curriculum and Textbook Board M Sayedul Huq, former member Mofizuddin Uddin and two officials of the NCTB for alleged embezzlement of over TK 57 lakh in the process of procuring paper for printing of primary level textbooks in 1997.

The two officials are M Aman Ullah, Senior Store in Charge and Md Abdur Rashid Miah. Store Officer.

According to the First Information Report (FIR) filed with Motijheel thana, the NCTB had signed a deal with Hindustan Paper Corporation Ltd (HPCL) for procuring 8,630 tonnes of paper priced at Tk 227.56 million. It was a project under a Norwegian grant of about 35 million Kroners or about TK 23 crore for supply of 'wood-free printing paper' for printing of textbooks for the

The HPCL supplied only 3733.99625 tonnes of paper out of 8,630 tonnes. Besides, many bundles contained less than the specified quantity of
