Abductors skip talks again

Kalparanjan expects negotiations to begin today

Uncertainty over negotiations with the armed group of tribals holding three Europeans hostage in the forests of Chittagong Hill Tracts (CHT) continued as talks with them could not be held for the second consecutive day yesterday.

The still unidentified group kidnapped three engineers -- Torben Mikkelsen and Nils Hulggard of Denmark and Tim Selby of Britain -- from a road construction site at Betchhari in Naniarchar thana in Rangamati on Friday last.

They demanded TK nine crore as ransom and proposed talks with negotiators led by Minister for CHT Affairs Kalparanjan Chakma on Wednesday.

But they did not show up for the negotiations on Wednesday and also yesterday with the minister who was accompanied by Dipankar Talukder MP and UP Chairman of Mahalchhari Archeamedis Chakam who was acting as a mediator, officials in Dhaka said.

The abductors have reiterated their demand for withdrawal of army cordon around their hideout in Kalapahar between Rangamati and Khagrachhari and put a new condition for negotiated release of the three hostages

They have demanded that Kalparanjan Chakma, Dipankar Talukder MP and Archeamedis Chakma should accompany them to a safe place after army withdrawal and said they would then free the hostages, our Staff Correspondent in Chittagong reported yesterday quoting sources

Proposed talks with the abductors on Wednesday at a Duk Bungalow in Mahalchhari and at a designated venue vesterday did not take place as the they did not show up.

The team led by Kalparanjan Chakma went there in vain and returned. Earlier, the abductors had demanded presence of the minister and the MP along with the UP Chairman.

Considering the urgency of release of the hostages, the minister got clearance from Prime Minister Sheikh Hasina to conduct the negotiations with the abductors, sources said.

Two representatives of the abductors turned up at the meeting venue vesterday with notes from the abductors and also from the hostages report

Purchase of Navy frigate

An 11-member parliamentary team leaves for South Korea today to see the progress of building a frigate for Bangladesh Navy.

The frigate worth 105 million US dollars is being built by Daewoo Corporation and 80 per cent payment has already been made.

The Parliamentary Standing Committee on Defence Ministry at a meeting yesterday discussed the issue in view of recent reports of Daewoo's becoming bankrupt.

Representatives from the Navy. however, assured the Committee that financial problems of Daewoo frigate, meeting sources said. They told the meeting Daewoo
