Recreational centres under defence, paramilitary forces

# They run those commercially but don't pay taxes

Various recreational and entertainment centres under the defence and paramilitary forces do not pay duties and taxes to the government although those are run commercially

Officials of the National Board of Revenue (NBR) say that Value Added Tax (VAT) and supplementary duties are applicable to earnings from cinema halls, community centres, auditoriums, restaurants and clubs under different cantonments and defence establishments as those are also used by

But despite repeated initiatives by them, those could not be brought under the VAT and supplementary duty network, the officials said.

The VAT and Excise Commissionerate wrote a number of letters to the authorities of cantonments and offices concerned for registration of those establishments and paying duties and taxes but they did not respond, according to sources

Show cause notices were also issued against the authorities of those establishments asking them to appear for hearing but they did not, one

As the authorities of cantonments and BDR units did not respond positively, NBR officials had brought the matter to the notice of the NBR chair-

The then chairman of NBR Abdul Muyeed Chowdhury wrote a letter to the

defence ministry in November 1999 saying it was leant from the commissionerate offices that cinema halls, community centres and clubs under the defence forces were not paying VAT and duties although these were supposed to.

The ministry then asked the headquarters of army, navy and air force to take steps in this regard on an emergency basis. But they tried to convince the NBR that those establishments were exempted from paying VAT and supplementary duties.

NBR officials however did not find any reason for such exemption as those are run commercially and earn huge amounts. The defence forces also could not produce any documents regarding exemption of duties and taxes, a top official noted.

He said those establishments remained out of tax network because of military rule in the country for long in the past.

The official further said it is not possible for a tax commissioner to conduct raids in those establishments with police force for realising duties and taxes because those are located in cantonments. Defence forces maintain their own security system there

There are at least six such establishments in Dhaka cantonment. These are Sagorika Cinema Hall, B A F Shaheen Auditorium, Garrison Cinema

#### 59 Hajj pilgrims held for arms trafficking!

Saudi police in Makkah have arrested 59 Hajj pilgrims from the Russian republic of Dagestan over the past week for arms trafficking, the Russian embassy in Riyadh said

Forty-two hunting rifles, swords and night-vision goggles were seized from a group of pilgrims who were trying to sell them to other Muslims making the annual pilgrimage, the embassy said.

According to the Arabic-language Al-Havat newspaper, the members of the group were then released by the Saudi authorities "In an act of tolerance" to allow them to complete their

pilgrimage. A Russian diplomat confirmed the release of the Dagestani pilgrims and said the embassy had been informed of it by Saudi authorities.

The Russian embassy has not intervened at any point in this busi-

Those arrested belonged to around 2,000 pilgrims from the Caucasus republic Dagestan who had arrived in Saudi Arabia by road via Turkey and Iraq Al Hayat said.

#### The spotted were brought from Rajshahi Central Park

The four spotted deer, seized by Mirpur police from Gabtali Cattle Market in the capital on Saturday were brought from the Rajshahi Central Park and Zoo (RCPZ).

One Enamul Haque of Laxmipur-Vatepara in the city bought the deer from RCPZ authorities for Tk 40,000 and later sold those to a trader for Tk two lakh, sources said. The central park and zoo is run by

the Rajshahi City Corporation (RCC). Ali Akbar, Superintendent of the RCPZ had admitted selling the four deer to Enamul Haque. A city corporation official request-

ing anonymity said Enamul Haque applied for purchasing the four male deer for rearing in the month of February.

Accordingly, the RCC authorities decided to sell the deer to the applicant for Tk 10,000 each, the official

The city corporation asked Enamul Haque to receive the deer from the RCPZ and also sent a letter to superintendent Ali Akbar in this regard on February 28.

The RCC had earlier sold 23 deer from the central park and zoo,' said Ali Akbar. There are now 175 spotted deer in the Rajshahi City Park and Zoo (RCPZ).

Meanwhile, Rajshahi City Corporation in a press release yesterday said the deer were sold to Enamul Haque on condition that he would rear them

### Bangabandhu Murder Case Prosecution ends reading from paper book

It is not the killing of an ordinary person, it is the killing of the President of the country. The conspirators knew very well that it would have wider repercussion. Justice Khairul Hug wrote in his judgement confirming death sentences against all the convicts of the Bangabandhu

His observations were read out resterday from the paper book on the split judgement of the High Court on the appeal and death references in the Bangabandhu Murder Case.

Completing the reading of the udgement of Justice Huq, who pheld the death sentences on all the 15 condemned accused in the two-judge HC bench. Adv Anisul

Huq said the deployment of army on August 15, 1975 was also part of the entire assassination plot.

On the 10th day of hearings in the third judge's court of Justice Mohammad Fazlul Karim, the prosecutor, quoting Justice Huq, said the presence of Maj Ahmed Sharful Hossain, Capt Kismat Capt Nazmul Hossain Hashem, Ansar and Capt Majed in the radio station was not an isolated act.

In his judgement Justice Khairul Huq commented that the presence of those officers in the radio station was part of a pre-planned conspiracy so that other aspects that would follow the killing of a President could **SEE PAGE 11 COL 7**

# Car bomb blast smashes windows of BBC building

British Anti-terrorist police warned yesterday of the risk of further terrorist attacks after a bomb blast outside the headquarters of the BBC blamed on

One person was slightly injured when the device went off in a taxi outside the British Broadcasting Corporation's offices in west London as bomb disposal experts attempted to carry out a controlled explosion.

Alan Fry, the head of Scotland Yard's Anti-Terrorist Branch, said the bomb, "clearly a big device" and made using high explosive, was being linked to the dissident Real IRA group. "We have been predicting, since Christmas, that the mainland, and

London in particular, were to be subject to terrorist attacks. "This was one of those attacks. I can only fear that we will see more." The blast smashed windows in the BBC buildings, destroyed the taxi

carrying the bomb and shook houses up to two kilometres away. One London underground worker suffered cuts around his eyes. Fry said bomb disposal experts rushed to the scene after receiving a coded warning passed on to them by a London hospital and a charity.

They were attempting a controlled explosion using a remote-controlled robot when the bomb exploded shortly after midnight. "I believe that those responsible for this explosion are indeed a dissi-

dent Irish republican group and that is where we are commencing the investigation," he added Asked if he thought the Real IRA, which broke off from the mainstream Irish Republican Army several years ago and is opposed to the Northern Ireland peace process, was to blame he said, "That would



BBC World Service yesterday issued a statement following media reports regarding the head of its Bengali Section, Mahmud Ali.

In a later exchange of prisoners, he was freed and resumed his army career in

## Tremor jolts northeast India, Myanmar

An earthquake measuring 5.1 on the Richter scale shook India's northeastern region and parts of neighbouring Myanmar early yesterday morning, officials said.

The quake caused panic among the people living in the states of Assam, Meghalaya, Manipur and Mizoram, though there were no reports of any damage to life and property.

According to AK Sahu, a seismologist with the Regional Seismological Centre in Shillong, the capital of Meghalaya, the epicentre of yesterday's quake, which occurred at 04:26 AM was plotted along the Indo-Myanmar border. Reuters adds, a tremor measur-

ing 5.2 on the Richter scale hit the western Indian state of Guiarat yesterday, more than a month after a giant earthquake killed an estimated 30,000 people there.
