A ruling party leader was murdered in Hadal union of Faridpur upazila in Pabna district vesterday.

The assailants swooped on Rezaul Karim Sabu, the Hadal union president of Awami League, near his home at village Balughata while he was going to the upazila town about 10 in the morning.

"He was beheaded with sharp weapons," police said.

A case was filed with Faridpur thana, but nobody was arrested in this connection.

A tense situation was prevailing in the area.

Warrant against complainant in **ULFA** leader

The First Assistant Metropolitan Sessions Judges Court, Dhaka vesterday issued a non-bailable warrant against the complainant of the case filed against ULFA leader Anup Chetia and his two associates on charges of possessing a satellite telephone set.

Judge Rafi Imam issued the warrant as the complainant Sub-Inspector Farid Ahmed did not appear in the court despite issuance of summons on him for a long time to be present in the court.

The court adjourned the proceedings till March 29 following a time prayer by the prosecution lawyers.

Chetia and his two associates Babul Sharma and Laxmi Prasad Goswami were arrested at Adabar under Mohammadpur thana on December 21 in 1997, for possessing forged pass ports, foreign currencies of 16 countries and a satellite telephone set.

Four separate cases were filed with Mohammadpur thana against

them in this regard. Chetia was awarded six years rigorous imprisonment and finéd Tk. 6,000 by the CMM's court, Dhaka, on October 25 in 1998 for possessing forged pass ports and illegal stay in

Bangladesh. In another case Chetia was awarded three years' rigorous imprisonment for possessing foreign currencies of 16 countries on February 18, this year.

But he said he would encourage the 'traditional rivals' to resume the peace process they began in Lahore in February 1999 that was derailed by a near-war they fought three months later in the territory.

Kofi Annan promised more than encouragement to the Afghan refugees however

Leaders of the BNP-led opposition alliance vesterday asked the government to step down immediately and make way for holding general election by May 30.

As part of countrywide rallies and demonstrations in all city and district headquarters, the alliance yesterday organised a rally at Muktangan to press for immediate resignation of the government. City BNP President Sadeque Hossain Khoka MP chaired the meeting.

Speakers said people's dissatisfaction over AL misrule compelled the government to announce that it also wanted election before June 12.

Addressing the gathering, BNP secretary general Abdul Mannan Bhuiyan asked the government to resign right away and hand over power to a caretaker govern ment in order to hold general election by May 30.

He said as the power base of the AL government has been badly shaken, it is only left with the formalities of resignation. He said the entire government, law and order and police administration have collapsed and

He said the AL since assuming power killed several hundred opposition activists, wounded an unspecified number of others and looted people's wealth. Also AL ministers, MPs, leaders and their sons and relatives forcibly occupied people's properties, grabbed lands, killed people and still continue to do so, he said. Family members of industrialist Nurul Haq Sikder are still in panic despite a "settlement" with Chief Whip's son Sadik Abdullah and withdrawal of the complaint with Gulshan thana against him, sources claimed vesterday

They are still being threatened not to file any case or talk to newsmen, the sources claimed. The family members refused to talk to The Daily Star yesterday.

Shots were fired on Shikder's Pajero jeep from Sadek's car and the vehicle was chased up to cantonment from Gulshan in the city on Friday night, allegedly to kidnap Shikder's daughter. The driver of the ieep was injured and one of its windows damaged in the firing, the family members had said on Saturday

The sources said Sadek is very disappointed and angry over newspaper coverage of the incident involving him. He held Sikder's family responsible for the newspaper reports, they said.

Meanwhile, Gulshan police neither arrested Sadek nor seized his aun.

Supply still inadequate

Textbooks printed with low quality paper, ink

Over two months into the academic vear, textbooks for secondary level are now available in markets but most of those are printed with low quality paper and ink harmful to eyesight, sources concerned said.

This happened due to lax monitoring by the National Curriculum and Textbook Board (NCTB), they The type of paper and ink specified in the tender was not used for printing the books, they claimed.

Forged 'security papers' are often

found in the books. Each textbook

must contain some 'security papers'

supplied by NCTB, the sources

Old edition books with new covers are also found in bookstalls. Pustaka, a concern of Beximco.

was awarded the job of printing and distributing about 2.5 crore textbooks of 60 categories for the current 2001 academic year.

However, it is still difficult to find all of the 60 categories of books in a bookstall due to inadequate supply.

"I had to search in bookstalls from Nilkhet to Bangla Bazar wholesale market in the city to find all the books," a student of class VIII of Government Laboratory School told this correspondent yesterday.

NCTB failed to ensure quality as it was under pressure from different quarters to ensure supply of books as Pustaka could not maintain the printing and supply schedule, the sources said.
