Delimitation of constituencies

EC asks officials for reports by Mar 30

The Election Commission (EC) has asked the officials concerned to send the latest reports on delimitation of all the 300 parliamentary constituencies by March 30, as part of its preparations for an early general election.

This time the EC has decided to incorporate the names of new administrative areas in the gazette, following administrative changes in the last one for delimitation published on May 30, 1995. But demarcation of the constituencies would not be changed, said EC sources.

Names of the new thanas in metropolitan areas would also be incorporated in the gazette. The sources said thanas across the country will be renamed as upazilas.

The commission has served the notice to all deputy election commissioners, district election officials, deputy commissioners and others concerned, asking them to send the delimitation report by "special messengers" to the Election Commission Secretariat

Meanwhile, the Ganotantry Party has urged the

Election Commission to make the voter list transparent and safeguard the upcoming election from the influence of black money and terrorism.

At a meeting with the Election Commission on electoral reforms yesterday, the party, which nominated only three candidates in the-1996 general election and lost their security deposits, proposed lowering the deposit money for candidature.

It said, "We feel it should be as low as the earlier one's, and the election commission can charge part of their expenses, if a candidate withdraws on the last date of

Money is no problem for him. He has already started giving donations to various organisations in Bagerhat-2 constituency (Sadar thana-Kachua), sources in political and other circles sav. Even a prominent local leader of

Awami League has said he considers AH Selim as his main rival in the next parliamentary election.

Industrialist Selim joined BNP in 1999, assuring party chief Khaleda Zia of "destroying" the "Awami fort" in Bagerhat-2 and Bagerhat-3

Selim has an intention to contest also from Bagerhat-3 constituency (Rampal-Mongla) if the party chief

Selim has created a sensation, telling local people that he would change their lot and make Bagerhat district a "paradise of SouthWestern zone" if BNP wins all the seats.

But Selim's main problem lies in

his own party where he has many rivals in getting nomination from any of the two constituencies. Component parties of the 4-party alliance in the district also have reservations about him, said some top leaders of Bagerhat BNP. "A newcomer can not go ahead of dedicated leaders", said one of them

who had opposed his joining BNP. He is spending huge amounts of money to draw voters' support in his favour. He has already started donating money to schools, colleges, mosques and temples in the two constituencies.

The recipients are often seen beating his drum, said Abu Siddique, a businessmen hailing from Munshigani in Sadar upazila.

"Selim Shaheb is our saviour and we can not forget his generosity", said Dilip Das of Kachua upazilla who wants to cast his vote for Selim for the first time.

Fourth day of SSC exams Over 2000 examinees. 20 teachers expelled

As many as 2,023 SSC examinees and 20 teachers were expelled from different centres across the country for adopting unfair means during the Bengali second paper examination yesterday.

On the fourth day of the SSC examinations, 229 examinees were expelled under the Dhaka Education Board, according to board officials

Of them, 38 were in Netrokona, 35 in Mymensingh, 24 in Kishoreganj, nine in Gopalganj, 14 in Shariatpur, four in Munshiganj, three in Narayanganj, two in Faridpur, three in Manikganj, 74 in Jamalpur, two in Tangail, 12 in Madaripur, one in Rajbari, four in

Six hundred and fifty five examinees and 16 teachers were

expelled under Rajshahi Education

Some 95 examinees and 12 teachers were expelled in Chapainawabganj, 51 examinees in Rajshahi, 42 in Naogaon, 31 in Natore, 88 in Pabna, 90 in Rangpur, 69 in Kurigram, two teachers and 24 examinees in Nilphamari, 46 in Lalmonirhat, 98 in Thakurgaon, 129 examinees and two teachers in Dinajpur, 244 in Gaibandha and 21 in Panchagar

Two hundred and eighty four examinees were expelled under the Chittagong Education Board.

According to board officials, 232 were expelled in Chittagong, 28 in Cox's Bazaar and 12 in Khagrachari, 11 in Rangamati and four in Bandarban.

Bangabandhu Murder Case

Submission against acquittal of Lt Col Muhiuddin ends

The prosecution in Bangabandhu Murder Trial yesterday ended its submission against acquittal of former lieutenant colonel Muhiuddin Ahmed (artillery) in the split judgment saying the grounds cited for the 'acquittal were illogical as well as "contradictory to the case

'The reasons which were cited to disbelieve some of the witnesses in acquitting Muhiuddin were not only illogical but also were contradictory to records," Chief Prosecution Counsel Serajul Haq told the court of Justice Mohammad Fazlul Karim, hearing the spli judgment of the previous High Court bench.

He added that the prosecution was "able to prove beyond doubt" the charges against the accused artillery officer with the testimonies of the witnesses, who happened to be the artillery men under Muhiuddin during the August 15, 1975 killing of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

The prosecution ended its submission on Muhiuddin, one of the five accused acquitted by one of the two judges in the previous bench, as the hearing before the third judge continued for the 13th day yes-

The major charges against Muhiuddin are that he joined the pre-murder briefing on the plot leaders in the name of night parade, ordered artillery fire at Dhanmondi during the incident and later was seen at Ganobhaban along with other plot leaders Justice Mohammad Ruhul Amin, the judge who

acquitted the five of the 15 accused, in his judgement cleared Muhiuddin saying, his joining the night parade was not an offence since it was a routine practice. He also rejected Muhiuddin's own confessional statement calling it "not voluntary and true" and

refused to consider testimonies of several witnesses

who belonged to artillery unit (papa battery) saying

those were contradictory and not credible. The prosecution argued that although night parades were usual events in army, the use of ammunitions was not allowed for such practices. But Muhiuddin ordered his troops to collect the ammunition

in line with instructions from the absconding convict lieutenant colonel Khondoker Abdur Rashid. Haq said the court might have ignored one of the artillery witnesses' testimony if it found it to be exagger-

ated since he presented some new evidence in court which he did not mention to the investigation officer
