Razzak calls for creating awareness against fatwa

Water Resources Minister Abdur Razzak yesterday called upon all to create awareness among the country's women against fatwa-mongers and anti-liberation elements to protect their rights.

The fatwa-mongers and the anti-liberation elements are conspiring against development of women by declaring fatwa and preventing them from participating in any development activities across the country," he said.

The minister was speaking at the First National Council of Bangabandhu Mohila Parishad at the Shishu Academy in the city.

Chaired by former director general of Women Affairs Directorate, Nulufar Begum, the function was also addressed, among others, by State Minister for Planning Dr Mohiuddin Khan Alamgir, Justice K M Sobhan, Prof Abdul Mannan Chowdhury, Mahbubuddin Ahmed, Bir Bikram, Barrister Tania Amir, and convener of the parishad Dr Khaleda Begum.

Terming the opposition alliance as an enemy of women development, he said the rights of women were severely violated during the 21 years' regimes of Zia, Ershad and Khaleda.

They do not believe in women

development as they want to turn Bangladesh into a country like Afghanistan ruled by the extremists like Taliban where women are forced to stay indoors.

The minister urged the women to launch a mass movement against the fatwa-mongers and anti-liberation elements who are expected to contest in the coming general elections.

Laying emphasis on creating awareness among the women about their rights, Dr Mohiuddin Khan Alamgir said the women of the country are not even aware about their rights which has been ensured in the Constitution.

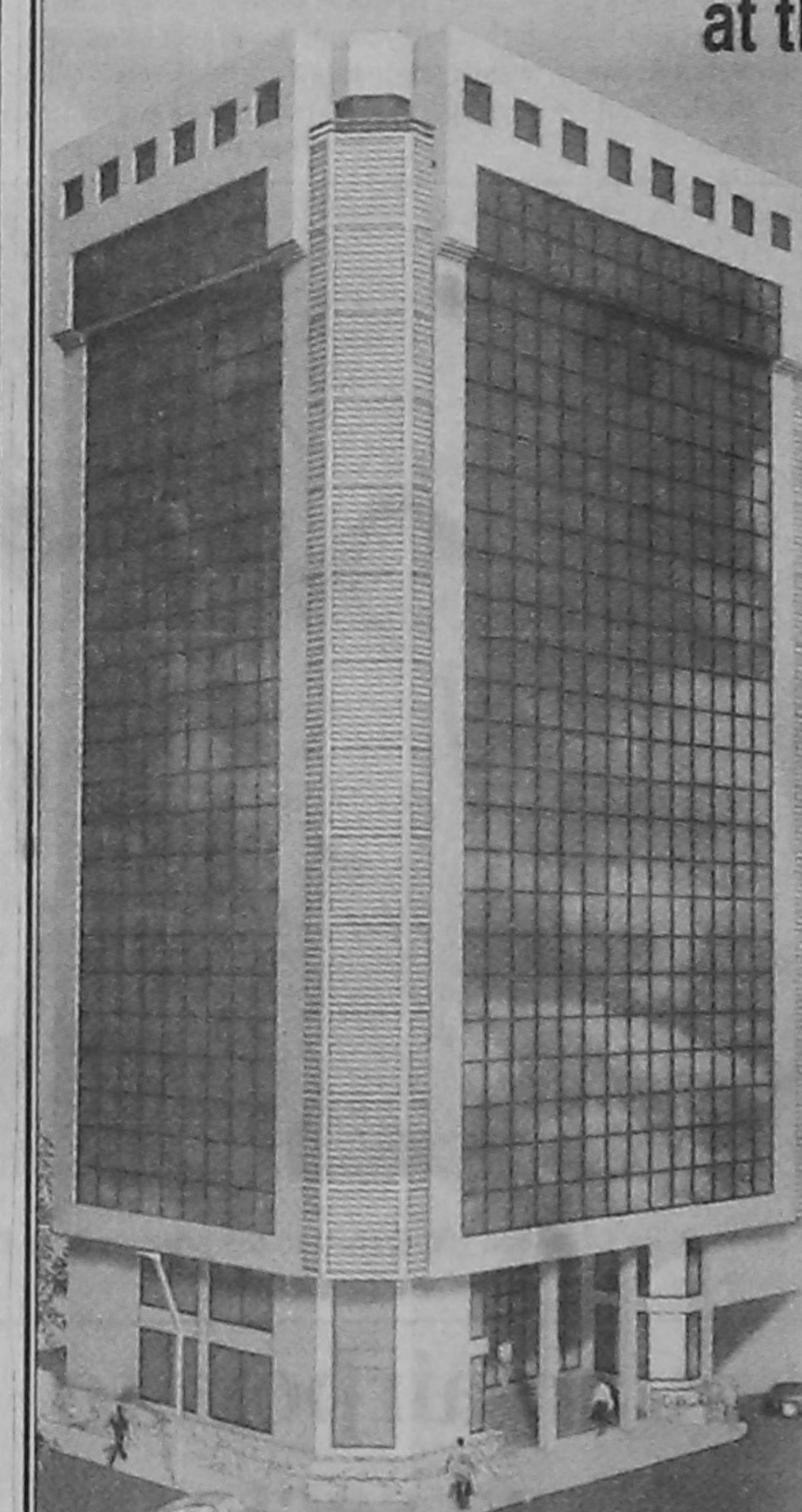
