# Create atmosphere for fair polls first: Badruddoza

Deputy Leader of the Opposition in Parliament Prof AQM Badrudoza Chowdhury has said BNP definitely wants election and stressed the need for recovery of illegal arms and removal of 'party men' appointed by the Awami League (AL) government in different important administrative positions to ensure free and fair polls.

The ruling party is for holding of the next election within five to six weeks after the caretaker government takes over but it is not possible within such a short period because recovery of illegal arms, restructuring of the Election Commission, administrative changes and release of all opposition leaders and activists detained

in 'false cases' are needed before the election, he said. Prof Chowdhury was addressing a discussion meet-

ing organised by the Jatiyatabadi Muktijoddaha Dal on the occasion of Independence Day at Engineers Institution in the city yesterday. President of Muktijoddaha Dal MA Majid was in the chair.

The BNP leader said AL wants holding of the election under the present administrative set up. But the caretaker government must be given reasonable time for recovering illegal arms and bringing changes in the administration to create a conducive atmosphere for election, he added

Quoting press reports, he said there are now over 1.50 lakh illegal arms and 25.000 licensed arms in the hands of AL cadres. No fair election is possible unless

these illegal arms are recovered, he stressed.

# Dry spell may be over in a couple of days

Rainfall is expected today or tomorrow in different parts of the country, putting an end to the prolonged dry spell.

Weathermen said yesterday nor'westers accompanied by rain are likely to hit the northern and central regions of the country in a couple of days.

The rain would bring relief to farmers having great difficulty in irrigating their fields with standing crops due to absence of rain for more than four months Cultivation of aus and boro paddy and some seasonal crops was badly affected due to lack of moisture content in soil, experts said.

Talking to The Daily Star, Director of Meteorological Department Anwarul Kabir said, "Indications are there that the northern and central regions may experience some rains as we can foresee nor'westers today or tomorrow at the

There has been virtually no rainfall in the country since November last year. As against an expected 43 mm rainfall in January this year, there was almost no rain.
