Shikha Chirantan to be installed at Suhrawardy Udyan today

BSS, Dhaka

Hundreds of 1971 veterans yesterday reunited in Dhaka to join a grand freedom fighters rally as part of Independence Day celebrations coinciding the installation of "Shikha Chirantan" (eternal flame) at its permanent site at Suhrawardy Udyan today.

Prime Minister Sheikh Hasina is due to formally install the flame to mark the 30th anniversary of Independence, four years after its inauguration at its makeshift location near the current permanent site.

The freedom fighters, who earlier gathered at different cantonments under a six-day programme of the armed forces division, would first join the grand rally at the National Parade Ground at about 12-30 pm.

They will hold a street march to arrive at the Suhrawardy Udyan, where the Prime Minister is expected to install the flame at 4 pm.

The Shikha Chirantan was opened at its makeshift site in 1997 to mark the Silver Jubilee Celebrations of the Independence in a ceremony joined by South African leader Nelson Mendela, Palestinian leader Yasir Arafat and Turkish President Suleyman

Meanwhile, Bangladesh Television will telecast live the grand rally of freedom fighters and installation ceremony of Shikha Chirantan.

\$ 31m WB credit to make civil justice system more efficient

The World Bank has approved a \$30.6 million credit for Bangladesh to make its civil justice system 'more efficient, effective and accountable

The funds will finance an initial 6-year project aimed in particular at improving case management, reducing delays and case backlog, and improving access to justice, especially for the poor and women, according to a press release issued in Dhaka yesterday.

"Effective laws and judges are not sufficient to improve the system if excessive delays, high fees, undue interference and lack of awareness limit people's access to justice," said the World Bank team leader of the project.

"While reforms on all levels are needed, developing a system and institutions which are capable of meeting demand through both formal and informal dispute resolution is important. The focus of the new project is therefore on developing an efficient court system," he said.

The Legal and Judicial Capacity Building Project is designed to address the most pressing problems of timelines and accessibility while paving the way for subsequent reforms in other areas. It will cover the first

phase of the Government's long-term strategy to build a well-functioning system capable of improving the financial, commercial, industrial and social life of the nation.

The government's programme is outlined in its "Strategy for Legal and Judicial Reforms" which was developed following extensive consultations with civil society, legal professionals and concerned government officials throughout the country

Main elements of the strategy are based on diagnostic studies completed by the country's own legal community, drawing, where necessary on international experts, many of whom came from within the South Asia region and whose countries have judicial systems similar to

The consultative process was of fundamental importance in development a truly home-grown reform program," said the joint team leader for the project.

"It not only provided invaluable input to the government's strategy, but was also a tremendous learning experience for the people of Bangladesh." he said.

All the victims were from the

Foreign powers fuelling conflict in Afghanistan

UN special rapporteur alleges

UN special rapporteur for Afghanistan Kamal Hossain has accused foreign powers of responsibility for fuelling the conflict there. "The international community, in

particular acting through the Security Council, is expected to discharge its fundamental obligation to protect the people and territory of Afghanistan from external interference and from the destructive armed conflict," Hossain, from Bangladesh, said in his annual report to the UN Human Rights Commission in Geneva.

He hit out Thursday at "those who are ruling at the top with external assistance" that enable them to continue the war by providing, for example, fuel for planes that were bombing civilians. "All the warring parties have been guilty of grave breaches of international humanitarian law," Hossain said.

"Their war-making is supported

by the involvement of Afghanistan's neighbours and other states in providing weapons, ammunition, fuel and other logistical support.

"State and non-state actors across the region and beyond continue to provide new arms and other material, as well as training and advisory assistance.' The rapporteur, who went to

Afghanistan in 1999, was not allowed to go there in 2000 and early 2001, but he interviewed refugees who had fled to Pakistan.

The United Nations, he said, had "a mandate, not only having got the Soviet troops out, but then to fill the vacuum with viable structures of governance."

Hossain recommended "initiating and sustaining a process in which all segments of the Afghan population inside and outside Afghanistan may be able to devise

Another allegation has been brought against the OC that he had arrested four Jubo League activists on the night of March 13 this year while going away with a microbus snatched earlier from Sonadanga. The OC also refused to release the arrested JL activists despite pressure from an MP.
