However, there was no untoward incident on the campus. The bus service of the university was suspended during the hartal

The Central Library and the Science Library of the university remained open but the attendance of students were very thin.

Meanwhile, a DU press release said the activities in the administrative building and different hall offices were normal and all the branches of the banks on the campus remained open.

During the hartal hours, ruling party-backed student organisation Bangladesh Chhatra League (BCL) staged anti-hartal demonstration while BNP's student wing Jatiyatabadi Chhatra Dal (JCD) brought out a procession in support of the hartal. Both the organisations held separate rallies.

Addressing the rally held in front of the DUCSU building, the BCL leaders called the opposition to join the parliament session in line with the call of Prime Minister Sheikh Hasina.

The JCD procession paraded through the Elephant Road in the city. It held a rally at Kataban intersection at around 1.00 pm.

Speaking at the rally, the JCD leaders demanded immediate resignation of the government and transfer of power to the caretaker government.


