Work on 10 uplift schemes suspended in Barisal

Terrorists demand 'toll' from contractors

UNB, Barisal

Implementing firms suspended work on 10 development projects involving Tk 30 crore in Barisal district following terrorists' attacks.

Sources said most of these projects located in suspended, said contractor of the project, Dulal Sarder. Gournadi upazila. The terrorists allegedly belonging to ruling party were demanding illegal tolls from the pro-

ject contractors. On March 31, a group of hoodlums attacked construction site of 19-km RRMP-3 project being implemented involving Tk 25 crore in Gournadi upazila as they were denied of partial project work of a Chinese company 'China Harba.'

Local people said Rubel, son of Chandshi UP Chairman Hakkani Alam, led the attack and forced to suspend the work being implemented by a local agency

of the China Harba company. Six labourers were injured critically and valuables looted from the project site during the attack.

On the same day in the same upazila, another group of hoodlums led by local terror Shaheed Sarder attacked a LGED road construction project, as the contractor

refused to give 'toll' of Tk 50,000 to them. During the attack, they snatched away cash Tk 20,000

and injured four labourers.

In the same upazila, local terror Mostafa attacked the "small Irrigation Project" being implemented in Pingalakati on March 27 after failing to realise Tk 50,000 as toll. Following the attack, the project work remained

On the same ground, a canal excavation project under the Water Development Board in Babuganj and two road construction projects in Babuganj and Uzirpur upazilas remained suspended.

Contractors of these projects said they did not go for legal action on security grounds.

Police said action could not be taken against these criminals, as they did not get specific allegation from any quarters.

Meanwhile, in Agoiljhara upazila, a group of terrors snatched away tender documents breaking the tender box from Upazila Nirbahi Office.

When contacted, engineers concerned of Roads and Highways, Water Development Board and Local Government and Engineering Department said in most of the cases the contractors themselves solve the problem. If the contractors fail, legal actions were taken officially, they said.

A teenage girl wants fair play

"Why shall I be punished alone? Why not he who violated my chastity and compelled me to go for abortion?

The questions were raised by a teenage girl who and her family have been ostracized by the village 'panchayet'.

Sixteen-year-old Duleha told the 'Panchayet' that her maternal uncle Kadrul had sex with her and when she got pregnant, he forced her to go for abortion. Kadrul denied the charge.

On her admission of the guilt, the 'Panchayet' sought religious opinion. Maulana Tayeb Ali of Bhatera gave a 'fatwa' (edict) that because of Duleha's admission of guilt and her time, she may be punished.

And since Kadrul denied the charge against him, he cannot be punished until his guilt was proved in the court of law, observed Maulana Tayeb.

Following his 'Tatwa', the 'panchayet' in its verdict-ostracized Duleha and her poor family excluding them from mixing with people in the society for the last seven months. The villagers have also been asked to refrain from communicating with them.

The incident has created a lot of sensation in the area.

When asked about the questions raised by the poor girl, Sultan Mia and Libar Mia, who were in meetings of the 'panchayet,' said they could not punish Kadrul for his denial of the allegation and left it to the court to decide if he was guilty.

Denying the allegation, Kadrul and his elder brother, and former UP member Shamsul Hossain, said: "It's a conspiracy against us."
